Reuben Smalley, Success

Activation of Cockburn Central Town Square

- Q1. Considering the Council report surrounding the activation of Cockburn Central Town Square outlines the significant obstacles to trading, including the 1km setback to similar fixed businesses, the need for permission from the landowner (the State), and Ministerial approval for a zoning change to allow for commercial leases, and the requirement for an expressions of interest process, has the Council considered the permanent establishment of a café within the Town Square, specifically the Siding, leveraging the fact that a business has previously operated within the broader Cockburn Central area and coexisted with established shops without apparently causing detriment? Has the Council pursued any of the actions to obtain changes to the zoning of the area, including Ministerial approval?
- A1. The Director Sustainable Development and Safety clarified that the reserve known as the Siding is a piece of Crown land. The City has a Management Order (MO) over it for the purposes of recreation. In order for Council to consider any commercial uses or activities on the site, the MO would need to be modified, granting Council the power to issue a licence or a lease for a commercial activity. At this stage there has been no application or request lodged by the City for a change to the MO and that is something that Council can consider at any time in terms of making a request.

Matthew Woodthorpe, Lake Coogee

ARC Policy

- Q1. Cockburn ARC has recently changed their policy on allowing physiotherapists into their centre, allowing free access to only partnered physios while day passes must be purchased for all others. Or it relies on participants being eligible for a Companion Card. The only long-term option now is a three-month lump sum payment for rehab memberships, now also forcing NDIS participants onto a membership that accumulates to roughly double the cost it did previously, fortnightly.
- The justification given is that it aligns with industry standards, but Cockburn ARC haven't elaborated on what the standards are. And on consulting multiple other centres, they reported to allow free access to physiotherapists if they are accompanying a client. What are the industry standards that the decision is based on?
- A1. The Director Community and Place advised the decision is informed by benchmarking practices that are in place across comparable local government-operated aquatic and recreation centres. While some facilities do offer complimentary access to physiotherapists accompanying clients, others apply a fee structure. Notably, the two most comparable centres, in the City of Joondalup and City of Armadale, also apply a charge. Given Cockburn ARC's status as one of the busiest facilities in Western Australia, the adopted approach reflects a balance between operational sustainability and equitable access for all users.



Q2. Why were the previous arrangements seemingly discontinued entirely?

A2. The Director Community and Place advised the previous arrangements allowed external physiotherapists to access the centre without charge when accompanying clients. Over time, this led to increased use of shared spaces by practitioners operating multiple client sessions daily, which impacted availability for general members and casual users. The revised entry process ensures:

- Equitable access for all paying patrons
- Improved management of shared spaces and equipment
- Enhanced compliance and safety through formal registration of physiotherapists.

Q3. Why was this decision appropriate for a community operated centre that touts its efforts to be inclusive to all members of the community?

A3. The Director Community and Place advised Cockburn ARC remains committed to inclusivity and community wellbeing. The introduction of registration for physiotherapists supports equitable access and helps maintain high service standards across the centre. The City will continue to work with physiotherapists and community stakeholders to ensure service delivery remains accessible, safe and responsive to community needs.

Q4. Since originally submitting my questions, I have been contacted about the situation via a phone call. Getting a general explanation of the circumstances around why the decision was made, and an offer of assistance with the process of organising a Companion Card and possibly contacting my own physiotherapist's company in regards to arranging payment of fees. It was definitely appreciated, but as mentioned earlier, eligibility for Companion Cards may not be possible for everyone, and fees may still be put onto the participants if no agreement can be reached. Could I have some clarification on whether this assistance will be forwarded to all NDIS participants in the future, or is it only in this circumstance?

If a participant isn't eligible for a Companion Card, and there is no agreement that can be reached on their behalf between Cockburn ARC and a participant's provider, then what happens next?

A4. The Director Community and Place reiterated that the City does understand that every participant's circumstances are unique, and navigating the NDIS and related support arrangements can certainly be complex. While staff aim to assist where possible, it remains the responsibility of each individual or their provider to organise access in line with the Cockburn ARC Terms and Conditions.

If a participant is not eligible for a Companion Card and no agreement can be reached with their provider, standard fees will apply. In such cases, participants may wish to explore alternative options, such as engaging a physiotherapist who already has an agreement in place or working with one of the resident physiotherapists on site. As we have discussed previously, the City is very happy to continue the conversation with you Mr Woodthorpe.



Rina Burrows, Bibra Lake (Not in attendance at meeting - responses provided)
Turtles

- Q1. What specific actions has the City implemented this year to protect local turtle populations, including feral animal and weed control measures, and what measurable results have been achieved?
- A1. This question was asked and responded to at the February 2025 Ordinary Council Meeting, the July 2025 Ordinary Council Meeting and the September 2025 Ordinary Council Meeting. Minutes of those meetings are available on the City's website.
- Q2. What habitat restoration works have been completed to date, where were they carried out, and what were the observed outcomes?
- A2. The City has been revegetating wetland reserves and improving turtle habitat for many years. On an annual basis, revegetation is undertaken across an average of 2.5 hectares annually across the 93 conservation reserves that are managed by the City. This roughly equates to 50,000-60,000 new plants being planted each year, with much of this work occurring in the wetland areas. The large scale of the revegetation program means that providing a full breakdown of the works is not feasible in this forum.
- It should also be noted that the nutrient stripping basins at Yangebup Lake have also been effectively improving the water quality at this wetland since 2015.
- Q3. How is the turtle population study being conducted this year, and when will the public be able to see the data or findings from last year's study and its outcomes?
- A3. This question was asked and answered at the August 2025 Ordinary Council Meeting and the September 2025 Ordinary Council Meeting.
- The 2024 Report is available on request from the City's Sustainability team, whom you can contact directly.

Marcin Gabriel-Borowski, Yangebup
Black Spot Project - New Signals, Beeliar and Dunraven Drive

- Q1. One month ago, I inquired about the status of this Project and was informed that the Project was going well. What is the progress since last month? Is there anything stopping it moving forward and what are we going to see next month?
- A1. The Director Infrastructure Services advised that, further to the response provided at the 2 September 2025 Ordinary Council Meeting, he could advise that detailed designs for the intersection upgrade have continued to progress with the appointed consultant.
- The primary obstacle which may impact progress is formal approval of the traffic signals (detailed designs) for which control of timing resides with Main Roads Western Australia. However, the City has taken all required steps in preparatory approvals to mitigate this risk.

Additionally, the construction works will be sourced from external contractors which has risks associated with availability of providers in the market and their submitted cost schedules which require alignment to the approved scope of the Blackspot grant.

**Dale Lomax, North Coogee
Spending and Tenders**

- Q1. This question is due to last year's 4.2M deficit. As a resident I have some concerns regarding tender processes and financial oversight. Most nations are now adopting Artificial Intelligence (AI) processes to combat financial fluidity, especially related to budgetary expenses regarding government contracts. Does the Council have any plans to adopt any modern processes like AI for budget adjustments during the year? This is to reduce waste, control spending, and ensure transparency, thereby reducing future deficits?
- A1. The Director Corporate and System Services advised the City does maintain a public register of open and past public tenders. AI in procurement is still emerging and there is no local government in Western Australia that has adopted AI in procurement. The City is exploring how we can use AI to improve processes and transparency of process, however, until legislation changes and processes are updated, the City will not be implementing AI in procurement.

Glenn Elliott, Success

Illegal Rubbish Dumping and Anti-Social Behaviour – Biloxi Loop, Success

- Q1. What are you going to do about the illegal dumping on Biloxi Loop in Success, near the Aubin Grove Train Station? We are continually living in a rubbish tip. It has gotten to the point now where there has probably been 10 or 12 complaints by residents on Biloxi Loop and continually the residents at 3 Biloxi Loop, which is the Department of Housing flats, are continuing to dump rubbish on our front verge. We are living in a rubbish tip. I ask the Council, what are you going to do about this continual problem, and I would like some concrete steps to stop this, because we are sick of it?
- A1. The Director Infrastructure Services advised he would take the question on notice and get a review of the volume of illegal dumping that has transpired at that particular location. We do have the capacity within the process to understand some of the material that has been dumped and maybe align that to specific people or properties.
- We will work with our Rangers and our CoSafe team to review that. Regarding the Department of Housing, that will be something that we will have to take up and identify clearly what the situation is and how we can support them to be able to ensure that the frequency of dumping, as you have raised, can be reduced or mitigated.
- Q2. I understand previously the City has installed CCTV cameras in parts of the City, in what you call hotspots. We continually get Police knocking on our doors asking for video footage because we are the first street next to Aubin Grove Train Station. There is also a Department of Housing set of flats across



the road. There have been multiple call outs for Police over the past three months and we have been asked multiple times for footage of that area. Can you please explain to me what would be a hotter spot for you to put video cameras in the City of Cockburn?

- A2. The Director Sustainable Development and Safety advised the City only has three mobile CCTV cameras that it currently operates. The priority areas tend to be areas where there is incidents of anti-social behaviour, including physical assaults and the like. So we do prioritise different areas. In this case I will take your question on notice and in terms of when we would schedule for CCTV to go on Biloxi Loop. At this stage it depends on the current schedule and the current hotspots that are being investigated.
- Q3. Could you please contact Cockburn Police and find out how many times they have been called out and how much for physical violence has been called from those set of units, and maybe that might help the City work out which hotspots should have CCTV. I am very keen to know where those three hotspots are, because looking in here I can see plenty of CCTV.
- A3. The Presiding Member thanked Mr Elliott for his questions and advised he was certain Mr Arndt will follow up on behalf of him and his neighbours.

Matthew Knowles, Success

Illegal Rubbish Dumping and Anti-Social Behaviour – Biloxi Loop, Success

- Q1. The rubbish eventually get moved but then gets replaced. It is fairly constant that it is there. What other solutions might there be if we didn't get CCTV cameras at that location?
- A1. The Director Sustainable Development and Safety clarified that the City has permanent CCTV cameras where there is a program or a roll-out program of locations where those permanent facilities go, however, acknowledging that sometimes there are incidents that need to be investigated, the City has purchased three mobile CCTV cameras which we move about to cover those gaps where there are no permanent cameras. In respect to this matter, it would appear that if it is clear that the material is coming from one particular location or source, then certainly the City officers can have discussions with the landowners about how they propose to control the matter.

The Presiding Member advised that the City could also arrange for additional CoSafe patrols, so there is a number of other initiatives that Mr Arndt will discuss with you to work out how we can best help resolve the situation.

Mark Dillon, Cockburn Central

- Q1. In relation to Mooba Café and the Siding, a question was asked whether the Council had put in for the change of use to the land. I have an email here saying that they lodged an enquiry last week with the Department of Planning, Lands and Heritage, to explore whether the Management Order for the reserve could be amended. Did the Director just say it wasn't submitted or it was submitted?



- A1. The Director Sustainable Development and Safety clarified what he indicated was that there has been no formal application lodged. You are correct that the City have made enquiries with the department, and the department have indicated that it is unlikely it would agree to a change to the Management Order for a commercial operation to be located on the reserve. As I have clearly indicated, there has been no formal application lodged with the department.

Background

Report

Following the adoption of the City's 2025-26 Annual Budget at the Special Council meeting on 19 June 2025, several funding requirements have been identified across both the operating and capital budgets.

These include adjustments to operating expenditure and revenue, capital expenditure, and income, and reserve transfers. Collectively, these changes result in a net increase of \$154,604 to the closing budget surplus.

In addition, further refinements were made to some carried forward projects from the FY25 Budget adopted at the 12 August 2025 Ordinary Council Meeting. These adjustments were necessary due to final end-of-financial year processing, with 11 capital projects and one operational project receiving final invoices and reaching completion.

Of the original 140 projects carried forward, 58 capital and 13 operational projects have since been processed, with approximately \$1.46 million in transactions. This has reduced the total carry forward amount from \$15.20 million to \$13.74 million.

It is worth noting that the report presented on 12 August incorrectly classified one project, valued at \$220,000 as capital, when it was actually operational. This has now been corrected in the current report.

The revised budget surplus of \$446,804 provides Council with some flexibility to allocate funds toward minor, unplanned items from consolidated revenue throughout the remainder of the financial year.

Budget/Financial Implications

The Municipal Budget for 2025-26 currently reflects a net budget surplus of \$292,200.

Following the adoption of the recommended amendments outlined in this report, the surplus will increase to \$446,804. This improvement is primarily due to reductions in operating expenditure, a modest increase in grant income, a capital budget decrease of \$1,924,358, and a net decrease in financial reserve drawdowns totalling \$1,531,681.

An Absolute Majority of the Council will be required to amend the 2025-26 Municipal budget.

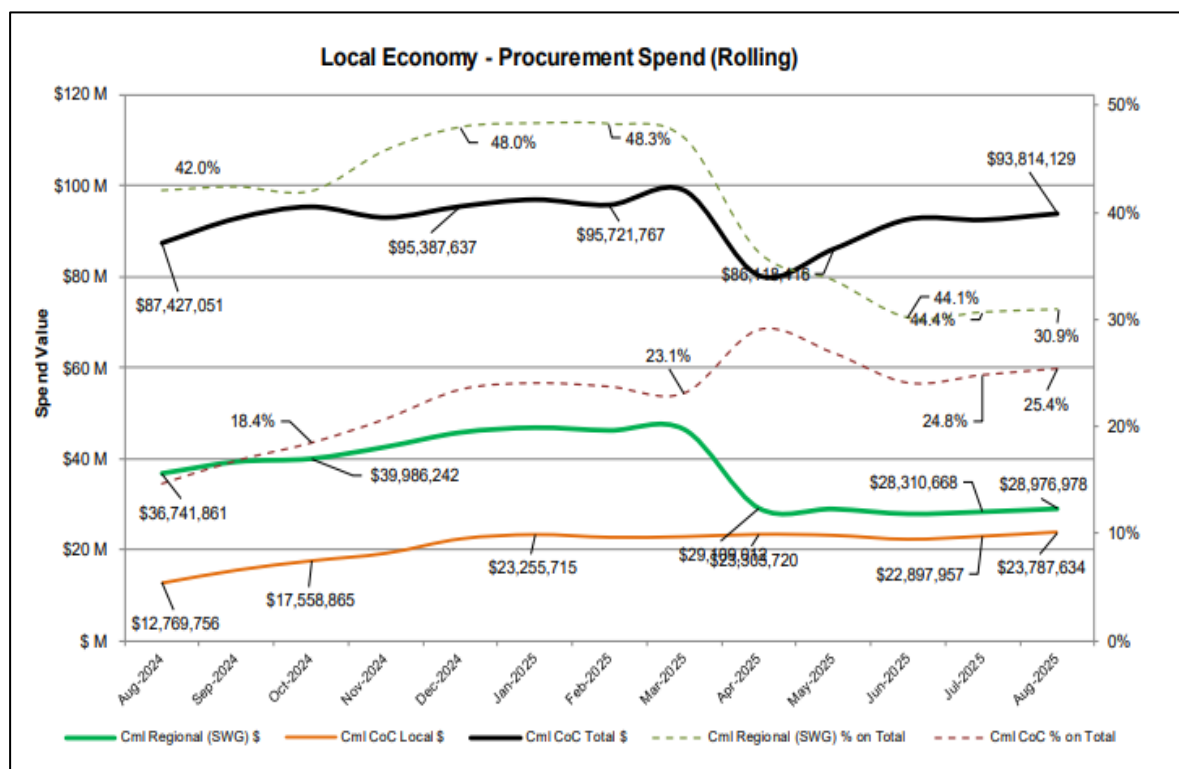

Local spending within Cockburn represented 27.9% of the City's monthly expenditure and 35.74% of procurement transactions. In the Perth South West Metropolitan Alliance (PSWMA) region, the monthly spend decreased to 31.1%, while the quantity of procurement transactions increased to 39.91%.

The following one year rolling chart to August 2025 tracks the City's procurement spend with businesses located within Cockburn and the PSWMA region:



In August, the 12-month rolling local expenditure in Cockburn reached \$23.79 million, representing 25.4% of the City's total spend. Within the PSWMA region, this figure increased to \$28.98 million, or 30.9% of the total spend.

This performance measurement aligns with the City's objectives under Council's Procurement Policy, specifically the "local and regional economy" principle, which emphasise a preference for local procurement.

Background

The *Local Government (Financial Management) Regulations 1996* prescribe that a local government must prepare a Statement of Financial Activity each month. Regulation 34(2) requires this statement to be accompanied by documents including:

1. Details of the composition of the closing net current assets (less restricted and committed assets).
2. Explanation for each material variance identified between year-to-date (YTD) budgets and actuals.
3. Any other supporting information considered relevant by the local government.

Regulation 34(4)(a) stipulates that the Statement of Financial Activity and associated documents must be presented to the Council within two months following the conclusion of the month to which the statement pertains. The Regulations require the reported information to be categorised by nature or type, statutory program, or business unit. The City presents this information according to its nature or type and organisational business structure.

Regulation 34 (5) requires each local government to annually set a percentage or value, as per the Australian Accounting Standards, for reporting material budget variances in monthly financial statements.

The materiality threshold has been set by Council at \$300,000 for the 2025-26 financial year (FY26).

A comprehensive analysis of budget variances is conducted on a continual basis. Any required budget amendments are either presented to the Council for approval via a dedicated Budget Amendment report or incorporated into the City's Mid-Year Budget Review process.

Report

The attached Financial Report for August 2025 has been prepared in accordance with the *Local Government Act 1995* and *Local Government (Financial Management) Regulations 1996*.

The following commentary outlines key financial results and provides an overview of budget performance as at the end of August 2025

Statement of Comprehensive Income

The monthly report includes a Statement of Comprehensive Income, mirroring the statutory annual budget format. This is showing a net result and total comprehensive income of \$128.19 million as of end of August.

This statement also presents the net operating result, which serves as a key indicator of financial sustainability. The adopted budget had initially projected an annual operating deficit of \$2.79 million, however after in year budget amendments the deficit has increased to \$4.61 million.

Statement of Financial Position

This Statement of Financial Position outlines the City's financial position as at the end of the month, compared to the close of the previous financial year. As of Aug 2025, net assets rose by \$128.97 million to \$1.99 billion, reflecting total comprehensive income for the period.

Statement of Financial Activity

Opening Surplus

The current opening surplus \$10.05 million, is \$7.58 million over the amended budget of \$2.47 million. With end of financial year processing and audit still to be finalised the opening surplus is subject to change, which will also determine the closing surplus for the month

Closing Surplus

The City's YTD closing surplus for August 2025 was \$141.10 million, versus a YTD budget of \$130.03 million.

This represents a favourable variance of \$11.08 million, inclusive of variances across the FY26 operating and capital budgets reported in the following.

Operating Revenue

The City's operating revenue of \$155.10 million was \$1.17 million ahead of YTD budget for August.

 - Interest Earnings: \$0.39 million ahead of year-to-date budget with budget cashflows to be updated.

Operating Expenditure

The City's operating expenditure of \$26.90 million to the end of August was \$9.1 million under year-to-date budget.

The City's operating expenditure for the year showed the following variances from the budget:

- Employee costs were \$0.79 million below the year-to-date (YTD) budget due to differences in staffing expenditures across service units, resulting in a net underspend.

Materials and contracts were \$4.36 million under the YTD budget, with notable variances as follows:

- Cockburn ARC contract costs: \$0.53 million below YTD budget
- Business Systems: \$0.38 million below YTD budget
- Information Technology - software support: \$0.94 million below YTD budget
- Coastal Management & Planning – Sand Bypassing: \$0.3 million below YTD budget due to timing factors
- Streets maintenance (streetscapes, verges): \$0.77 million below YTD budget.

Depreciation Expense:

- There is a favourable variance of \$3.75 million compared to the year-to-date budget. This difference is because a depreciation journal entry has not yet been posted.

Capital Expenditure

The Council's adopted capital works program budget for FY2025–26 has increased from \$65.37 million to \$79.51 million, primarily due to carry-forward adjustments. As at end of August, year-to-date capital expenditure totals \$5.09 million, which is \$1.1 million ahead of the year-to-date budget.

The following major project variances have been identified within the City's capital program budget:

- Plant and Equipment (\$0.10 million over YTD budget):
 - Light fleet replacement program - \$0.85 million under budget
 - Major plant replacement program - \$0.95 million over budget. Budget to be transferred between two Waste Truck capital projects to fix budget misallocation.
- Buildings (\$0.76 million over YTD budget):
 - ARC expansions \$0.36 million over YTD budget (timing variance).
- Coastal (\$0.38 million over YTD budget):
 - Port Coogee Revetment Renewals expansions - \$0.36 million over YTD budget with a current \$26,173 over full year budget.

Non-Operating Grants, Subsidies and Contributions

The City's capital grants and contributions budget totals a net amount of \$27.21 million. This includes \$12.69 million in grant funding, primarily allocated to road projects, and \$14.52 million in developer contributions for relevant initiatives.

There was \$0.26 million of non-operating, or contributions recognised as at the end of August, versus a YTD budget of \$0.5 million because of cashflow timing with recognition of revenue being tied to project completion as per Australian Accounting Standards requirement of capital revenue to be recognised in line with progress of project delivery (matching principle).

Financial Reserves

A detailed schedule of the City's financial reserves is provided in the financial report, showing a balance of \$230.44 million held at the end of August. This will be subject to further adjustment as end of financial year balancing occurs.

General revenue reserves were \$200.68 million, with the balance of \$29.76 million for externally or legislatively restricted purposes (inclusive of \$16.65 million for Developer Contribution Plans and \$6.13 million for POS cash in lieu purposes).

Transfers in and out of financial reserves are made in accordance with budgetary and statutory requirements.

Cash and Financial Assets

As of 31 August, the City's cash and financial assets were \$305.19 million, up \$44.23 million from July.

The balance comprised financial assets, including term deposits and investments totalling \$287.74 million, as well as cash and cash equivalent holdings, such as bank cash and call deposits amounting to \$17.45 million.

Of these funds, \$231.55 million are internally and externally restricted (mostly in cash reserves). The remaining \$73.64 million is unrestricted municipal money for funding the City's operations and liabilities.

Investment Performance, Ratings and Maturity

As of 31 August, the City's term deposit portfolio recorded a slight decline in its running yield to 4.68%, down from 4.81% previously. This softening reflects both the immediate impact of the rate cuts and growing market expectations of further rate cuts by the Reserve Bank of Australia (RBA) later this year.

Despite the modest decrease, portfolio returns remain well above the City's KPI benchmark of 4.10%, which comprises the updated cash rate of 3.60% plus a 0.50% performance margin. New investments placed during the month, ranged between 4.00% and 4.17%, which is consistent with prevailing market sentiment and the broader downward trend in interest rates.

Current term deposit investments are fully compliant with Council's Investment Policy requirements, as indicated below:

The portfolio also includes several reverse mortgage securities purchased under previous policy and statutory provisions. These have a face value of \$2.314 million and market value of \$1.49 million, although the City currently carries them at a book value of \$0.739 million (net of a \$1.575 million impairment provision made several years ago).

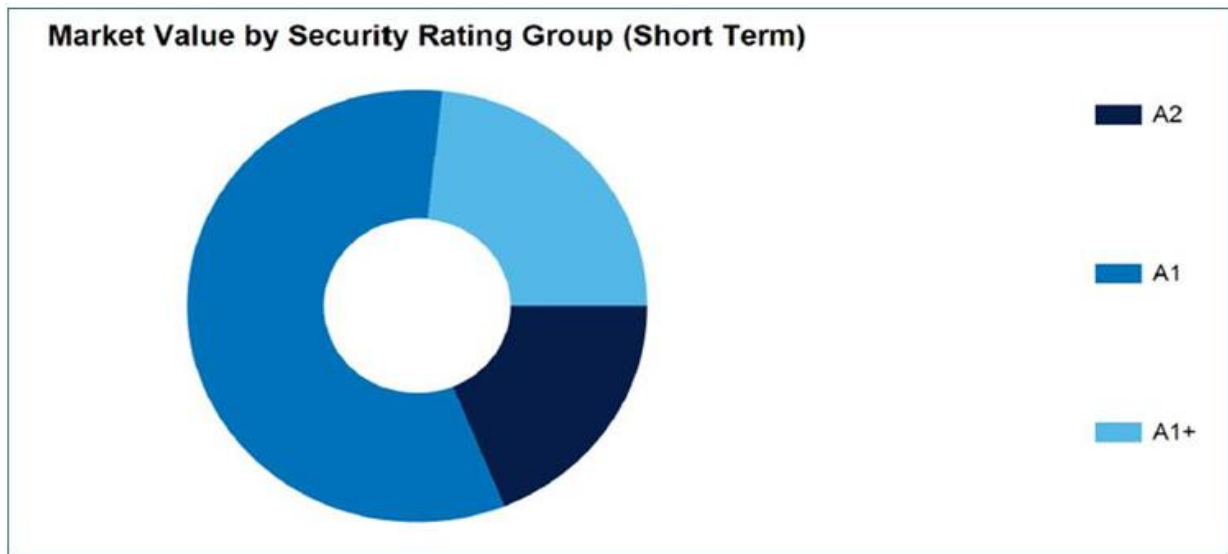
The City has continued to receive both interest and principal payments, with \$0.686 million of the original \$3.0 million investment returned to date.

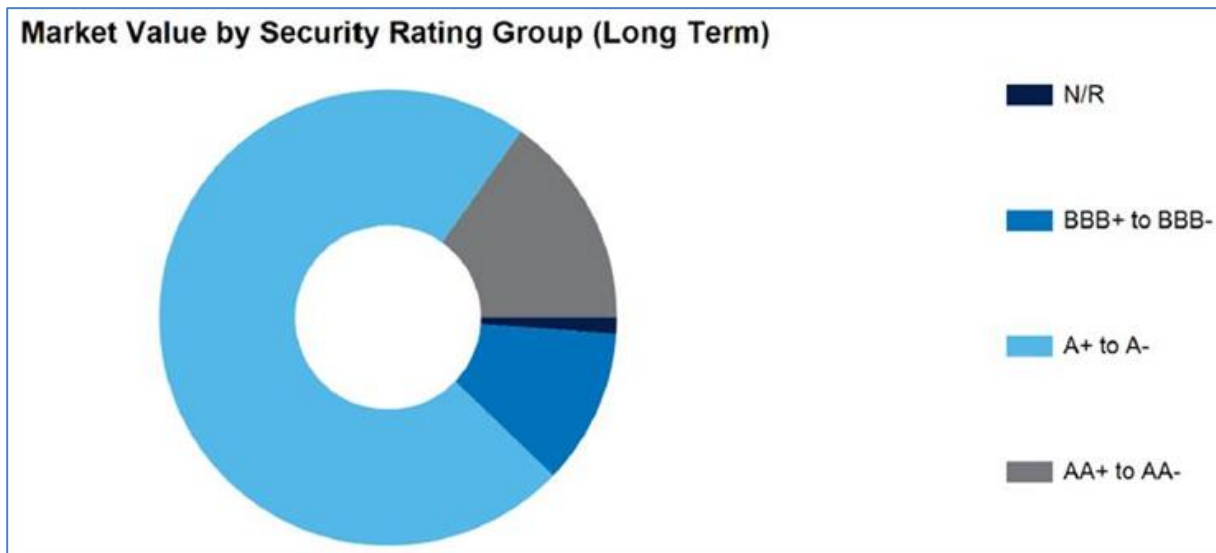
The City's short-term deposits (less than 12 months) made up 56.42% (\$166.55 million) of the City's portfolio, compared 58.04% (\$146.9 million) last month.

These were classified under the following credit ratings:



Deposits invested between 1 and 3 years made up 43.58 percent (\$128.65 million) of the City's portfolio, compared to 41.96 percent (\$106.2 million) last month.

Investment in Fossil Fuel Free Banks

At month's end, the City allocated \$50.3 million, representing 17.4% of its total investment portfolio to banks that do not fund fossil fuel-related industries. This represents a reasonable proportion decrease from \$50.3 million (20.3%) in the previous month.

The City's investments in fossil fuel-free institutions are subject to fluctuations, influenced by the competitiveness of deposit rates and the capacity of these banks to accept additional funds. Nevertheless, the City remains firmly committed to prioritising such investments, provided the rates remain competitive with those offered by other financial institutions.

Rates Debt Recovery

The collectible rates and charges currently raised for 2025–26, comprising net arrears, annual levies, and part-year rating, total \$167.44 million.

As of 31 August, the City had collected \$69.41 million, representing 41.45% of the total. This leaves an outstanding balance of \$98.03 million (58.55%). After excluding deferred rates of \$1.16 million, the remaining collectible balance stands at \$96.87 million (57.85%).

The City received \$0.64 million in rate prepayments for next year. It also collected \$0.22 million in underground power charges during the third year of a ten-year plan.

There are 43 properties with overdue rates under debt recovery, totalling \$0.38 million in rates and legal fees—down from 50 properties and \$0.45 million last month, indicating effective recovery efforts.

Formal debt recovery proceedings begin when ratepayers have unpaid rates and have not arranged instalment or alternative payments, nor requested relief under the City's Financial Hardship Policy.

Trade and Sundry Debtors

The City had \$2.68 million in outstanding trade and sundry debtors to the end of August (down from \$2.35 million last month).

Those debts overdue by more than 90 days were relatively stable at \$0.15 million (5.54% of total debt outstanding) compared to \$0.15 million (6.44%) the previous month.

The 90-day debtors included \$56k from Naval Base shacks and \$48k from landfill customers. These debts are actively managed.

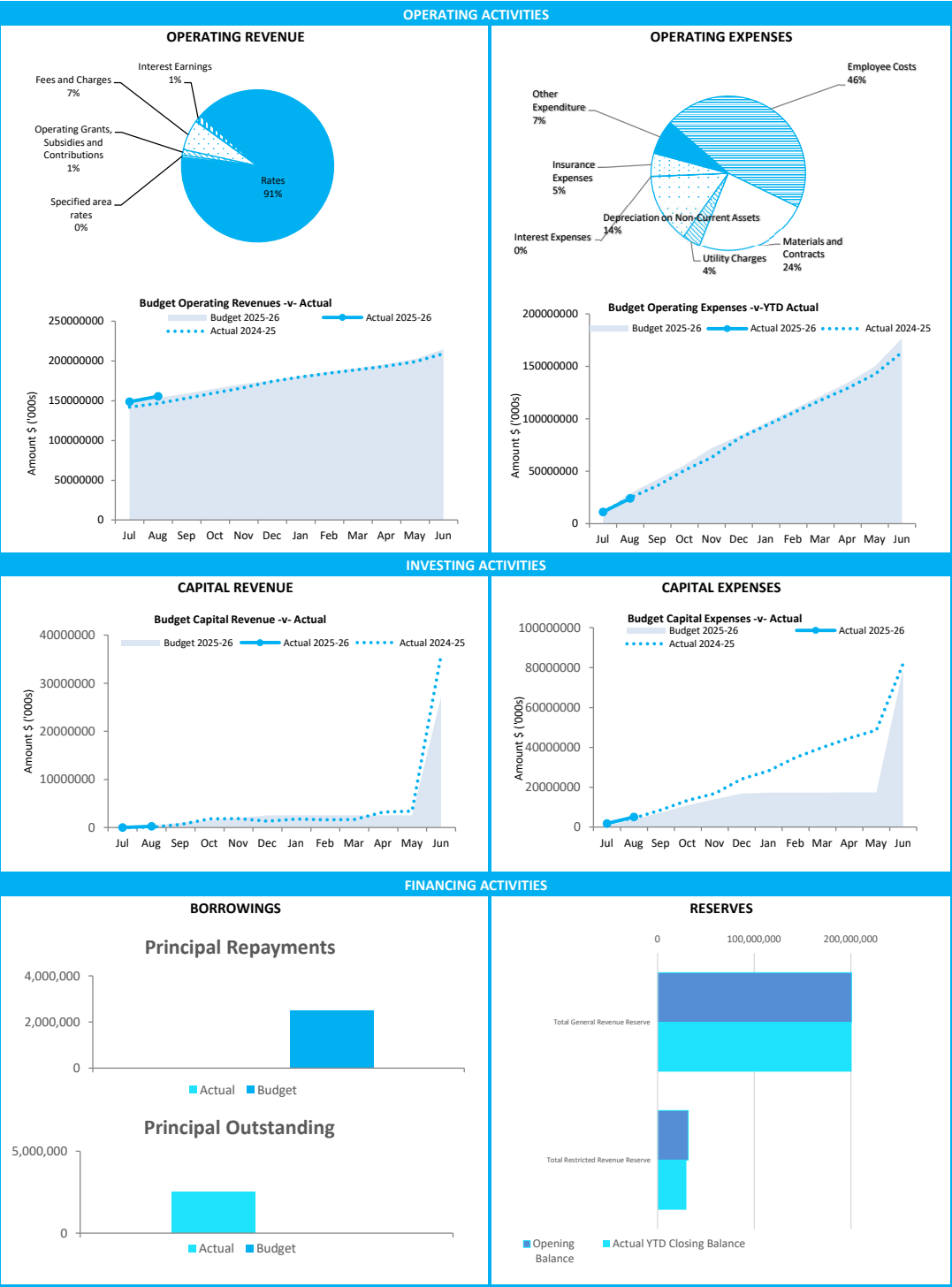

OPERATING GRANTS, SUBSIDIES AND CONTRIBUTIONS

Refers to all amounts received as grants, subsidies and contributions that are not non-operating grants.

NON-OPERATING GRANTS, SUBSIDIES AND CONTRIBUTIONS

Amounts received specifically for the acquisition, construction of new or the upgrading of identifiable non financial assets paid to a local government, irrespective of whether these amounts are received as capital grants, subsidies, contributions or donations.

REVENUE FROM CONTRACTS WITH CUSTOMERS

Revenue from contracts with customers is recognised when the local government satisfies its performance obligations under the contract.

FEES AND CHARGES

Revenues (other than service charges) from the use of facilities and charges made for local government services, sewerage rates, rentals, hire charges, fee for service, photocopying charges, licences, sale of goods or information, fines, penalties and administration fees. SERVICE CHARGES

All expenditures on materials, supplies and contracts not classified under other headings. Expenditures made to the respective agencies for the provision of power, gas or water. Exclude expenditures incurred for the reinstatement of roadwork on behalf of these agencies.

INSURANCE

All insurance other than worker's compensation and health benefit insurance included as a cost of employment.

LOSS ON ASSET DISPOSAL

Shortfall between the value of assets received over the net book value for assets on their disposal.

DEPRECIATION ON NON-CURRENT ASSETS

Depreciation expense raised on all classes of assets.

INTEREST EXPENSES

Interest and other costs of finance paid, including costs of finance for loan debentures, overdraft accommodation and refinancing expenses.

OTHER EXPENDITURE

Statutory fees, taxes, allowance for impairment of assets, member's fees or State taxes. Donations and subsidies made to community groups.

BASIS OF PREPARATION

BASIS OF PREPARATION

REPORT PURPOSE

This report is prepared to meet the requirements of *Local Government (Financial Management) Regulations 1996*, Regulation 34. Note: The statements and accompanying notes are prepared based on all transactions recorded at the time of preparation and may vary due to transactions being processed for the reporting period after the date of preparation.

BASIS OF ACCOUNTING

This statement comprises a special purpose financial report which has been prepared in accordance with Australian Accounting Standards (as they apply to local governments and not-for-profit entities) and Interpretations of the Australian Accounting Standards Board, and the *Local Government Act 1995* and accompanying regulations.

The *Local Government (Financial Management) Regulations 1996* take precedence over Australian Accounting Standards. Regulation 16 prohibits a local government from recognising as assets Crown land that is a public thoroughfare, such as land under roads, and land not owned by but under the control or management of the local government, unless it is a golf course, showground, racecourse or recreational facility of State or regional significance. Consequently, some assets, including land under roads acquired on or after 1 July 2008, have not been recognised in this financial report. This is not in accordance with the requirements of *AASB 1051 Land Under Roads paragraph 15* and *AASB 116 Property, Plant and Equipment paragraph 7*.

Accounting policies which have been adopted in the preparation of this financial report have been consistently applied unless stated otherwise. Except for cash flow and rate setting information, the report has been prepared on the accrual basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and liabilities.

PREPARATION TIMING AND REVIEW

SIGNIFICANT ACCOUNTING POLICES

CRITICAL ACCOUNTING ESTIMATES

The preparation of a financial report in conformity with Australian Accounting Standards requires management to make judgements, estimates and assumptions that effect the application of policies and reported amounts of assets and liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances; the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

THE LOCAL GOVERNMENT REPORTING ENTITY

All funds through which the City controls resources to carry on its functions have been included in the financial statements forming part of this financial report.

In the process of reporting on the local government as a single unit, all transactions and balances between those funds (for example, loans and transfers between funds) have been eliminated.

All monies held in the Trust Fund are excluded from the financial statements. A separate statement of those monies

GOODS AND SERVICES TAX

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of GST receivable or payable. 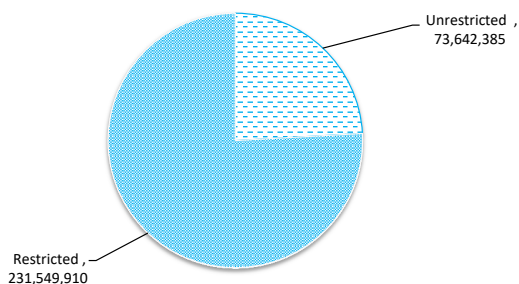

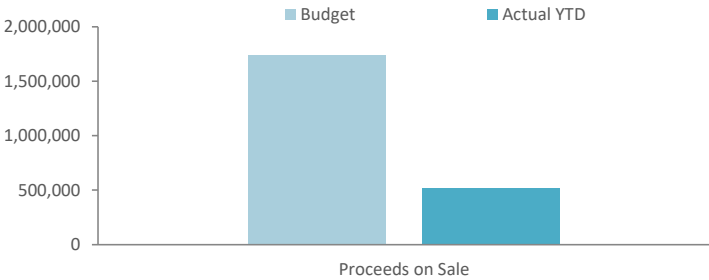

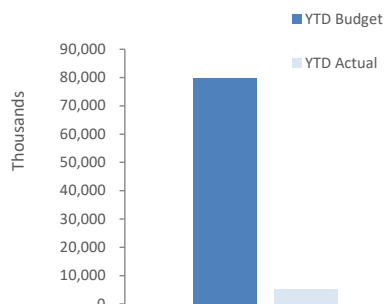

All assets are initially recognised at cost. Cost is determined as the fair value of the assets given as consideration plus costs incidental to the acquisition. Provisions are recognised when the City has a present legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Provisions are measured using the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Employee benefits

Short-term employee benefits

Provision is made for the City's obligations for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries and sick leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled.

Any remeasurements for changes in assumptions of obligations for other long-term employee benefits are recognised in profit or loss in the periods in which the changes occur. The City's obligations for long-term employee benefits are presented as non-current provisions in its statement of financial position, except where the City does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current provisions.

Contract liabilities

An entity's obligation to transfer goods or services to a customer for which the entity has received consideration (or the amount is due) from the customer. Grants to acquire or construct recognisable non-financial assets to identified specifications be constructed to be controlled by the City are recognised as a liability until such time as the City satisfies its obligations under the agreement.

- (3) REQUESTS the Chief Executive Officer to seek Ministerial approval to enable trading activity within The Siding at Cockburn Central and, if approved, request a report to Council outlining an Expression of Interest process for operators;
- (4) NOTES the review of section 6.18 of the City's Consolidated Local Law 2000 in relation to the one-kilometre setback requirement for trading near existing businesses (with a view to introducing reasonable exemptions that would enable temporary coffee vans, ice-cream trucks, and other small-scale pop-up vendors to operate in community spaces for the purpose of local activation) will be considered as part of the Local Laws Review Report schedule for presentation at the next Governance Committee.

Reason

Mooba Café was originally established within Cockburn Central as a pop-up initiative to activate the space, and it succeeded. It created a community hub that drew steady foot traffic, encouraged people to meet, and gave families and workers a reason to spend time in the heart of Cockburn Central. Even during winter months, when the water-play area was unused, the café kept the precinct alive and welcoming.

With the recent closure of Mooba and the removal of the adjoining pop-up park and grassed area, the community has lost its primary gathering space.



The remaining lawn is limited, and The Siding's current design is not functional: it lacks shade, has no tables or family-friendly seating, and relies on large dark-concrete blocks that become too hot to use in summer. This layout discourages use and fails to meet the needs of a growing town-centre community.

Claims that there is "no demonstrated need" or that "the assets are new" ignore the overwhelming community feedback including a petition of over 1,200 signatures calling for the retention of Mooba and a trading presence on site.

That level of response clearly demonstrates that residents want activation and social life in this space.

The one-kilometre setback rule for trading is inappropriate in a pedestrian-based centre like Cockburn Central, where activation depends on foot traffic, not destination travel.

Reasonable exemptions would allow coffee vans or ice-cream trucks to operate seasonally or at peak times, complementing nearby businesses rather than competing with them.

By improving The Siding's functionality and enabling small-scale trading, the City can minimise the impact of losing the pop-up park, maintain that community connection that has been built and established there, and deliver visible, practical activation in line with the Corporate Business Plan's stated objectives.

Officer Comment

1. Noted.
2. The City is engaging with the community in November 2025 as part of the Corporate Business Plan and as outlined in the report. The City can report the broader outcomes of this consultation, and any feedback relating to infrastructure within The Siding, and its relationship to the surrounding context, as part of the report back to Council. Council can consider the consultation outcomes and proposed activations to be delivered under the current Corporate Business Plan including any minor works within the area. Any functionality review of existing infrastructure would require consideration of the budget implications and appropriate resourcing.

Background

Deputy Mayor Stone submitted a Notice of Motion on 11 September 2025 for the following:

That Council receives a report on options for improving activation of Cockburn Central Town Square (The Siding), including:

1. Reconfiguration of existing infrastructure and landscaping to improve functionality and community use.
2. Opportunities for temporary trading licences or relocations for small businesses during adjacent construction periods including any approvals that may be required to facilitate commercial activity in The Siding.
3. Outcomes from past community consultations and how these can inform future improvements.

Reason

Cockburn Central is undergoing significant change. The recent notice to Mooba Café to vacate Lot 7 and subsequent impending loss of the pop-up park highlights the fragility of community activation in the Precinct.

The City's Corporate Business Plan identifies Cockburn Central activation as a key priority. It is therefore timely for Council to consider opportunities to strengthen The Siding and surrounding areas as a true community hub.

Report

The Siding - Overview

The Siding is located at Lot 16 Junction Boulevard, Cockburn Central and owned by the State of WA with a management order to the City of Cockburn for public recreation (Reserve No: 49100).



The Siding is classified as a Local Open Space as per the Public Open Space Strategy which are predominantly provided for the needs of the immediate residential population.

Local open spaces are embellished for casual and informal recreation by the community and easily accessed by bicycle or foot.

The Siding provide for play, informal recreation and sport, at a relatively low level of complexity.

The Siding is surrounding by apartment blocks, hotel (under construction), Cockburn Train Station and an adjacent land parcel which has an approved Development Application for Mixed Residential (Lodging Houses) and Commercial Development.

Reconfiguration of existing infrastructure and landscaping to improve functionality and community use

The Siding was established as part of the subdivision application for Cockburn Central with a landscaping approach to meet a future community.

The landscape included a grassed space, artwork, trees, performance area and pedestrian connectivity to the train station.

In 2012, The Siding was upgraded with a water park, large free-standing shelter, additional seating, tree and shrub planting to improve activation of the local open space.

These improvements raised the level of embellishment to an advanced state with the POS Strategy detailing there were no further upgrades required.

Since these works have been completed there has been no demonstrated need to initiate further embellishments to the open space.

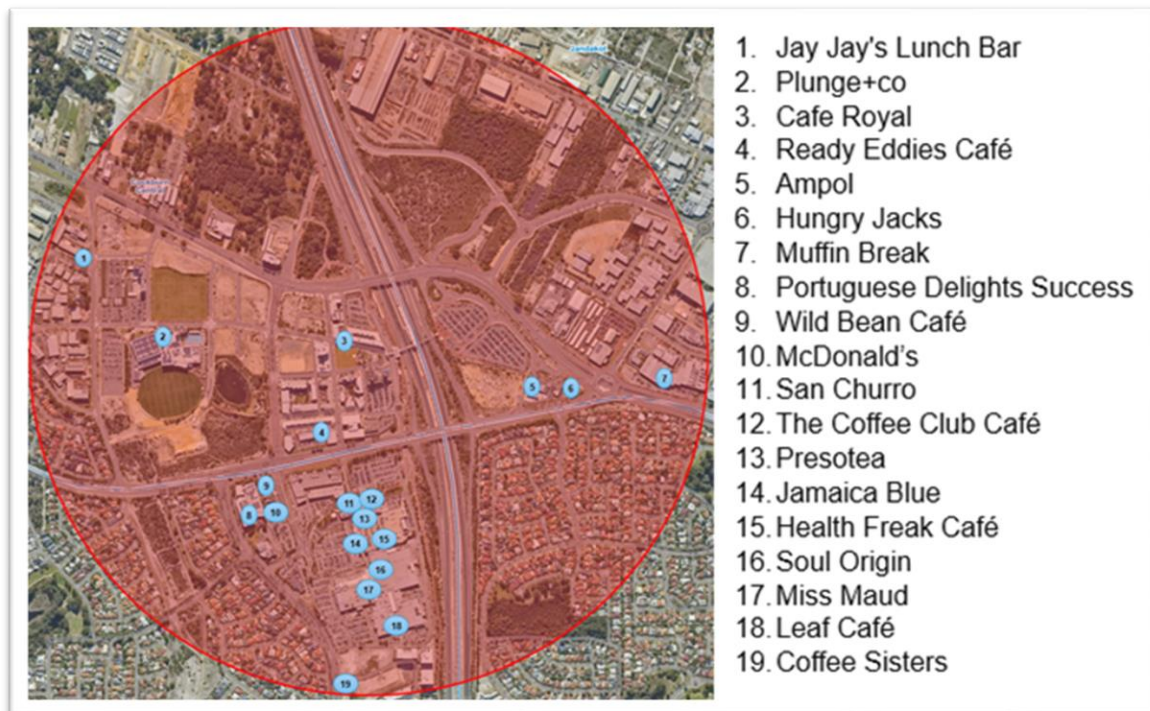
Additionally, as the assets are relatively new, there is currently no renewal requirements which would facility a consultation process with the Community.

Opportunities for temporary trading licences or relocations for small businesses during adjacent construction periods including any approvals that may be required to facilitate commercial activity in The Siding

Opportunities for temporary locations for small businesses within the Cockburn Central area would be reliant on the business proprietor negotiating directly with the private landowner of any vacant mixed-use spaces already available within the area.

There are several issues with a temporary food business moving onto the State-owned reserve (The Siding), which include:

1. City of Cockburn Local Government Act Local Laws – The local laws impose a 1km setback to similar fixed business and does not provide discretion to vary.

2. Trading in Reserves must be Approved by the Landowner – Commercial activity in public reserves like The Siding requires both permission from the landowner (the State) as well as City approval. In this circumstance, the management order for the recreation reserve does not allow for commercial leases and a change to the zoning would require Ministerial approval.
3. Trading on City or State-owned land generally requires an Expressions of Interest process - where businesses are invited to submit their formal intention to compete for a business opportunity. This process is used to determine market interest and identify capable providers before determining the next phase of the project.

Outcomes from past community consultations and how these can inform future improvements

The City completed consultation with residents in November 2024 as part of the Community Conversation program. Below are the outcomes from the consultation:

- High numbers of FIFO residents, hardly see anyone.
- Empty shops rented out

Background

Council endorsed the October, November and December 2025 Meeting Schedule at the 2 September 2025 Ordinary Council Meeting, which included an August, Risk and Improvement Committee (ARIC) Meeting on the 2 December 2025.

Subsequent to this, the City has received a request from its auditors to bring forward the ARIC. This report presents this request and a proposed new date for Council's consideration.

The ARIC is a formally appointed Committee of Council required under the Local Government Act 1995 as part of recent local government reforms.

One of ARIC's duties is to review the Annual Financial Report and the auditor's findings each year, providing independent assurance to Council on the financial report.

Report

On 8 October 2025, the City's auditors requested that the ARIC meeting be brought forward to 27 November 2025. The auditors made this request to assist the City to ensure that Council could consider and accept the 2024/25 Annual Financial Statements within the required timeframe.

The reasons given for seeking an earlier ARIC meeting date were:

- To meet the statutory deadline for Council acceptance of the annual financial statements by 31 December 2025, as required under the Act
- To allow adequate time for any audit findings to be addressed and avoid the last-minute rush that was experienced in the previous year.

After considering the auditors suggestion of 27 November (a Thursday), the City instead proposed Tuesday, 25 November 2025 for the ARIC meeting. This date aligns with the City's usual Tuesday meeting schedule and existing briefing arrangements, minimising disruption.

The auditors have confirmed that this new date is acceptable and achievable from their perspective. In other words, the 2024/25 financials will be completed in time for the ARIC meeting to review on 25 November, and the auditors (including the Office of Auditor General representatives) are able to attend and present their audit report on that day.

In contrast, keeping the ARIC meeting on 2 December would tighten the window for Council adoption. Any delay in finalising the audit or any significant findings on 2 December could potentially push Council acceptance to very late December, increasing the risk of non-compliance.

The City is keen to lock in the 25 November date to eliminate this risk and to ensure a smoother end-of-year financial reporting process.

Budget/Financial Implications

There are no direct financial impacts from rescheduling the ARIC meeting date. The change does not alter the content of the annual financial statements or any budgets.

Legal Implications

Changing the date of a Council committee meeting is permissible under the Local Government Act 1995 and associated regulations, provided that appropriate notice of the new meeting is given.

The rationale for this change is to ensure compliance with section 5.54 which requires that a local government's annual report must be accepted no later than 31 December after the end of that financial year.

By moving the ARIC meeting to 25 November 2025, the City is facilitating the timely preparation of the Annual Report 2024/25 within this deadline.

Community Consultation

The City will give notice of the proposed change of date on its website, through social media and other appropriate communications channels.

Risk Management Implications

By approving the recommended change, Council will mitigate a significant timing risk in the annual financial reporting process. The risk of not changing the date is that there would be minimal buffer to resolve any last-minute audit issues or to convene an additional Council meeting if something unforeseen occurred.

In that scenario, the City might face compliance risk if the Annual Report could not be adopted by 31 December.
