### Travis Battista, South Lake

Keeping on Animals Local Law 2026 – Poultry

- Q1. Under the proposed Keeping of Animals Local Law 2026, the permitted number of poultry on residential properties under 1,000 square metres is going to be reduced compared to the current allowance (currently 12). What does the City expect residents to do with poultry they are currently keeping lawfully under the existing local law, but which would exceed the new limit once the proposed law comes into place?
- A1. The Director Sustainable Development and Safety advised that, under the new Local Law a person may apply for a permit for approval to keep more than the allowed number of poultry specified in the table under proposed clause 4.12. If a person already has a permit or approval issued under the current law, then nothing will change as that permit or approval is taken to be a permit or approval under the proposed new Local Law. The proposed new Local Law provides greater flexibility in residential zones by easing the locational restrictions imposed by the current Local Law. For example, the current Local Law does not permit poultry within nine metres of a dwelling, and within existing residential zones that may be problematic.

### Stephen Shaw, Bibra Lake

Turtle Management Program

- Q1. Will the City commit to strengthening its Fox Management Program by making sure contractor reports use all available fox sighting data, including volunteer trail camera logs, and properly map seasonal hotspots and movement corridors? Management Program by making sure contractor reports use all available fox sighting data?
- A1. The Director Sustainable Development and Safety advised this question was previously asked and answered at the 8 April 2025 Ordinary Council Meeting, whereby a detailed response was provided on how the City uses fox sighting information, including volunteer data, to inform active fox management. At the time it was confirmed that mapping and analysing fox sighting data sits outside the current fox controller's contracted responsibilities, which is focused on ground control work.
- Q2. Volunteers are seeing increased fox activity across the Beelias Wetlands particularly during last turtle nesting season, but recent reports don't reflect this or align with PestSmart national guidelines. How is the City currently sharing fox control information with DBCA and the Perth South West Metropolitan Alliance, and will it commit to using community data and adopting more transparent, evidence based practices going forward? DBCA control North Lake and other lakes close to Bibra Lake, so conversing with DBCA and the Shire would help greatly in these matters.



A2. The Director advised this question was previously asked and answered at the 8 April 2025 Ordinary Council Meeting, whereby a detailed response was provided in respect to how the City shares fox sighting information with the Perth South West Metropolitan Alliance (PSWMA).

The PSWMA will provide information on Regional Fox Monitoring Studies and the effectiveness of regional fox control. This advice was provided in response to public questions at the September 2025, June 2025, May 2025, April 2025 and the March 2025 Ordinary Council Meetings, at which it was confirmed that the PSWMA regularly engages with DBCA as part of its regional coordination and that any further queries should be directed to the PSWMA.

Copies of the Fox Control Reports produced by the City have been available on request and the City's Annual Budget is also publicly available.

**Michael Separovich, Spearwood**  
Sustainability Rebate

Q1 When did the Home Eco Audit change to being an Environmental Subsidy Scheme?

A1. The Director Sustainable Development and Safety advised the Home Eco Audits have not become a subsidy scheme. It has been rebranded to *Sustainable Home Consult*. "The Sustainable Home Rebate" is a completely separate Program.

Q2. Is the rebate funded from the \$1.375M budgeted for the Sustainability and Climate Change Service Plans adopted in the 2026 Budget?

A2. The Director advised yes, the Sustainable Home Rebate Program and the Sustainable Home Consults (formerly the Home Eco Audits) are funded from this Budget allocation.

Q3. How large is the pool of funds available for the rebates?

A3. The Director advised in 2025-2025 Municipal Budget, \$50,000 has been allocated.

Q4. How much external funding does the City receive to support these rebates?

A4. The Director advised there is no external funding.

Q5. Was the decision to implement these Sustainable Home Rebates a decision of Council, was it done under delegated authority, or was it done under management's discretion of the adoption of the Budget?

A5. The Director advised the Eco Audits have been offered by the City since 2011. The Sustainable Home Rebate Scheme has been offered for the last two financial years. Each time Council has provided funds through the adoption of the Budget. It should be noted that the Sustainable Home Rebate Program clearly aligns with the actions in the Climate Change Strategy which is also formally approved by Council.

Q6. Was there a briefing to Elected Members about the adoption of the new rebate and any broader conversation about appropriate uses of ratepayer funds?



- A6. The Director advised there was no specific briefing to Elected Members outside the adoption of budgets and the adoption of the Climate Change Strategy. Elected Members, however, were provided with a written update in mid-2024, where it was communicated to them that there would be two trials, at a first instance, in 2024, and the intention was to expand the Program based on the level of uptake. The first trial was fully subscribed in two weeks, and the second trial in one month.
- Q7. Is the sustainability rebate separate to any other rebates the City already has such as for home composting?
- A7. The Director advised yes.
- Q8. Is there any differentiation between rebates for Council related, such as pool covers for example, and other services that are State controlled utilities such as the Water Corp, Synergy and Transperth?
- A8. The Director advised the eligible items were selected to encourage energy and water efficiency and reduce greenhouse gas emissions. Rebates for items that were already being provided by the State government, such as waterwise irrigation systems, are not included in the program.
- Q9. Is it considered appropriate for the local government to be using its municipal funds without any external grant funding to cover for the gaps that have been left by the State government?
- A9. The Director advised that whilst this is not a question that has been previously submitted, the answer is that the City has been proactive in trying to encourage households within the City to look at ways to reduce energy and water consumption. The program that the City has on offer is a way of incentivising households to proceed down that path, which is in alignment with the Strategic Community Plan and the City's Climate Change Strategy.

**Joyce Gadalan, North Lake**

Turtle Conservation

- Q1. This morning 2 adult males were killed on Hope Road near Progress Drive highlighting that current speed limit measures aren't working. Both the Bibra Lake and Yangebup Little Rush master plans already identify traffic calming, wildlife safe infrastructure, revegetation, fencing and ecological connectivity as required actions, yet these remain unfunded. Will the City progress to implement these existing commitments, including assessing the feasibility of closing and rehabilitation of Hope Road between the roundabout off Progress Drive and WA Wildlife to create a safe habitat for turtles and other fauna?
- A1. The Director Sustainable Development and Safety advised there was a motion that was raised at the Annual Electors' Meeting held earlier this year, and it specifically related to this particular matter. A report will be tabled at the 10 March 2026 Ordinary Council Meeting, which will include the City's response in relation to that Motion.



**Corinne Franklin, Banjup**

Offset agreement – Rose Shanks Reserve

- Q1. Why did the City not have the courtesy to inform Banjup residents that it had agreed to an offset agreement for the old mine site in the Rose Shanks Reserve?
- A1. The Director Sustainable Development and Safety advised that, as this is a complex question and deserves a more detailed answer, he is happy to have these discussions offline. However, the simple answer is that the decision for the land to be developed has been undertaken by the Western Australian Planning Commission (WAPC). The City’s role has been reflective of those State government decisions in trying to achieve the best outcomes, given the predetermination of what land would actually be developed. As that discussion involves some commercial aspects, that is the reason it was discussed as a confidential item. It should be clearly noted that the Environmental Protection Authority’s decision in terms of the land clearing is based on the WAPC advice and not on the City’s discussion about environmental offsets.
- A2. Why are the miners not picking up the cost of rehabilitation?
- A2. The Director advised the question would be taken on notice, but essentially the owners of the land will be ceding approximately 70% of their land as conservation reserve.
- Q3. What would have been the cost if the City itself had rehabilitated the mine site?
- A3. The Director advised that is a moot question as the City does not own the land.

## Background

Lot 2 (No.46) Sciano Avenue, Success covers an area of 4.1076ha, roughly bound by Deptford Street and Lewisham Park to the west, Sciano Avenue to the north, Wentworth Parade to the east, and existing houses to the south.

The subject site is located approximately 300 metres southwest of the Cockburn Gateways Shopping Centre and the broader Cockburn Central Secondary Centre.

Initiated by Council at the [12 August 2025 Ordinary Council Meeting \(Item 14.1.2\)](#), Amendment No.186 to TPS3 seeks to rezone Lot 2 (No.46) Sciano Avenue from 'Residential (R30)' to 'Development'.

On 10 September 2025 the Environmental Protection Authority (EPA) advised the scheme amendment is [unlikely to have a significant effect](#) on the environment, does not warrant formal assessment under Part IV of the *Environmental Protection Act 1986*, and provided advice regarding the future investigation and management of existing vegetation on-site.

On 22 September 2025, the Department of Planning, Lands and Heritage (DPLH) under delegation from the Minister for Planning granted consent to advertise the proposal under section 83A of the *Planning and Development Act 2005*.

## Submission

The proposed scheme amendment has been lodged by planning consultants, Planning Solutions, on behalf of Phoenix Ridge Pty Ltd (the landowner).

The proposal is part of a staged process, whereby the guiding provisions of the scheme are being modernised to facilitate the preparation of a subsequent local structure plan that better captures the development potential of the site.

## Report

The purpose of this report is for Council to consider submissions made during the advertising period and make a recommendation to the Minister for Planning on final determination.

### Appropriateness of the 'Development' Zone

One submission queried the appropriateness of the 'Development' Zone, and expressed concern that the Zone objective (below) could lead to unsuitable development of the site that might unreasonably impact on surrounding land use.

*“to provide for future residential, industrial or commercial development to be guided by a comprehensive structure plan prepared under the Scheme.”*

Whilst the Development Zone will allow for the consideration of complementary uses, retention of the DA14 Special Control Area (in particular Provision 2 below), ensures the primary focus of the future structure plan will be for residential housing.

Whilst this wording would not preclude future structure planning from considering a mixed-use development outcome that might integrate some commercial use, preparation of a structure plan consisting of zones primarily capable of facilitating industrial or commercial land use would clearly be inconsistent with the intent of the above scheme provision.

The scale of such a proposal would also likely be contrary to the City's [Local Planning Strategy](#) and supporting [Local Commercial and Activity Centres Strategy](#).

Industrial development is unlikely given the site's access limitations and proximity to existing residential land use, which limits the means to create transitional zones or reserves to mitigate or manage future amenity impacts (as would be required under [State Planning Policy 4.1 – Industrial Interface](#)).

The appropriateness or proportion of such zones is not a consideration for the current scheme amendment. The future structure plan will consider the broader implications of any commercial (or other non-residential) type of zone proposed.



A level of commercial development is already approvable under the land's existing 'Residential' zoning in TPS3. Such uses include 'Educational Establishment' (which would include private primary and secondary schools), a 'Place of Worship' and/or 'Child Care Premises'.

Applying a 'Development' zone (or 'Urban Development' under more recently approved local planning schemes) to areas identified as suitable for further intensification is a more contemporary (and deliberately flexible) approach to planning for greenfield sites throughout Western Australia.

### Native Vegetation

When responding to the Section 81 referral the EPA noted implementation of the amendment may result in the clearing of remnant vegetation, representative of the Banksia Woodlands of the Swan Coastal Plain Threatened Ecological Community (Banksia TEC) and habitat for threatened species of black cockatoo.

The EPA advised the potential impacts on the TEC and black cockatoo habitat should form the subject of further surveys to inform future planning processes.

Separate to this scheme amendment, the applicant has submitted an application seeking approval under the Commonwealth *Environmental Protection and Biodiversity Conservation Act 1999* (EPBC Act) to clear 2.096 hectares of vegetation containing foraging habitat for Black Cockatoos on the site, which includes 1.961 hectares of Banksia TEC.

The application was advertised by the Department of Climate Change, Energy, the Environment and Water (DCCEEW) for a period of 14 days between 4 and 18 November 2025. The City lodged a submission during the advertising period advising it considered approval to clear the TEC and black cockatoo habitat premature ahead of considering a structure plan for the site.

The structure plan process enables consideration of the viability of future subdivision and/or development to retain native vegetation.

The City was concerned approving full clearing ahead of the structure plan process could limit its ability to pursue the protection off some of the best remaining areas of remnant vegetation.

Contrary to the City's input, on 26 November 2025 DCCEEW determined the proposed clearing to be '[Not a Controlled Action](#)'. Providing the landowner obtains the necessary planning approvals (which trigger clearing exemptions under State environmental legislation), the effect of this decision is to allow for the full area of the Black Cockatoo foraging area (including Banksia TEC) to be cleared, without the need to offset the loss of vegetation elsewhere.

Despite the matters raised by the EPA prior to advertising, both State Agencies responsible for providing advice on environmental matters during advertising (Department of Biodiversity, Conservation and Attractions; and Department of Water and Environmental Regulation) made 'no comment' regarding the existing vegetation.

Wherever possible, it is the City's practice to seek the retention of good quality vegetation wherever possible on local environmental and amenity grounds. In this



instance the natural contours of the site (which slopes down rapidly west-to-east towards Wentworth Parade) need to accommodate drainage (on the downhill side) and tie into the level of existing roads, likely make retaining existing levels (and associated vegetation) a challenging proposition.

Like the developed outcome to the west, such an outcome may be limited to the retention of a small portion within future public open space, positioned where earthwork levels and servicing arrangements make it practical to achieve. Further input will be sought from both State Agencies through that process.

Road Widening

The section of Wentworth Parade abutting the site was constructed in 2001 by the major developer in the area, to facilitate the subdivision of land to the east of Lot 2, between Pearson Drive, Wentworth Parade, Bartram Road and the Kwinana Freeway.

The road was constructed to a boulevard standard with two lanes in either direction north of Malata Crescent, and a single lane of traffic south of Chelsea Circuit, within a total reserve width varying between 32 and 35 metres.

The section adjacent the eastern boundary of Lot 2 was constructed as a single consolidated carriageway (i.e. with no median or protected turning pockets), in anticipation that the road would be upgraded to its ultimate standard upon the subdivision and development of Lot 2.

The current reserve width varies between 16 and 30 metres.





Figure 3 – Existing Reserve Width and extracts of Approved Structure Plans for surrounding land (Wentworth Heights 2001 & 2011)



The attached Concept Design (refer Attachment 2) was prepared by the City to determine the minimum widening required from Lot 2 to achieve a consistent design outcome between Malata Crescent and Chelsea Crescent.

This plan identifies approximately 1,760m<sup>2</sup> of Lot 2 being needed to accommodate the required road infrastructure within a total reserve width varying between 28 and 32 metres. Whilst only conceptual, this width appears likely to accommodate future upgrades, including expanding the central median and providing a pedestrian footpath on the western side.

It is recommended this requirement be inserted as an additional provision for DA14 in Table 9 of the scheme, to ensure the structure plan accommodates the widening required, and the land is ceded to the Crown free of cost at subdivision.

Unless needed to directly facilitate the form of development proposed by the structure plan, future upgrading to the ultimate standard will likely become the City's responsibility.

### **Development Area Name**

Lot 2 was zoned 'Development' and included within a much larger Development Area 14 – Beenyup Road Special Control Area upon gazettal of TPS 3 in December 2002.

The included sections of Beenyup Road (west of Kwinana Freeway) have subsequently been renamed to Pearson Drive and Sciano Avenue.

Besides Lot 2, the remainder of DA14 has been structure planned, developed and rationalised into the scheme via [Amendment No.168](#) (gazetted 8 March 2024).

As the majority of the land has been removed from DA14 and its name reflects an outdated geographical reference, it is recommended that the amendment is modified to be specific to its remaining area, being 'Lot 2 (No.46) Sciano Avenue, Success'.

This revision will also assist in clarifying the road widening required by the new scheme provision (discussed above) is specific to a structure plan prepared for Lot 2.

**Community Consultation**

The amendment was advertised for a period of 42 days in accordance with Part 5, Division 3, Regulation 47 of the Planning and Development (Local Planning Schemes) Regulations 2015, from 23 October to 4 December 2025.

Advertising consisted of a notice on the City's 'Comment on Cockburn' website, and letters to nearby residents, relevant State Government agencies and Service Authorities.

A hard copy of the scheme amendment documentation was also available to view during business hours at the City's Administration Building in Spearwood for the duration of the advertising period.

The City received four submissions, including:

- two from members of the public, raising concerns with the uncertain development outcome and likely loss of vegetation
- two from State Government agencies/servicing authorities providing general comment.

A copy of the Schedule of Submissions, inclusive of officer commentary in response to the individual issues raised, is included (refer Attachment 3). No specific modifications are recommended in response to the submissions received.

**Risk Management Implications**

Under Section 76 of the Planning and Development Act 2005, where a local government has failed to adopt an amendment to a local planning scheme that ought to be adopted, the Minister for Planning may order the local government to adopt the amendment.

In an effort to streamline the planning process in response to current housing supply and affordability concerns, the WAPC may recommend that the Minister removes the requirement for a structure plan to be prepared (by deleting the remaining portion of Development Area 14) but retain the 'Residential' zoning with a higher density coding.



Deleting the requirement for a structure plan would hinder the City's ability to ensure an appropriately coordinated development outcome with adjoining land, such as completing the local road network (by extending any or all of Lewisham Vista, Benmore Rise or Wakehurst Loop), or consolidating public open space contributions with existing facilities (such as an eastern expansion of Lewisham Park).

It could also hinder the City's ability to advance the vegetation management recommendations of the EPA.

**Advice to Proponent(s)/Submitters**

The Proponent(s) and those who lodged a submission on the proposal have been advised this matter is to be considered at the 10 February 2026 Ordinary Council Meeting.

## AMENDMENT REPORT

### 1.0 INTRODUCTION

This Amendment has been requested by Planning Solutions on behalf of the landowner, Phoenix Ridge Pty Ltd, to rezone Lot 2 (No.46) Sciano Avenue, Success from its current 'Residential (R30)' to the 'Development' zone.

The site was zoned 'Residential (R30)' upon gazettal of TPS 3 in December 2002, reflective of the predominant zoning in the wider Success locality at that time. Prior to this, the site had been zoned 'Rural' under the City's then District Zoning Scheme No.2.

In April 2024, the City initiated a new local planning scheme, draft Local Planning Scheme No.13 (draft LPS 13). Amongst the changes, draft LPS 13 proposes to rezone Lot 2 to the 'Urban Development' (reflective of the model zone name) and retain a Special Control Area to specify the requirement for subdivision and development to be guided by a structure plan.

Although the changes contemplated by this Amendment to TPS 3 are foreshadowed in draft LPS 13, the timing for gazettal of the new scheme is unknown. At the time of writing, consent to advertise draft LPS 13 has not been granted by the Western Australian Planning Commission and Minister for Planning.

A 'Development' zoning, prior to approval of draft LPS 13, will support the preparation of a structure plan which provides for greater flexibility in residential density currently afforded to the site through its R30 density coding, cognisant of the site's proximity to the Cockburn Central Secondary Centre and major transport infrastructure.

### 2.0 SITE OVERVIEW

The subject site is located in the suburb of Success, located approximately 20km south of the Perth Central Business District and 400m southwest of the Cockburn Gateway Shopping Centre. The site is surrounded by primarily low-density residential development, with instances of higher-density R60 lots to the east, and R160 townhouse dwellings to the northeast.

The site has frontage to three roads, being Deptford Street (Access Street), Sciano Avenue (Access Street) and Wentworth Parade (a local distributor road). The site is located adjacent to three other roads (Lewisham Vista, Wakehurst Loop and Benmore Rise), all of which are likely to be extended through Lot 2, upon future subdivision occurring.

The site features an existing single dwelling with associated shed, landscaping and two crossovers from Sciano Avenue exists on the northern portion of the site. A track along

the perimeter of the site has cleared for use as a managed firebreak.

The southern half of the site is currently occupied by a large portion of vegetation, which may contain Banksia Woodland, a Threatened Ecological Community (TEC) under the *Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act)*.

### 3.0 AMENDMENT TYPE

Part 5, Division 1, Regulation 34 of the *Planning and Development (Local Planning Schemes) Regulations 2015*, identifies different amendment types: basic, standard and complex. Regulation 35(2) requires the local government to specify in their resolutions to prepare or adopt an amendment what type of amendment it is, as well as the explanation for forming that opinion.

This amendment is considered to be a 'standard' amendment, which Regulation 34 describes as:

- a) *an amendment relating to a zone or reserve that is consistent with the objectives identified in the scheme for that zone or reserve;*
- b) *an amendment that is consistent with a local planning strategy for the scheme that has been endorsed by the Commission;*
- c) *an amendment to the scheme so that it is consistent with a region planning scheme that applies to the scheme area, other than an amendment that is a basic amendment;*
- d) *an amendment to the scheme map that is consistent with a structure plan or local development plan that has been approved under the scheme for the land to which the amendment relates if the scheme does not currently include zones of all the types that are outlined in the plan;*
- e) *an amendment that would have minimal impact on land in the scheme area that is not the subject of the amendment;*
- f) *an amendment that does not result in any significant environmental, social, economic or governance impacts on land in the scheme area;*
- g) *any other amendment that is not a complex or basic amendment*

This proposed amendment satisfies pates (c), (e), and (f) of the above criteria.

#### 4.0 LEGAL DESCRIPTION AND OWNERSHIP

The subject site is owned by Phoenix Ridge Pty Ltd. The details of the lot are provided in the table below:

#### 4.0 PRELIMINARY ENGAGEMENT

The City of Cockburn and Planning Solutions have engaged with the Department of Planning, Lands and Heritage to discuss the merits of this Amendment, ahead of the zoning changes to the site foreshadowed by draft LPS 13.

#### 5.0 PLANNING FRAMEWORK

##### 5.1 State Planning Framework

###### Metropolitan Region Scheme

The subject site is zoned 'Urban' under the Metropolitan Region Scheme (MRS).

The purpose of the 'Urban' zone under the MRS is:

*to provide for residential development and associated local employment, recreation and open space, shopping, schools and other community facilities.*

The site is not located adjacent to any reserve or subject to any additional resolutions under the MRS.

###### Perth and Peel @ 3.5 Million

*Perth and Peel at 3.5 Million* is the overarching spatial planning framework applicable to the Perth and Peel regions. The document provides guidance on where development should occur to ensure sustainable urban growth, protect the environment and heritage and make the most effective use of existing infrastructure. *Perth and Peel @ 3.5 million* sets the context for four draft sub-regional planning frameworks, including the South Metropolitan Peel sub-regional Framework relevant to the subject site (refer below).

Section 4 of the framework provides the strategy and targets for infill residential development, with the aim to deliver a compact and connected city. Specifically, the strategy provides a South Metropolitan Peel sub-region target infill of 44,230 additional dwellings by 2031 and 75,510 dwellings by 2050.

The proposed Amendment will facilitate the preparation of a structure plan, ensuring the proper and orderly development of the subject site for primarily residential purposes, consistent with the long-term infill goals of *Perth and Peel at 3.5 million*.

#### State Planning Policy 3.7 – Bushfire

The subject site is located within a designated Bushfire Prone Area, pursuant to Section 18P of the *Fire and Emergency Services Act 1999*. By virtue of this designation, compliance with *State Planning Policy 3.7 – Bushfire* (SPP 3.7) and the associated *Planning for Bushfire Guidelines* (Guidelines) is necessary.

The current and proposed scheme provisions require preparation of a comprehensive structure plan to be prepared for the site, prior to further subdivision and development being undertaken. Assessment against the provisions of SPP 3.7 and the Guidelines will be undertaken at the structure planning stage once a greater level of detail is provided in respect of matters such as the specific location of residential lots, road, public open space and any retained classifiable vegetation.

#### State Planning Policy 4.2 – Activity Centres

*State Planning Policy 4.2 - Activity Centres* (SPP 4.2) outlines the planning and development of activity centres across Perth and Peel, emphasising the redevelopment and renewal of existing centres.

Cockburn Central, which for the purposes of the policy includes the Cockburn Gateways Shopping Centre and adjacent commercial development within the locality of Success, is classified as a ‘Secondary Centre’. The subject site is located approximately 300m from the Cockburn Central Secondary Centre.

## **5.2 City of Cockburn Local Planning Framework**

### City of Cockburn Town Planning Scheme No.3

The subject site is zoned ‘Residential (R30)’ under the City of Cockburn Town Planning Scheme No.3. The site is also subject to the Development Area 14 (DA 14) Special Control Area and two Development Contribution Areas (DCAs), being DCA 1 and DCA 13.

The objectives of the ‘Residential’ zone are:

- i) *To provide for a range of housing and a choice of residential densities to meet the needs of the community.*
- ii) *To facilitate and encourage high quality design, built form and streetscapes throughout residential areas.*
- iii) *To provide for a range of non-residential uses, which are compatible with and complementary to residential development.*

The objective of the 'Development' zone is:

*To provide for future residential, industrial or commercial development to be guided by a comprehensive Structure Plan prepared under the Scheme.*

Since TPS 3 was gazetted in 2002, changes in typical practice have seen growth areas which require preparation of local structure plans zoned as 'Development', in lieu of 'Residential'. Such an approach affords greater flexibility to the local structure planning process, without the need to seek approval of a scheme amendment for any changes to residential density codings.

#### City of Cockburn Local Planning Strategy

The City of Cockburn Local Planning Strategy (LPS) was approved by the WAPC in October 2024.

The LPS sets out the planning direction for the City to investigate the opportunity for the Cockburn Central Activity Centre to be reclassified as a 'Strategic Metropolitan Centre', based on the function of the centre. Facilitating residential development opportunities within proximity to the Cockburn Central Activity Centre will assist in providing additional population to support a potential elevation of this centre.

## **6.0 PROPOSAL**

This amendment to TPS3 proposes to rezone the subject from the 'Residential (R30)' to 'Development'.

The amendment seeks to retain the existing Development Area 14 (Beenyup Road) Special Control Area, to ensure that there remains a head of power under TPS 3 for a local structure plan to be prepared and approved prior to subdivision and development of the site being undertaken.

The rezoning to the 'Development' zone will ensure that there is a flexible approach to future structure planning, without being hindered by a fixed residential coding.

## **7.0 CONCLUSION**

The proposed Amendment has been prepared to support greater flexibility, responding to the site's proximity to major infrastructure and the Cockburn Central Secondary Centre. The Amendment will ensure that future residential subdivision remains capable of being coordinated by a comprehensive local structure plan, without a fixed density coding, ahead of approval of the City's draft LPS 13.



### Background

The subject portion of road reserve is situated adjacent to the southern boundary of 9002L Garston Way, North Coogee. An image of the portion road closure is shown below and is identified with red hatching.



The road reserve was originally designed for a cul-de-sac ending at Garston Way, as shown in the historic image below:



Garston Way has since been extended westward to intersect with Bennett Avenue, thereby eliminating the need for the existing cul-de-sac and rendering the residual 99m<sup>2</sup> portion of the road reserve surplus to requirements.

The City has conducted a Dial Before You Dig enquiry which identified no services will be impacted by the part road closure. Western Power have also advised there are no assets within the proposed area of road closure.

### Submission

Braykell Four Pty Ltd submitted application 201754 to the Western Australian Planning Commission for a high-density residential subdivision, which was approved on 20 October 2025.

The Western Australian Planning Commission (WAPC) granted approval partially on the basis of the Plan of Subdivision endorsed by the Department of Planning, Lands and Heritage (DPLH), which was date-stamped 30 September 2025.

The permanent road closure of the subject surplus road reserve will enhance the proposed development and enhance the streetscape of Garston Avenue.

A copy of the Subdivision Plan can be viewed (refer Attachment 1).



In accordance with section 58 (3) of the *Land Administration Act 1997* concerning road closures, the City published a notice in a local newspaper regarding the proposed closure for the required 35-day period ending on Friday, 12 December 2025. No responses or submissions were received following this advertisement.

If Council agrees, Braykell Four Pty Ltd will buy the proposed closed road from the State and cover all related closure costs.

Western Power have advised no objection to the proposal of road reserve closure and amalgamation subject to the provision for a substation site within the proposed development.

The Department of Planning, Lands and Heritage has no objection, pending a formal application and due diligence by the proponent.

### **Report**

This report fulfils the statutory administrative obligations specified in the Land Administration Act 1997. Endorsement from Council is necessary to enable the proponent to advance the permanent road closure proposal with the State of Western Australia.

This report has been prepared in response to a request from Braykell Four Pty Ltd, seeking Council's support for the permanent closure of a portion of road reserve on Garston Way, North Coogee.

The purpose of the request for part road closure and amalgamation is to facilitate design potential and enhance the aesthetics of the development once completed, thus complimenting the development of the surrounding area.

**Background**

A comprehensive evaluation of budget variances is conducted over the course of the financial year. Any necessary adjustments are submitted to Council through an agenda item, which was formerly presented to the Expenditure Review Committee, or are incorporated into the statutory mid-year budget review as required by legislation.

**Report**

The City’s opening surplus is currently budgeted at \$2.47 million, comprising the \$1.0 million adopted by Council in June and a further \$1.47 million relating to the carry forwards adopted by Council in August.

Following the completion of the audit, the City’s actual closing surplus (net current assets) for 2024-25 has been confirmed at \$10.36 million. This outcome provides an additional \$7.9 million within the current annual budget.

To ensure prudent financial management, the additional \$7.9 million will be incorporated into the 2025-26 budget by increasing the opening surplus. This amount will be fully allocated to the Land Management Reserve.

This approach aligns with Council’s Corporate Strategic Planning and Budget Policy and is intended to support the funding of the DCP 13 component of the scheduled June 2026 acquisition of the Cockburn Coast Oval. To facilitate the recovery of these funds from DCP13, an internal loan repayment schedule will be established to draw down from the reserve.

It is important to note that this result does not improve the City’s budgeted operating deficit for 2025-26, as it solely reflects the level of net current assets resulting from the 2024-25 budget performance.

Following adoption of the 2025–26 Annual Budget on 19 June 2025, and subsequent amendments approved by Council, further adjustments have been identified within both the operating and capital budgets.

The amendments proposed in this report do not result in any net change to the overall 2025-26 Municipal budget position. As such, the previously reported operating deficit of \$74,295 remains unchanged.

To ensure transparency, the attached Schedule of Budget Amendments outlines the specific projects and budget items recommended for adjustment. A summary table is also provided, categorising the amendments by both category and type.



Local expenditure within the City of Cockburn represented 42.92% of total monthly spend and 32.91% of all procurement transactions. Within the Perth South-West Metropolitan Alliance (PSWMA) region, the City’s monthly expenditure increased to 45.24%, compared to 31.23% recorded in November.



The following one-year rolling chart to December 2025 tracks the City’s procurement spend with businesses located within Cockburn and the PSWMA region:



In December, the 12-month rolling local expenditure in Cockburn reached \$17.09 million, representing 18.1% of the City’s total spend. Within the PSWMA region, this figure increased to \$33.60 million or 35.60% of the total spend.

This performance measurement aligns with the City’s objectives under Council’s Procurement Policy, specifically the “local and regional” principle, which emphasise a preference for local procurement.

#### Background

The *Local Government (Financial Management) Regulations 1996* prescribe that a local government must prepare a Statement of Financial Activity each month. Regulation 34(2) requires this statement to be accompanied by documents including:

1. Details of the composition of the closing net current assets (less restricted and committed assets).
2. Explanation for each material variance identified between year-to-date (YTD) budgets and actuals.
3. Any other supporting information considered relevant by the local government.

Regulation 34(4)(a) requires that the Statement of Financial Activity and related documents be submitted to Council within two months after the relevant month's end. The Regulations require the reported information to be categorised by nature or type, statutory program, or business unit. The City presents this information by its nature or type and organisational business structure.

Regulation 34 (5) requires each local government to annually set a percentage or value, as per the Australian Accounting Standards, for reporting material budget variances in monthly financial statements. The materiality threshold has been set by Council at \$300,000 for 2025-26 (FY26).

Budget variances are reviewed regularly. Necessary amendments are either submitted to the Council for approval or included in the City's Mid-Year Budget Review.

## Report

The attached Financial Reports for November and December 2025 have been prepared in accordance with the *Local Government Act 1995* and the *Local Government (Financial Management) Regulations 1996*. As no Council meeting was held in January, the November 2025 financial report has been included to meet statutory requirements.

The following commentary outlines key financial results and an overview of budget performance for the period ending December 2025.

### Statement of Comprehensive Income

The monthly report includes a Statement of Comprehensive Income presented in the statutory annual budget format, showing net and total comprehensive income of \$79.56 million as at the end of December.

This statement highlights the net operating result as a measure of financial performance. The original budget projected an operating deficit of \$2.79 million for the year, however, following budget amendments made during the year, the projected deficit increased to \$5.14 million.

### Statement of Financial Position

This Statement of Financial Position provides a comparison of the City's financial position at the end of the reporting period with the position at the close of the previous financial year. As at 31 December 2025, the City's net assets increased by \$79.56 million, reaching a total of \$1.94 billion.

### Statement of Financial Activity

#### *Opening Surplus*

The audited opening surplus of \$10.36 million exceeds the amended budget of \$2.47 million by \$7.89 million. The higher-than-budgeted opening position reflects the finalisation of year-end balances, including adjustments to carry-forward amounts, reserve movements, and timing differences in prior-year accruals. The additional surplus will be reviewed and incorporated into the mid-year budget review.

#### *Closing Surplus*

The Statement of Financial Activity for the period ended 31 December 2025 reports a year-to-date closing surplus of \$115.15 million, which is \$36.96 million above the year-to-date budgeted position of \$78.19 million. The surplus will be assessed as part of the statutory mid-year budget review, with any recommended adjustments presented to Council for consideration. The current position largely reflects timing differences across operating, investing, and financing activities, as outlined in the sections that follow.



Operating Revenue

The City's operating revenue was \$177.16 million, \$2.21 million above the year-to-date budget.

The City's year-to-date operating revenue reflects key budget variances which will be reviewed during the statutory Mid-Year Budget Review process:

- Rates Revenue: There is a shortfall of \$0.27 million compared to the year-to-date budget, primarily resulting from cashflow timing linked to the delayed receipt of valuation schedules. It is expected that this variance will resolve once the outstanding property schedules are delivered.
- Fees and Charges are \$0.29 million above the year-to-date budget, mainly due to earlier-than-expected receipts in several areas. Development and Safety revenues exceed budget by \$0.58 million, and Recreation and Place by \$0.51 million. These gains are partly offset by lower lease revenue (\$0.34 million) and landfill fees (\$0.27 million).
- Operating Grants, Subsidies & Contributions are \$0.30 million above budget overall, mainly due to early Financial Assistance grants (\$1.39 million above budget), insurance claim recoveries (\$0.30 million), non-recurrent Roe-8 funding timing (\$0.28 million), and unexpected sportsground contributions (\$0.21 million). Family Day Care (\$0.52 million) and Cockburn Care (\$1.45 million) are below budget, but these shortfalls are offset by the other favourable variances.
- Interest earnings are \$0.63 million above the year-to-date budget; cashflow projections will be updated.
- Other Revenue: This category is \$0.98 million higher than the year-to-date budget, mainly because of a one-time item that was not part of the original budget. This item concerns a confidential issue previously reported to the Council.

Operating Expenditure

The City reported operating expenditures totalling \$99.78 million to December 2025, which is \$4.48 million less than the year-to-date budgeted amount of \$104.25 million.

Year-to-date operating expenses show key budget variances; any adjustments will be addressed in the Mid-Year Budget Review.

- Employee Costs will be closely reviewed as part of the mid-year budget process.
- Materials and Contracts are \$3.79 million under budget year-to-date, mainly due to project timing. Information Technology is \$0.83 million below budget, including \$0.30 million from GIS migration, but software support is \$0.67 million over budget.
- The TechnologyOne CiAnywhere project is \$0.33 million under budget due to project phasing.
- Cockburn ARC materials and contract costs are \$0.82 million below budget.
- Coastal Management and Planning Sand Bypassing is currently \$0.30 million under budget due to the timing of scheduled works.
- Street maintenance is \$1.1M under budget.
- Cockburn ARC building maintenance is \$0.74 million under budget.
- Henderson Landfill operations are \$0.64 million over budget, drainage maintenance is \$0.48 million over budget, and road maintenance is \$0.31 million over budget.
- Family Daycare parent payments are \$0.38 million below the allocated budget.
- Utility charges are \$0.60 million over budget mainly due to power expenses for street lighting (cashflow timing).
- Other Expenditure is \$0.64 million under budget, primarily due to the cashflow timing of the landfill levy, which is \$0.38 million below budget.



- Depreciation expense is \$0.50 million overbudget due to timing differences in asset capitalisation, with depreciation commencing earlier than assumed in the budget. The position will be reviewed as part of the mid-year budget review.

### Capital Expenditure

The revised capital works budget for 2025–26 is \$79.95 million, up from \$77.81 million, mainly because of carry-forward adjustments.

As at the end of December 2025, year-to-date capital expenditure totalled \$15.17 million, which is \$4.61 million below the YTD budget of \$19.78 million.

The following major project variances have been identified within the City's capital works program:

- Buildings (\$1.40 million under YTD budget) are underspent due to the staging of works, including Cockburn ARC ducting (\$0.16 million), the solar photovoltaic systems project (\$0.16 million), and works at the Malabar Park BMX facility (\$0.19 million).
- Plant and Equipment (\$1.03 million under YTD budget) is largely attributable to the phasing of the fleet replacement program.
- Roads (\$0.37 million under YTD budget) reflects current project delivery, including the State Blackspot Rowley Road / De Haer intersection, Wattleup Road (Moylan to Postans), and the Banjup traffic calming program.
- Drainage is \$0.46 million under the year-to-date budget due to project scheduling for Bibra Lake Industrial Area lid replacements, Cascara sump wall and fence renewal, and Edeline Street drainage upgrades.

- Footpaths are \$0.37 million under the YTD budget due to ongoing work on Wattleup Road, Spearwood Avenue, and Lake Coogee.
- Parks hard infrastructure are \$0.92 million under YTD budget due to the timing of expenditure on projects including the Waterbuttons Park playground and citywide irrigation renewals.

#### Non-Operating Grants, Subsidies and Contributions

The capital grants and contributions budget for the City in the 2025–26 budget is \$27.03 million, including \$12.50 million in grant funding, mainly for road infrastructure projects, and \$14.52 million from developer contributions for related capital initiatives.

As at 31 December 2025, \$1.65 million in non-operating grants, subsidies, and contributions had been recognised, compared with a year-to-date budget of \$2.19 million. This variance reflects the ongoing realignment of budgeted cashflows with the timing of actual funding recognition.

#### Financial Reserves

A detailed schedule of the City's financial reserves is provided in the financial report, showing a balance of \$225.59 million at the end of December.

Of the total amount, \$187.24 million is allocated to general revenue reserves, while \$38.35 million is designated for specific purposes.

This includes \$25.34 million for Developer Contribution Plans (DCPs) and \$6.20 million for Public Open Space (POS) cash-in-lieu contributions.

Transfers to and from reserves are made in accordance with budgetary and statutory requirements.

#### Cash and Financial Assets

As at 31 December 2025, the City reported cash and financial assets amounting to \$316.60 million, representing a \$6.13 million decrease from November.

This balance comprises financial assets (term deposits and investments) of \$301.23 million, and cash and cash equivalents (bank and call deposits) of \$15.37 million.

Of this balance, \$226.32 million (71.5%) is internally or externally restricted, primarily representing cash-backed reserves, while \$90.29 million (28.5%) remains unrestricted and available to support municipal operations and capital funding requirements.

#### Investment Performance, Ratings and Maturity

Although the RBA kept its cash rate unchanged across November and December, the City's term deposit portfolio recorded a slight softening in running yield, easing to 4.52% at December month-end (down from 4.54% in November). Despite this minor

movement, portfolio performance remains well above the City’s KPI benchmark of 4.10% (base rate 3.60% plus a 0.50% performance margin).

New investments placed over the period achieved rates above the prior month’s average (November average 4.32% - 4.34%), ranging between 4.45% and 4.77%, consistent with market expectations that further rate cuts are unlikely in the near term.

Current term deposit investments are fully compliant with Council’s Investment Policy requirements, as indicated below:

The portfolio also includes reverse mortgage securities acquired under previous policy and statutory provisions. These securities have a face value of \$2.31 million and a current market value of \$1.49 million. For reporting purposes, the City carries them at a book value of \$0.74 million, net of a \$1.58 million impairment provision recorded several years ago.

The City continues to receive interest and principal repayments, with \$0.70 million recovered to date from the original \$3 million investment.

The City’s short-term deposits (less than 12 months) made up 57.45% (\$177.57 million) of the City’s portfolio, compared to 55.36% (\$175.89 million) in November.


**Market Value by Security Rating Group (Short Term)**

Investment in Fossil Fuel Free Banks

As at 31 December, the City held \$54.3 million with banks that do not fund fossil fuel-related industries. This balance was unchanged from November, and it represented 18.6% of the total investment portfolio, a slight increase in proportional allocation compared with the previous month.

The proportion of fossil fuel-free investments is subject to periodic fluctuations, driven by the competitiveness of deposit rates and the capacity of these institutions to accept additional funds.

Nonetheless, the City remains committed to prioritising such investments, provided they continue to offer rates that are competitive with other financial institutions.

Rates Debt Recovery

For 2025-26, total collectible rates and charges (including net arrears, annual levies and part-year rating) total \$168 million.

As at 31 December, the City had collected \$117.94 million, representing 70.20% of the total. This leaves an outstanding balance of \$50.06 million (29.80%). After excluding deferred rates of \$1.17 million, the remaining collectible balance stands at \$48.89 million (29.10%).

The City received \$1.12 million in rate prepayments for the next financial year. In addition, \$0.24 million in underground power charges was collected as part of year three of the ten-year plan.

Overdue rates and charges subject to debt recovery decreased to 380 properties, totalling \$1.47 million, compared with 509 properties and \$1.77 million in November.

This reduction reflects ratepayer payments and arrangements made following contact from officers as part of the City's debt recovery program. This does not mean all of these accounts are subject to legal action, rather, it reflects the annual timing of the City's recovery program, with escalation activity commencing at this point in the year and typically involving increased contact with ratepayers.

Before initiating any formal action, officers take comprehensive steps to work collaboratively with ratepayers to resolve outstanding balances. This includes making direct contact, encouraging payment arrangements, and discussing available support options.

Formal proceedings are only commenced where rates remain unpaid and the ratepayer has not entered into an instalment plan or alternative payment arrangement, nor sought assistance under the City's Financial Hardship Policy.

#### Trade and Sundry Debtors

Outstanding trade and sundry debtors totalled \$1.49 million at the end of December, a decrease from \$2.01 million in the previous month.

The value of debts overdue by more than 90 days increased to \$0.328 million (22.09%), up from \$0.135 million (6.72%) in November. This significant increase is attributable to Naval Base debtors who did not pay their original invoices in full by the due date and have since transitioned to instalment payment arrangements.

Debts outstanding for more than 90 days include \$201k relating to Naval Base shacks, \$59k for leasing debtors, and \$17k from landfill customers. These balances are subject to active management and ongoing follow-up.



**KEY TERMS AND DESCRIPTIONS**

FOR THE PERIOD ENDED 31 DECEMBER 2025

**REVENUE****RATES**

All rates levied under the *Local Government Act 1995*. Includes general, differential, specified area rates, minimum rates, interim rates, back rates, ex-gratia rates, less discounts and concessions offered. Exclude administration fees, interest on instalments, interest on arrears, service charges and sewerage rates.

**OPERATING GRANTS, SUBSIDIES AND CONTRIBUTIONS**

Refers to all amounts received as grants, subsidies and contributions that are not non-operating grants.

**NON-OPERATING GRANTS, SUBSIDIES AND CONTRIBUTIONS**

Amounts received specifically for the acquisition, construction of new or the upgrading of identifiable non financial assets paid to local government, irrespective of whether these amounts are received as capital grants, subsidies, contributions or donations.

**REVENUE FROM CONTRACTS WITH CUSTOMERS**

Revenue from contracts with customers is recognised when the local government satisfies its performance obligations under the contract.

**FEES AND CHARGES**

Revenues (other than service charges) from the use of facilities and charges made for local government services, sewerage rates, rentals, hire charges, fee for service, photocopying charges, licences, sale of goods or information, fines, penalties and administration fees. Local governments may wish to disclose more detail such as rubbish collection fees, rental of property, fines and penalties, other fees and charges.

**SERVICE CHARGES**

Service charges imposed under *Division 6 of Part 6 of the Local Government Act 1995. Regulation 54 of the Local Government (Financial Management) Regulations 1996* identifies these as television and radio broadcasting, underground electricity and neighbourhood surveillance services. Exclude rubbish removal charges. Interest and other items of a similar nature received from bank and investment accounts, interest on rate instalments, interest on rate arrears and interest on debtors.

**INTEREST EARNINGS**

Interest and other items of a similar nature received from bank and investment accounts, interest on rate instalments, interest on rate arrears and interest on debtors.

**OTHER REVENUE / INCOME**

Other revenue, which can not be classified under the above headings, includes dividends, discounts, rebates etc.

**PROFIT ON ASSET DISPOSAL**

Excess of assets received over the net book value for assets on their disposal.

**NATURE OR TYPE DESCRIPTIONS****EXPENSES****EMPLOYEE COSTS**

All costs associate with the employment of person such as salaries, wages, allowances, benefits such as vehicle and housing, superannuation, employment expenses, removal expenses, relocation expenses, worker's compensation insurance, training costs, conferences, safety expenses, medical examinations, fringe benefit tax, etc.

**MATERIALS AND CONTRACTS**

All expenditures on materials, supplies and contracts not classified under other headings. These include supply of goods and materials, legal expenses, consultancy, maintenance agreements, communication expenses, advertising expenses, membership, periodicals, publications, hire expenses, rental, leases, postage and freight etc. Local governments may wish to disclose more detail such as contract services, consultancy, information technology, rental or lease expenditures.

**UTILITIES (GAS, ELECTRICITY, WATER, ETC.)**

Expenditures made to the respective agencies for the provision of power, gas or water. Exclude expenditures incurred for the reinstatement of roadwork on behalf of these agencies.

**INSURANCE**

All insurance other than worker's compensation and health benefit insurance included as a cost of employment.

**LOSS ON ASSET DISPOSAL**

Shortfall between the value of assets received over the net book value for assets on their disposal.

**DEPRECIATION ON NON-CURRENT ASSETS**

Depreciation expense raised on all classes of assets.

**INTEREST EXPENSES**

Interest and other costs of finance paid, including costs of finance for loan debentures, overdraft accommodation and refinancing expenses.

**OTHER EXPENDITURE**

Statutory fees, taxes, allowance for impairment of assets, member's fees or State taxes. Donations and subsidies made to community groups.

**BASIS OF PREPARATION**

**REPORT PURPOSE**

This report is prepared to meet the requirements of *Local Government (Financial Management) Regulations 1996*, Regulation 34. Note: The statements and accompanying notes are prepared based on all transactions recorded at the time of preparation and may vary due to transactions being processed for the reporting period after the date of preparation.

**BASIS OF ACCOUNTING**

This statement comprises a special purpose financial report which has been prepared in accordance with Australian Accounting Standards (as they apply to local governments and not-for-profit entities) and Interpretations of the Australian Accounting Standards Board, and the *Local Government Act 1995* and accompanying regulations.

The *Local Government (Financial Management) Regulations 1996* take precedence over Australian Accounting Standards. Regulation 16 prohibits a local government from recognising as assets Crown land that is a public thoroughfare, such as land under roads, and land not owned by but under the control or management of the local government, unless it is a golf course, showground, racecourse or recreational facility of State or regional significance. Consequently, some assets, including land under roads acquired on or after 1 July 2008, have not been recognised in this financial report. This is not in accordance with the requirements of *AASB 1051 Land Under Roads paragraph 15* and *AASB 116 Property, Plant and Equipment paragraph 7*.

Accounting policies which have been adopted in the preparation of this financial report have been consistently applied unless stated otherwise. Except for cash flow and rate setting information, the report has been prepared on the accrual basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and liabilities.

**CRITICAL ACCOUNTING ESTIMATES**

The preparation of a financial report in conformity with Australian Accounting Standards requires management to make judgements, estimates and assumptions that effect the application of policies and reported amounts of assets and liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances; the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

**THE LOCAL GOVERNMENT REPORTING ENTITY**

All funds through which the City controls resources to carry on its functions have been included in the financial statements forming part of this financial report.

In the process of reporting on the local government as a single unit, all transactions and balances between those funds (for example, loans and transfers between funds) have been eliminated.

All monies held in the Trust Fund are excluded from the financial statements. A separate statement of those monies







**SIGNIFICANT ACCOUNTING POLICIES**

All assets are initially recognised at cost. Cost is determined as the fair value of the assets given as consideration plus costs incidental to the acquisition. For assets acquired at no cost or for nominal consideration, cost is determined as fair value at the date of acquisition. The cost of non-current assets constructed by the local government includes the cost of all materials used in the construction, direct labour on the project and an appropriate proportion of variable and fixed overhead. Certain asset classes may be revalued on a regular basis such that the carrying values are not materially different from fair value. Assets carried at fair value are to be revalued with sufficient regularity to ensure the carrying amount does not differ materially from that determined using fair value at reporting date.



**KEY INFORMATION**

**Provisions**

Provisions are recognised when the City has a present legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Provisions are measured using the best estimate of the amounts required to settle the obligation at the end of the reporting period.

**Employee benefits**

**Short-term employee benefits**

Provision is made for the City's obligations for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries and sick leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled.

The City's obligations for short-term employee benefits such as wages, salaries and sick leave are recognised as a part of current trade and other payables in the calculation of net current assets.

**Other long-term employee benefits**

The City's obligations for employees' annual leave and long service leave entitlements are recognised as provisions in the statement of financial position.

Long-term employee benefits are measured at the present value of the expected future payments to be made to employees. Expected future payments incorporate anticipated future wage and salary levels, durations of service and employee departures and are discounted at rates determined by reference to market yields at the end of the reporting period on government bonds that have maturity dates that approximate the terms of the obligations. Any remeasurements for changes in assumptions of obligations for other long-term employee benefits are recognised in profit or loss in the periods in which the changes occur. The City's obligations for long-term employee benefits are presented as non-current provisions in its statement of financial position, except where the City does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current provisions.

**Contract liabilities**

An entity's obligation to transfer goods or services to a customer for which the entity has received consideration (or the amount is due) from the customer. Grants to acquire or construct recognisable non-financial assets to identified specifications be constructed to be controlled by the City are recognised as a liability until such time as the City satisfies its obligations under the agreement.



**KEY TERMS AND DESCRIPTIONS**

FOR THE PERIOD ENDED 30 NOVEMBER 2025

**REVENUE****RATES**

All rates levied under the *Local Government Act 1995*. Includes general, differential, specified area rates, minimum rates, interim rates, back rates, ex-gratia rates, less discounts and concessions offered. Exclude administration fees, interest on instalments, interest on arrears, service charges and sewerage rates.

**OPERATING GRANTS, SUBSIDIES AND CONTRIBUTIONS**

Refers to all amounts received as grants, subsidies and contributions that are not non-operating grants.

**NON-OPERATING GRANTS, SUBSIDIES AND CONTRIBUTIONS**

Amounts received specifically for the acquisition, construction of new or the upgrading of identifiable non financial assets paid to local government, irrespective of whether these amounts are received as capital grants, subsidies, contributions or donations.

**REVENUE FROM CONTRACTS WITH CUSTOMERS**

Revenue from contracts with customers is recognised when the local government satisfies its performance obligations under the contract.

**FEES AND CHARGES**

Revenues (other than service charges) from the use of facilities and charges made for local government services, sewerage rates, rentals, hire charges, fee for service, photocopying charges, licences, sale of goods or information, fines, penalties and administration fees. Local governments may wish to disclose more detail such as rubbish collection fees, rental of property, fines and penalties, other fees and charges.

**SERVICE CHARGES**

Service charges imposed under *Division 6 of Part 6 of the Local Government Act 1995. Regulation 54 of the Local Government (Financial Management) Regulations 1996* identifies these as television and radio broadcasting, underground electricity and neighbourhood surveillance services. Exclude rubbish removal charges. Interest and other items of a similar nature received from bank and investment accounts, interest on rate instalments, interest on rate arrears and interest on debtors.

**INTEREST EARNINGS**

Interest and other items of a similar nature received from bank and investment accounts, interest on rate instalments, interest on rate arrears and interest on debtors.

**OTHER REVENUE / INCOME**

Other revenue, which can not be classified under the above headings, includes dividends, discounts, rebates etc.

**PROFIT ON ASSET DISPOSAL**

Excess of assets received over the net book value for assets on their disposal.

**NATURE OR TYPE DESCRIPTIONS****EXPENSES****EMPLOYEE COSTS**

All costs associate with the employment of person such as salaries, wages, allowances, benefits such as vehicle and housing, superannuation, employment expenses, removal expenses, relocation expenses, worker's compensation insurance, training costs, conferences, safety expenses, medical examinations, fringe benefit tax, etc.

**MATERIALS AND CONTRACTS**

All expenditures on materials, supplies and contracts not classified under other headings. These include supply of goods and materials, legal expenses, consultancy, maintenance agreements, communication expenses, advertising expenses, membership, periodicals, publications, hire expenses, rental, leases, postage and freight etc. Local governments may wish to disclose more detail such as contract services, consultancy, information technology, rental or lease expenditures.

**UTILITIES (GAS, ELECTRICITY, WATER, ETC.)**

Expenditures made to the respective agencies for the provision of power, gas or water. Exclude expenditures incurred for the reinstatement of roadwork on behalf of these agencies.

**INSURANCE**

All insurance other than worker's compensation and health benefit insurance included as a cost of employment.

**LOSS ON ASSET DISPOSAL**

Shortfall between the value of assets received over the net book value for assets on their disposal.

**DEPRECIATION ON NON-CURRENT ASSETS**

Depreciation expense raised on all classes of assets.

**INTEREST EXPENSES**

Interest and other costs of finance paid, including costs of finance for loan debentures, overdraft accommodation and refinancing expenses.

**OTHER EXPENDITURE**

Statutory fees, taxes, allowance for impairment of assets, member's fees or State taxes. Donations and subsidies made to community groups.

**BASIS OF PREPARATION**

**REPORT PURPOSE**

This report is prepared to meet the requirements of *Local Government (Financial Management) Regulations 1996*, Regulation 34. Note: The statements and accompanying notes are prepared based on all transactions recorded at the time of preparation and may vary due to transactions being processed for the reporting period after the date of preparation.

**BASIS OF ACCOUNTING**

This statement comprises a special purpose financial report which has been prepared in accordance with Australian Accounting Standards (as they apply to local governments and not-for-profit entities) and Interpretations of the Australian Accounting Standards Board, and the *Local Government Act 1995* and accompanying regulations.

The *Local Government (Financial Management) Regulations 1996* take precedence over Australian Accounting Standards. Regulation 16 prohibits a local government from recognising as assets Crown land that is a public thoroughfare, such as land under roads, and land not owned by but under the control or management of the local government, unless it is a golf course, showground, racecourse or recreational facility of State or regional significance. Consequently, some assets, including land under roads acquired on or after 1 July 2008, have not been recognised in this financial report. This is not in accordance with the requirements of *AASB 1051 Land Under Roads paragraph 15* and *AASB 116 Property, Plant and Equipment paragraph 7*.

Accounting policies which have been adopted in the preparation of this financial report have been consistently applied unless stated otherwise. Except for cash flow and rate setting information, the report has been prepared on the accrual basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and liabilities.

**CRITICAL ACCOUNTING ESTIMATES**

The preparation of a financial report in conformity with Australian Accounting Standards requires management to make judgements, estimates and assumptions that effect the application of policies and reported amounts of assets and liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances; the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

**THE LOCAL GOVERNMENT REPORTING ENTITY**

All funds through which the City controls resources to carry on its functions have been included in the financial statements forming part of this financial report.

In the process of reporting on the local government as a single unit, all transactions and balances between those funds (for example, loans and transfers between funds) have been eliminated.

All monies held in the Trust Fund are excluded from the financial statements. A separate statement of those monies







SIGNIFICANT ACCOUNTING POLICIES

All assets are initially recognised at cost. Cost is determined as the fair value of the assets given as consideration plus costs incidental to the acquisition. For assets acquired at no cost or for nominal consideration, cost is determined as fair value at the date of acquisition. The cost of non-current assets constructed by the local government includes the cost of all materials used in the construction, direct labour on the project and an appropriate proportion of variable and fixed overhead. Certain asset classes may be revalued on a regular basis such that the carrying values are not materially different from fair value. Assets carried at fair value are to be revalued with sufficient regularity to ensure the carrying amount does not differ materially from that determined using fair value at reporting date.

**Employee benefits**

**Short-term employee benefits**

Provision is made for the City's obligations for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries and sick leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled.

The City's obligations for short-term employee benefits such as wages, salaries and sick leave are recognised as a part of current trade and other payables in the calculation of net current assets.

**Other long-term employee benefits**

The City's obligations for employees' annual leave and long service leave entitlements are recognised as provisions in the statement of financial position.

Long-term employee benefits are measured at the present value of the expected future payments to be made to employees. Expected future payments incorporate anticipated future wage and salary levels, durations of service and employee departures and are discounted at rates determined by reference to market yields at the end of the reporting period on government bonds that have maturity dates that approximate the terms of the obligations. Any remeasurements for changes in assumptions of obligations for other long-term employee benefits are recognised in profit or loss in the periods in which the changes occur. The City's obligations for long-term employee benefits are presented as non-current provisions in its statement of financial position, except where the City does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current provisions.

**Contract liabilities**

An entity's obligation to transfer goods or services to a customer for which the entity has received consideration (or the amount is due) from the customer. Grants to acquire or construct recognisable non-financial assets to identified specifications be constructed to be controlled by the City are recognised as a liability until such time as the City satisfies its obligations under the agreement.

## Background

The following Notice of Motion was received from Deputy Mayor Widenbar on 21 June 2023:

*That Council, following the completion of the City of Cockburn District Traffic Study 2024, REQUESTS the City to undertake investigation of the intersection of Spearwood Avenue and Beeliar Drive to assess both road safety and congestion (intersection performance) characteristics, with a report back to Council indicating potential upgrade options, costings and required timelines for delivery of the required upgrades.*

#### Reason

The intersection of Beeliar Drive and Spearwood Avenue is an important junction of two district distributor roads.



The intersection has experienced increasing congestion and incidences of accidents in recent years. Continued growth in the local area and limited upgrade options require long term planning to ensure this intersection may continue to serve the local community.

Subsequently, the following recommendation was adopted at the 13 July 2023 Ordinary Council Meeting - Item 17.1 (2023/MINUTE NO 0184) Intersection of Spearwood Avenue and Beeliar Drive – Investigation

#### **Officer Recommendation/Council Decision**

That Council REQUESTS the City undertake investigation of the intersection of Spearwood Avenue and Beeliar Drive.

Investigation purpose is to assess both road safety and congestion (intersection performance) characteristics, with a report back to Council indicating potential upgrade options, costings and required timelines for delivery of the required upgrades. Timing of the report to Council to be within 12 months of the Council endorsement of the updated District Traffic Study.

#### **Submission**

#### **Report**

Further to the adoption of the updated City of Cockburn District Traffic Study at the OCM 13 August 2024 Item 14.1.1, the City has undertaken an investigation of potential upgrades for the intersection of Spearwood Avenue and Beeliar Drive.

#### Existing Road Network

##### Beeliar Drive

Beeliar Drive is a dual-lane divided Distributor A road operating under a 70 km/h speed limit. Traffic data (August 2024) indicates an average weekday flow of 30,620 vehicles per day, including 10% heavy vehicles, with an 85th percentile speed of 75 km/h.

##### Spearwood Avenue

Spearwood Avenue is a dual-lane divided Distributor A road north of the intersection, with a single-lane road south of the roundabout. Traffic volumes (July 2024) show 20,396 vehicles per day, including 13% heavy vehicles, and an 85th percentile speed of 68 km/h.

The existing roundabout provides four pedestrian and cyclist crossings utilising raised medians as refuge islands.

### Crash Data Analysis

Main Roads WA Crash Map data for the five years ending December 2024 shows 53 crashes, including 12 injury crashes requiring medical intervention and 41 non-injury crashes. The majority (38 crashes) were rear-end collisions, typical of intersections experiencing queuing rather than design-related safety issues (refer Attachment 1).

### Combined Operational and Safety Assessment

Despite high traffic volumes the roundabout demonstrates strong safety performance consistent with Austroads guidance for high-volume roundabouts. Rear-end crashes dominate, with relatively few severe collisions.

However, congestion has become a material issue, with SIDRA modelling and on-site observations confirming substantial queuing during peak periods and Degree of Saturation (DoS) values exceeding 100%. This indicates the intersection is operating beyond available capacity, warranting consideration of upgrade options.

### Transport Planning Context

The District Traffic Study (2023) indicates that future year scenarios will result in both AM and PM peak operations exceeding acceptable capacity on the west and north approaches.

Beelias Drive was previously assessed by Main Roads WA for transition to the State road network due to its regional significance. Although removed in the latest review, the City continues engagement with Main Roads regarding long-term ownership.

The Main Roads WA (MRWA) Future Roads framework outlines potential reclassification of regional routes, with Russell Road now identified as a more immediate candidate as opposed to Beelias Drive.

The intersection is identified in Structure Plan Cell 9 (Yangebup) and Cell 10 (Beelias) as ultimately operating under traffic signal control.

Surrounding residential areas include R40 and R60 densities, supporting higher active transport activity.




Figure 2: Extract from Structure Plan Cell 9, Yangebup & Cell 10 Beelias

### Upgrade Options Considered

The City commissioned SMEC to undertake intersection capacity and conceptual geometric modelling for four upgrade options

1. Existing intersection layout
2. Existing intersection layout with additional lane capacity
3. Metered roundabout
4. Traffic signals

### Guidance on Degree of Saturation

Intersection modelling considers many different factors, most commonly when considering intersection capacity the degree of saturation (DoS) is a key factor to address.

Main Roads Western Australia Traffic Signal Approval Policy provides guidance on acceptable levels of saturation

- Desirable DoS range 0.85-0.95
- DoS = 1.0 (100%): intersection at capacity
- DoS > 1.0: demand exceeds capacity.

A typical representation of Degree of Saturation as considered as user experience is provided below for reference.

### **Degree of Saturation (DoS) Summary Table**

<b>DoS Range</b>	<b>Operational Behaviour</b>	<b>User Experience Summary</b>
< 0.60	Uncongested flow	Free-flow travel, negligible delay
0.60–0.85	Stable flow	Minor delays, short queues
0.85–1.00	Near capacity	Noticeable queues, moderate delays, sensitivity to disturbances
1.00	At capacity	Sustained queues, unstable flow, increased delay
> 1.00	Over-saturated	Long queues, significant delays, network stress

### Option 1: Existing intersection layout

Site observations and SIDRA results confirm significant queues on the south and east approaches during peak periods. DoS values exceed 100% for both existing and future scenarios.

A roundabout operating above capacity on a high-volume arterial road also reduces safe crossing gaps, presenting challenges for pedestrians and cyclists.

Conclusion: Not suitable for current or future traffic conditions.



Option 2: Existing intersection layout (Roundabout) with additional lane capacity

Option 2 A:

Additional lanes on Spearwood Avenue provide limited improvement. Future year modelling shows DoS values  $\geq 120\%$ , indicating failure to meet acceptable performance thresholds.

Conclusion: Not suitable for current or future traffic conditions.




Figure 4: Existing intersection layout with additional lane capacity along Spearwood Avenue

Option 2 B:

Further widening and additional turning lanes on Beelihar Drive provide marginal additional benefit. Future year PM peak DoS is 126%, although AM peak remains within acceptable ranges.

Both variations continue to operate above capacity in key peak periods and remain unsuitable for safe active transport due to reduced crossing opportunities.

Upgrade Cost: Approximately \$3.38 million.

Conclusion: Improvements are insufficient to meet long-term performance needs.




Figure 5: Existing intersection layout with additional lane capacity along Spearwood Avenue and Beelihar Drive

### Option 3: Metred Roundabout with Additional Capacity

This option adds lane capacity and signalised metering on Beelias Drive legs.

SIDRA results show modest performance gains over Option 2; however, DoS still exceeds 100% (approximately 105% PM peak).

While metering can enhance congestion performance, it cannot support additional pedestrian protection without reducing vehicle capacity — negating its primary function.

Key constraints include:

- High-volume arterial setting with limited safe crossing gaps at high saturation
- Significant land limitations preventing expansion of the central island or free-flow slip lanes
- Restricted Access Vehicle (up to 32.5 m) requirements along west and north approaches.

Upgrade Cost: Approximately \$3.98 million.

Conclusion: Operational improvements achieved but still fails to meet acceptable DoS and does not support active transport safety.




Figure 6: Metred Roundabout with additional capacity

Option 4: Traffic Signals (Preferred Option)

Traffic signals achieve AM DoS 95% and PM DoS 97%, maintaining operations below full saturation. Wide existing medians allow dual turn pockets, supporting higher throughput.

Signals also deliver:

- Controlled pedestrian and cyclist crossings, essential for safe access in a growing, higher-density residential catchment
- A layout consistent with Structure Plan intent for the area
- Improved safety for all modes through regulated conflict points.

Upgrade Cost: Approximately \$6 million. Includes costs for detailed design and construction.

Conclusion:

This is the only option that:

- Meets DoS performance targets
- Accommodates Future Year traffic growth
- Provides a safe, legible, and equitable intersection for all users.




Figure 8: Traffic Signals Option

### Approvals and Funding

Advancing the traffic signal option requires formal approval under the Main Roads WA Traffic Signals Approval Policy, with review processes typically taking 12–24 months. This approval is required in advance of any application for funding.

Given total project costs exceed Black Spot thresholds (State and Federal), alternative funding sources include:

- Metropolitan Region Road Group Improvement Grants
- State/Federal advocacy efforts with local Members of Parliament.

### Summary

The assessment demonstrates that roundabout-based options, even when widened or metered, cannot achieve acceptable DoS performance under forecast traffic volumes. These do not provide appropriate active transport protection on this high-volume corridor.

Traffic signals are the only option that:

- Meets long term congestion and capacity requirements
- Aligns with strategic planning frameworks
- Supports safe and reliable pedestrian and cyclist access
- Provides the most resilient and adaptable long term intersection form.

### **Strategic Plans/Policy Implications**

#### City Growth and Moving Around

A growing City that is easy to move around and provides great places to live.

The top three priorities for Moving Around the City identified by the community in the City of Cockburn *Strategic Community Plan 2020-2030* were:

- Road safety
- Improved public transport options including better connected and more frequent buses
- Traffic congestion and freight movement

The City is investigating and carefully planning for the future needs of our community, improving road infrastructure to improve road safety outcomes.

### **Budget/Financial Implications**

Current investigation and concept designs have been funded from the City's Operational Budgets within Transport and Traffic.

To progress this investigation further it is recommended that an Operational Project be established and be funded through budget to an established timeframe and scope.

The detailed design and construction stages of this project are considered long term at this stage. This project is not currently considered within the Forward Capital Works Model. Funding would need to be assigned within the Forward Capital Works Model with consideration of funding mix. Funding options are discussed above with either option likely requiring significant Municipal funding contributions, possibilities exist within funding programs and political cycles which lessen the burden on Municipal reserves.

**Community Consultation**

The 2024 Cockburn Liveability Survey Results Place Score reflects the community's desire for a well-connected cycling and walking network and safe access to the local road network.

Public consultation with the adjacent or impacted property owners will be carried out when more detailed designs for the preferred layout is approved by Council and subsequent to the approval by MRWA should traffic signals be progressed.

**Risk Management Implications**

The proposed modification will improve the performance of the intersection of Spearwood Avenue / Beeliar Drive. Should Council not approve the recommendation, the community concerns about safety and congestion will remain. This risk is considered a moderate reputational risk.

As a project with significant capital value, detailed planning and designs are required to appropriately mitigate the financial risks associated with delivery of the project. This risk is rated as a moderate financial risk.

#### Community Conversations

There have been two Community Conversations held at Cockburn Central, in line with the Corporate Business Plan 2025/26 project of developing a Towns Team approach to activate Cockburn Central.

The focus has been on supporting the group to understand and participate in the Towns Team approach and to trial activation activities.

The tender is based on the Schedule of Rates detailed in Confidential Attachment 2, applicable for a contract term of three (3) years, which may increase subject to CPI and approved Council operational and project budgets each financial year.

The tender includes discretionary options to extend the contract term for one (1) year and subsequently up to and additional twelve (12) months, to a maximum of five (5) years, exercisable under Delegated Authority and subject to CPI and approved Council operational and project budget each financial year.

**Background**

The City of Cockburn sought the services of a suitably qualified and experienced service provider to undertake the educting and cleaning of gully pits, access pits, and gross pollutant traps, as well as to assist with the road sweeping program at various locations throughout the City.

Prospective tenderers involved in controlled or liquid waste disposal were required to hold a current Department of Water and Environmental Regulation (DWER) Controlled Waste Carrier licence for their business, drivers, and vehicles.

The scope of required services encompasses both scheduled and unscheduled activities, including inspection, programming, comprehensive reporting (including defect reporting), as well as the educting and cleaning of gully pits, access pits, associated pipework, and gross pollutant traps.

Repair works are excluded from this contract. Road sweeping is not part of the standard scope of works. However, the tender provides that the Contractor may be requested to provide road sweeping services as an optional item if required by the City.



The City has 24,115 drainage pits with subdivision developments increasing the number of pits each year. Industry practice to maintain effective drainage systems requires these pits are cleaned biannually to minimise flooding and blockages.

With additional treatments for Bubble Up pits and Gross Pollutant traps. The cleaning of drainage pits stops sand and debris entering the pipes and mitigates blockages so that the pipes maintain their primary function and the hydraulics required to drain the water during rain events.

Planned maintenance is key to managing a drainage network. The risk of failure to maintain the drainage system can cause flooding, sink holes and damage the City's reputation as well as increased insurance claims. With 562km of pipes the risk of failure to maintain significantly increases the reactive investigation and cleaning costs.

The proposed Contract will be in place for a period of three (3) years from the date of award; with City instigated options to extend the period for one (1) subsequent year and up to an additional twelve (12) months after that, to a maximum of five (5) years.

Tender Number RFT36/2025 – Educting/Cleaning Services – Gully and Access Pits, was advertised on Wednesday, 12 November 2025 in the Local Government Tenders section of “The West Australian” newspaper. It was also displayed on the City's website and e-Tendering platform between Wednesday, 12 November 2025 and 2:00pm (AWST) Thursday, 27 November 2025.

AARO Group demonstrated strong experience, provided detailed organisation information and detailed relevant projects that delivered value-added services to local governments; they were more project related to pipe relining rather than services aligning with the scope of works requested by the City.

Drainflow Services provided satisfactory responses, though these contained limited detail regarding company size, organisational structure, and specific project information. Drainflow Services maintains multiple contracts with local government entities for similar service types.

Tenderers Resources

AARO Group provided a structured response with clear details on current commitments, nominated staff, subcontractors, and a basic contingency plan, supported by satisfactory plant and equipment list. It was noted they demonstrated reliance on subcontractors.

Drainflow Services demonstrated significant resource capacity with a large fleet and multiple contracts.

Methodology

AARO Group provided a detailed methodology covering cleaning processes, quality control, traffic and pedestrian management, and emergency response, including a 24/7 contact system and two-hour response time, though some evaluators noted minor gaps in traffic management details.

Drainflow Services outlined its approach with descriptions of equipment and processes, emergency availability, and resource capacity. Overall, AARO Group scored higher for clarity and comprehensiveness, while DFS demonstrated capability.

Sustainability

Both tenderers demonstrated sustainability initiatives, each with differing focus. AARO Group emphasised operational practices such as water recycling, reuse of flushed water, use of sustainable products, and investment in renewable energy (175 solar panels, EV fleet), supported by ISO 14001 certification. Additionally, AARO Group outlined social procurement strategies through Indigenous employment and



partnerships with Aboriginal businesses, together with a comprehensive diversity and inclusion policy.

Drainflow Services highlighted environmental innovation with its Hydro Wash facility achieving a 91.73% recovery rate, circular economy practices, composting, and biodiversity protection, also backed by ISO 14001 certification.

### Local and Regional

AARO demonstrated a strong local presence with its Kwinana Beach location, employment of local staff, engagement with local suppliers, and commitment to offering traineeships and apprenticeships, directly contributing to the regional economy.

In contrast, Drainflow Services operates from Malaga and referenced adherence to WA's Buy Local Policy and provided limited evidence of direct local economic impact within the City boundaries or South West Metropolitan region.

### Tender Summation

The evaluation panel recommends that Council accept the submission from DFS Industrial & Environmental Services Pty Ltd T/as Drainflow Services as being the most advantageous tenderer to deliver the requirement of RFT36/2025 - Educting / Cleaning Services – Gully and Access Pits.

Drainflow Services achieved the highest overall score due to its competitive pricing and strict adherence to specified requirements. Reference checks were successfully completed with positive feedback, and the company also passed an externally conducted Financial Risk Assessment.

The recommendation is based on:

- Well demonstrated experience in performing similar work for other local governments;
- A range of personnel that have experience in managing the works associated with the requirements of the contract;
- Having the required resources and contingency measures to undertake the works;

The best overall value for money that provides the most advantageous outcome for the City in performing the works.

### **Budget/Financial Implications**

The estimated contract value is \$3,728,720 (ex GST) over a three year period. This estimate is based on the cleaning of 10,000 drainage pits per annum, representing an uplift of 1,000 pits per annum compared to the *Drainage Asset Management Plan 2020–2024*. As this is a schedule of rates contract, annual expenditure will continue to be governed by annual operational budgets adopted by Council, and the contract does not commit the City to any fixed number of pits per year.

Operational experience indicates that the current service level is not sufficiently prescriptive to reflect the differing maintenance needs across pit types, locations, and risk categories within the drainage network. To ensure effective and efficient asset management, a more targeted, risk-based service level framework is recommended for development as part of the upcoming Drainage Asset Management Plan review.

For the remainder of the current financial year, drainage maintenance will be delivered under a primarily reactive maintenance approach, supplemented by modest proactive educting in accordance with the currently adopted drainage maintenance budgets. While this approach is necessary to remain within existing financial constraints, it is acknowledged that it will carry an elevated risk of localised flooding, particularly during high-intensity rainfall events.

Should flooding occur, operational teams will be deployed promptly to respond to blocked drains and restore flow paths to mitigate impacts on community safety and infrastructure. This reactive approach will remain in place until revised, sustainable long-term service levels and funding allocations are established through the Drainage Asset Management Plan review and included in the review of the Long Term Financial Plan.

### **Risk Management Implications**

Failure to award and implement this contract will result in the City being unable to maintain its drainage network in accordance with industry best practice. The key risks include:

- **Increased Flooding and Blockages:** Without scheduled cleaning, sand and debris will accumulate in pits and pipes, reducing hydraulic capacity and increasing the likelihood of flooding during rain events.
- **Infrastructure Damage:** Blockages can lead to pipe failures, sinkholes, and costly emergency repairs.



- Escalating Reactive Costs: Lack of planned maintenance will significantly increase reactive investigation and cleaning costs, which are typically higher than scheduled works.
- Reputational Damage: Flooding and infrastructure failures can negatively impact community confidence and the City's reputation.
- Insurance and Liability Exposure: Increased risk of property damage and personal injury claims, leading to higher insurance costs and potential legal liabilities.
- Environmental Impact: Unmaintained gross pollutant traps may allow pollutants to enter waterways, breaching environmental obligations.

## Background

The City of Cockburn has a demonstrated leadership commitment to Aboriginal and Torres Strait Islander and diverse cultures, which has been consolidated through multiple Reconciliation Action Plans (RAPs), since the City became the first metropolitan area local government to have a RAP in 2011. A new RAP is a key deliverable in the current Corporate Business Plan 2025-2029.

The new Strategic Community Plan 2025-2035 endorsed by Council has a key objective to celebrate and recognise Aboriginal and Torres Strait Islander and diverse cultures. The completion of the Aboriginal Cultural and Visitors Centre (ACVC) concept and design stage, along with funding advocacy for the ACVC has been a priority project reflected in the RAP and Corporate Business Plan documents.



The current Corporate Business Plan includes the following action:

At the 25 July 2024 Special Council Meeting, Council adopted the 2024/2025 Budget inclusive of ACVC budget provision, with the following Council resolution:

1. Expenditure to finalise the detail design to be capped at \$250,000.
2. The completed detail design updated Pre-Tender Assessment, and proposed funding model to be presented to a future Council meeting for adoption (including outcomes from the City’s advocacy for further external funding).
3. Access to the remaining budget provision of \$2,000,000 for construction commencement will be subject to Council adoption of the detail design, updated Pre-Tender Assessment, and proposed funding model including either state, federal and/or business institutions.

Advocacy for corporate sector, State and Federal Government funding has been a consistent message through the 10 December 2021 Council resolution endorsing the Concept Plan and reiterated through the above 25 July 2024 resolution.

**Report**

Design documentation

During the 2024/2025 financial year the ACVC design was finalised within the determined Council Budget. The site plan and floor plan from the detail design documentation is attached (refer Attachment 1). The pre-tender estimate was completed in August 2025 with escalation assumed to February 2026, and determined at \$18.1M.

Advocacy outcomes

Since 2021, the ACVC project has been a priority advocacy project, receiving considerable attention and internal resources to advance messaging and engage through contacts in the philanthropic environment.

The City has facilitated meetings with key stakeholders over this time, including meetings with Minister(s) and senior staff in relevant State and Federal ministries, local Members of Parliament and election candidates.



The City has also made grant applications for the Thriving Suburbs Fund and Housing Support Program Community Empowering Infrastructure programs, unfortunately neither of which were successful.

As part of the City's Advocacy Program, the City hosted target sponsors at Business News breakfasts and provided collateral and follow-up emails.

Furthermore, the City has approached over 40 target organisations in the Cockburn and surrounding regions.

There has been some interest in funding specific community program delivery in the short-term, but no capital investment.

The lack of capital investment had stalled the draw-down of a \$1.5 million grant from Lotterywest COVID recovery funding awarded in 2021. This grant was effectively closed out as the pre-requisite construction milestones had not been achieved by the 2025 deadline.

To support the advocacy requests the City developed and launched a community campaign at [www.cockburn.wa.gov.au/acvc](http://www.cockburn.wa.gov.au/acvc) in collaboration with the Aboriginal Reference Group. This has been well received by the community and aims to highlight the importance of local cultural connection.

### Next Steps

Following completion of the design stage, advocacy can continue with a strengthened message that the detailed design plans are now complete. The advocacy is also to include discussions with Prescribed Body Corporates, which have been established through the Native Title Act 1993 (Cth).

Advocacy outcomes will be updated to Elected Members every six months.

Whilst the ACVC represents a significant future community space, it is recognised there are a number of available spaces within City owned community assets that could facilitate RAP outcomes.

It is proposed that these opportunities are progressed through future direction from the Aboriginal Reference Group. This enables ongoing cultural leadership from the City whilst advocacy for the ACVC continues.

All initial funding allocation is requested to facilitate discussions with the Aboriginal Reference Group on potential use and design of existing assets, which will enable Reconciliation Action Plan outcomes to be explored.

Utilisation of interim spaces may also assist in strengthening future funding applications for the ACVC, by providing measurable data on community engagement, impact and need on progressing the specific goals of the ACVC project which encompasses:

1. **Culturally Safe Space:** Provide a welcoming environment for Aboriginal people to connect with language, culture, and heritage.
2. **Authentic Experience:** Showcase the richness of Nyungar culture through art, storytelling, and language.



3. **Community Connection:** Facilitate events that bring people together, promote respect, and break down stereotypes.
4. **Economic Benefits:** Create jobs and opportunities for Aboriginal people, support local businesses, and boost the local economy.
5. **Reconciliation:** Foster understanding between Aboriginal and non-Aboriginal people, acknowledge past injustices, and build a harmonious future.

Creating a designated space within our existing buildings that could focus on these goals will demonstrate the importance of the ACVC Project and create progress in building the community connections and relationships to achieve these goals.





#### Background

Following recent State and Federal Elections, the City of Cockburn is a recipient of multiple funding commitments supporting community, sporting, infrastructure, and safety initiatives.

City officers worked in conjunction with election candidates for over 12-months ahead of the election to make recommendations for funding to support projects already identified for outyears funding from the Municipal Budget or small projects that have significant impact to clubs and community groups.

Each commitment requires a formal funding agreement between the City and the respective State or Federal agency prior to the release of funds.

To ensure the timely delivery of these projects and avoid delays in commencement, Council approval is sought to authorise the Chief Executive Officer (CEO) to negotiate and execute these agreements once received.

The City has not received correspondence on all of the listed projects and anticipate that some funding will be directly allocated to the relevant lessee or sports groups.

In such instances, the City will support the groups to achieve the agreed outcomes.



In previous years the City has also been the recipient of funding where the original intended recipient or community group has been unable to meet the criteria to facilitate a project – typically involving City managed land or assets. This report provides for that instance as recommendation 1.2.

### **Budget/Financial Implications**

The City will have extra upfront expenses beyond the grant, such as preparing design plans for these projects. These costs must be covered by Municipal Funds since they are not included in any funding agreement.

In some cases, however, these grants may provide advantageous outcomes to the City that may have otherwise been funded upfront by the City. Consideration to the asset management implications of projects also needs to be considered.

The scope of listed projects will be negotiated to require that there is no additional or unplanned spending as a result of the grants, with the possible exception of \$20 million for Wally Hagan redevelopment and \$8 million for Prinsep Park. Both of these projects are subject to a future Council decision; however the City is required to enter into a grant contract in order to secure the funding.



**Legal Implications**

Each contract will be reviewed by the City's legal team. The awarding of works shall be in compliance with the City's Procurement Policy.

**Community Consultation**

There has been no community consultation on the election commitments. Projects requiring engagement will be scoped and delivered by the City of Cockburn in alignment with the City's Engagement Policy.

**Risk Management Implications**

There is a financial risk for the City in not accepting the grant funding, which coincides with the reputational risk posed by the same action.

If the City does not enter into an agreement, it may create an unfavourable relationship with local MPs, the State Government and the community groups who are expecting the projects to be delivered.

Projects may be impacted by delays in contract execution and procurement of available contractors. This will be communicated to stakeholders as necessary.

Jurisdictional and ownership agreements may be required during negotiations – for example the installation of CCTV on Main Roads infrastructure is complex and may require further amendments to the scope in order to remain within budget.

Project scope and cost escalations are also identified risks for consideration. These will be included in the contract, however any costs over the contracted scope and committed funding, including employee costs, will need to be borne by the City of Cockburn.



As the adoption of the Budget is a key Council decision, the Mayor and CEO consider it appropriate to move the Special Meeting of Council so as not to clash with the 2026 ALGA National General Assembly.



The CEO reviewed the Meeting Schedule for June/July to identify potential dates for a rescheduled Special Council Meeting. The following dates were identified as potential options:

- Thursday 18 June; and
- Tuesday 30 June – noting a Briefing Forum is currently scheduled for this date. This Briefing Forum would be rescheduled to the 23 June (the current date of the Special Council Meeting).

Both dates were reviewed by the City’s finance team, who indicated a preference for the 30 June to allow sufficient time for the City to advertise its rates strategy and prepare the 2026/2027 Budget.

**Background**

The *Corruption, Crime and Misconduct Act 2003 (WA)* (the Act) functions as key legislation in conferring special investigative powers on the Corruption and Crime Commission. In doing so, the Act is considered an essential accountability mechanism to scrutinise the use of power in the State.

The Joint Standing Committee on the Corruption and Crime Commission (the Committee) was established to monitor and report to Parliament on the exercise of the function of the Commission.

On 4 December 2025, the Committee commenced an inquiry into ways to modernise the Act (the Inquiry). The terms of reference invite submissions into any part of the Act, but are focused on four key areas:

1. The definition of misconduct, including what should constitute serious misconduct and minor misconduct.
2. Who should be included in the definition of public officer.
3. The impact of disclosure restrictions on:
  - a) Witness welfare
  - b) A witness's ability to assist police
  - c) The ability to provide feedback to complainants.
4. Measures for ensuring robust investigations of allegations when the Corruption and Crime Commission refers matters back to government agencies and the WA Police Force.



The Inquiry is due to be tabled on 19 November 2026, with a deadline for submissions of 13 February 2026.

The City of Cockburn was invited to make a submission to the Inquiry as a government agency directly affected by the Act. A proposed submission was drafted and prepared on the basis of recommendations from both General Counsel for the City and the People Experience Service Manager.

### **Report**

The invitation to offer a submission to the Inquiry was viewed as an opportunity for the City of Cockburn to meaningfully comment on crucial legislation which ensures integrity and trust across the state.

The proposed submission – contained in Annexure 1 - touches on several aspects which the Committee invited comment on. This includes where clarity around specific procedures would be useful, and the specific obligations the City would be under if misconduct would be undertaken.

Additionally, the proposed submission reflects on the importance of being regularly updated so that we may adequately respond to local community concerns and enquiries.

Several proposed changes are also endorsed by the City in the proposed submission, including expanding the definition of public officials to contractors who are performing the work of a public official and allowing disclosure of restricted matters to a registered health practitioner or close relatives where it is appropriate to do so.

## ANNEXURE ONE

City of Cockburn Submission to the Joint Standing Committee on the Corruption and Crime Commission,

The City of Cockburn thanks the Joint Standing Committee for the opportunity to make a submission regarding ways to modernise the *Corruption, Crime and Misconduct Act 2003*. We have structured this submission along the four key areas of particular interest that the Committee identified, with an additional section covering other comments we wish the Committee to consider.

1. The definition of misconduct, including what should constitute serious misconduct and minor misconduct.

Clarity remains an issue with regards to what constitutes serious misconduct and minor misconduct. This creates unnecessary confusion around reporting obligations, and which reporting agency (PSC or CCC) the City should be reporting suspected misconduct to. The City recommends that the Act be updated to create clearer definitions differentiating between serious and minor misconduct.

Where the CCC refers a matter to the City for investigation and response, the legislation should establish the appropriate process and the appropriate standard of evidence required for the conduct of the investigation.

Additionally, the City considers that s 4(c) of the Act should be expanded so that certain serious offences committed outside of the scope of a public officer's official capacity be captured as serious misconduct. The CCM Act is not currently clear as to whether certain alleged offences can constitute serious misconduct, regardless of whether the offences are alleged to occur in an official capacity. The City suggests creating a standard where a certain seriousness of offending is deemed to impact the proper conduct of a public officers' duties, even though it is alleged to have not occurred in the public officer's performance of their duties.

2. Who should be included in the definition of public officer

The City supports expanding the definition of public officer to include private contractors to the extent that they are involved in or performing the work of a public official. This should include:

- Labour hire employees
- Independent contractors
- Volunteers,
- Interns.

The definition should extend only to the performance of functions of the public officer, and not capture activities of the above people that do not constitute the functions of a public officer.

### 3. The impact of disclosure restrictions

The City supports allowing disclosure of restricted matters to registered health practitioners aside from exceptional circumstances. Serious misconduct matters can and do have serious impacts on the mental health of participants including complainants, the accused, investigators, principal officers and witnesses. There should be no harm from the disclosure of these matters to health practitioners who are bound by their own confidentiality obligations.

Also, the City supports the disclosure of restricted matters to close relatives and close support people in certain circumstances where this would not impact the integrity of the investigation. The City also supports allowing disclosure to organisations that provide advice and support, similar to that provided by a legal practitioner including:

- Union representatives or industry body representatives for the purpose of receiving support or advice; and
- Insurer or any contractor of the insurer for the purpose of or in connection with a claim for worker's compensation or under a management liability policy..

### 4. Measures for ensuring robust investigation of allegations when the Corruption and Crime Commission refers matters back to government agencies and the WA Police Force.

The Corruption and Crime Commission is likely aware that local communities are often aware of the subject matter of investigations. Often, serious misconduct can create a rift in the fabric of a local community. Providing feedback to the local community on the outcome of investigations can go some way to repair those rifts.

In local government, investigations will regularly result in a referral of the matter to WA Police, or another government agency such as the Department of Local Government, Industry Regulation and Safety or the WA Electoral Commission. These agencies have discretion as to how and if they investigate and take any action against a public officer alleged to have engaged in serious misconduct. Local governments are not regularly informed of the outcome of such investigations and may not be able to disclose outcomes to the community. It would be useful for the Corruption and Crime Commission to have an oversight role in the investigation and prosecution of offences that constitute misconduct by these external agencies. This would ensure that these agencies are properly exercising their prosecutorial powers where serious misconduct is involved.

## 5. Additional comments

The City recommends and endorses standard legislative modernisation efforts, for example updating gendered language such as 'his' or 'her' to gender neutral language.

The City supports introducing specific timelines around reporting matters to the Corruption and Crime Commission. The review of Western Power's investigation into serious misconduct by the Corruption and Crime Commission acknowledged the requirement for notifying authorities to notify the Commission in a timely fashion.<sup>1</sup> For the sake of clarity in outlining these obligations, the City would recommend statutory timelines for both notifying the Commission of an investigation ('as soon as practicable' or within 3 business days) and for reporting of findings once an investigation has concluded (within 3 months).

Finally, the City invites the Committee to provide clarity around the meaning of 'reasonable suspicion' within the Act. Certain sections of the act such as s 28 and s 45H introduces a reporting obligation on the City in respect of matters which are 'suspected on reasonable grounds' to involve misconduct.

The City takes 'suspects on reasonable grounds' as containing two elements:

- the alleged conduct, if proved would constitute serious misconduct; and
- there is evidence sufficient to create reasonable grounds for a suspicion that the conduct occurred.

It would be preferable for the legislation to codify the standard for 'suspects on reasonable grounds' so that this is clearly understood and applied

## **Background**

The City of Cockburn is seeking suitably qualified and experienced Contractor/s to conduct arboricultural works within parks, streetscapes and bushland reserves.

The tender is divided into the following three (3) separate zones. Tenderers may apply for one, part or all of the following services:

### **Zone A – West**

This zone will consist of all arboricultural works within the western division of suburbs with the exclusion of Bushland Reserves.

### **Zone B – East**

This zone will consist of all arboricultural works within the eastern division of suburbs with the exclusion of Bushland Reserves

### **Zone C – Bushland Citywide**

This zone will consist of all arboricultural works within Bushland Reserves Citywide.

The Scope of Works throughout each Zone may include, but is not limited to:

- Pruning of trees
- Removal of trees
- Grinding of tree stumps including removal of grindings.
- Tree root chasing.
- Chipping of tree pruning material and delivery to the Principals Operations Centre 52 Wellard Street, Bibra Lake, the City's materials storage yard at 11 Howson Way, Bibra Lake, or as otherwise instructed by the Principals representative
- Tree root investigation and barrier installation
- Emergency Arboricultural works such as afterhours storm clean up works.
- Powerline clearance pruning
- Polyphagous Shot-hole Borer (PSHB) or other biosecurity related arboricultural works
- Programmed arboricultural works.



The Contractor under the proposed Contract/s, will be required to provide all labour, plant, tools and equipment, materials, transportation/cartage, administrative costs, travelling expenses etc. and anything else necessary for the completion of the works/services.

The proposed Contract/s shall be in place for a period of three (3) years from the date of award; with Principal instigated options to extend the period for one (1) subsequent year and up to an additional twelve (12) months after that, to a maximum of five (5) years.

The expectation is for the Contract/s to commence in February 2026.

*Evaluation Criteria Assessment*Demonstrated Experience

The evaluation panel identified two clear leaders in this criterion Beaver Tree Services and Tree Care WA. Both submissions demonstrated extensive experience delivering arboricultural services for local governments, supported by detailed examples and strong added value initiatives.

Beaver Tree Services was the highest scoring submission showcased long-standing contracts with Armadale, Rockingham, and Kwinana, while Tree Care WA was the second-highest scoring provided highly relevant projects including being the current incumbent for arboricultural works in City of Cockburn and conducting Polyphagous Shot-hole Borer (PSHB) related works for Department of Primary Industries and Regional Development (DPIRD).

The panel is confident that both Tree Care WA and Beaver Tree Services have suitable experience that would apply to all three Zones (A, B and C).

ARBFIRM presented adequate experience but with limited detail on project scope and staffing qualifications. Chalmers Tree Services showed some relevant experience but primarily through subcontracting roles and lacked depth in methodology.



Classic Tree Services scored the lowest in this criterion despite having significant operational experience, due to poor compliance with instructions and insufficient detail in their examples.

### Tenderer's Resources

All respondents were identified as having sufficient resources to meet minimum requirements for at least a single zone award with moderate confidence.

Tree Care WA was the highest scoring in this criterion demonstrating strong capacity with qualified staff, contingency measures, and a comprehensive plant and equipment fleet. Beaver Tree Services were the second-highest scoring also demonstrating significant resources and equipment availability.

The panel was confident that Tree Care WA and Beaver Tree Services demonstrated sufficient resources and contingency measures suitable for contract requirements in all three Zones (A, B and C).

The remaining respondents had smaller resource availability or unclear allocation of resources for this contract, and this was reflected in lower scoring for this criterion.

### Methodology

Beaver Tree Services and Tree Care WA provided the strongest methodologies, with clear approaches to scheduling, traffic management, quality control, emergency response and record management.

Beaver Tree Services was the highest scoring respondent followed closely by Tree Care WA as the second-highest scoring respondent.

ARBFIRM and Chalmers Tree Services offered adequate but less detailed responses, while Classic Tree Services scored lowest due to missing timeline details and unclear methodology.

### Sustainability

Tree Care WA and Beaver Tree Services provided the strongest responses. Both demonstrated ISO 14001 accredited Environmental Management Systems and detailed operational initiatives.

Tree Care WA was the highest scoring in this criterion with Beaver Tree Services scoring slightly lower.

ARBFIRM and Chalmers Tree Services scored lower for this criterion offering adequate sustainability measures and commitment. Classic Tree Services scored lowest overall due to minimal detail and poor compliance with instructions.

### Local

Chalmers Tree Services scored highest in this criterion, demonstrating local engagement through its Baldvis base and staff located across the South West Group region.



Tree Care WA was the second highest scoring, with an Oldbury location, a substantial proportion of staff based in the SW metropolitan area, and use of local suppliers.

The remaining respondents scored lower for this criterion as they demonstrated limited local and regional benefit.

### Summation

The evaluation panel recommends that Council accept the following submissions for RFT37/2025 - Arboricultural Services (City Wide), as being the most advantageous for the City.

- **Zone A (West): Tree Care WA** for the specific scope, having satisfied all criteria in the evaluation process and demonstrated ability to undertake the specific services of arboricultural works within the western division of suburbs with the exclusion of Bushland Reserves. and as indicated by the procurement cost model. The submission by Tree Care WA ranked one for both the qualitative and cost criteria achieving the best overall assessment.
- **Zone B (East): Beaver Tree Services** for the specific scope, maintenance having satisfied all criteria in the evaluation process and demonstrated ability to undertake all-arboricultural works within the eastern division of suburbs with the exclusion of Bushland Reserves and as indicated by the procurement cost model. The submission by Beaver Tree Services ranked second for qualitative criteria and third for cost criteria achieving the third-best overall assessment. While Tree Care WA was the highest scoring for qualitative and cost criteria, the panel recommends the award of the eastern portion of the City to a second contractor to mitigate the risk associated with a sole incumbent delivering arboriculture works across the City. While Chalmers Tree Services was the second-ranked for overall assessment for Zone B the evaluation panel highlighted concerns over limitations in previous experience, staff and resources necessary to deliver the volume of works required in Zone B. For this reason, the panel recommends Beaver Tree Services being the second-highest scoring submission for qualitative criteria with high confidence in the tenderers ability to fulfill contract requirements for Zone B.
- **Zone C (Bushland Citywide): Tree Care WA** for the specific scope – having satisfied all criteria in the evaluation process and demonstrated ability to undertake all arboricultural works within Bushland Reserves Citywide and as indicated by the procurement cost model.

Referee checks have been completed for both Tree Care WA and Beaver Tree Services, with positive feedback received. Additionally, both tenderers have successfully passed an independent Financial Risk Assessment.



The recommendation is based on:

- Demonstrated experience in performing similar works for other local governments with both being a previous or current incumbent to City of Cockburn
- Having two large-scale arboriculture organisations engaged across Cockburn is advantageous for workload contingency.
- A range of personnel and resources that have the experience and capacity in managing the services associated with the requirements of the contracts.
- Clear understanding of the methodology, procedures, record keeping and WH&S requirements to undertake the services.
- The required plant and machinery and contingency measures to undertake the specific scopes to achieve the required outcomes; and
- The best overall value for money to perform the works associated with the specific scopes.

### **Budget/Financial Implications**

The estimated contract sum is \$5,850,000.00 (Ex GST) based on the three zones for a three (3) year term and will be funded from multiple sub activities (123, 166, 167, 174, 175 and 230) in Service Unit 511.

As this is a schedule of rates contract with no minimum expenditure commitment, the City will only be able to deliver services within the limits of the budget approved by Council.

To meet customer and technical (Arboricultural) levels of services modelled within the Contract, a budget amendment and increase to future annual budgets will be required.

These adjustments will be progressed through the standard budget process and reflected in the next update of the Long-Term Financial Plan.



The approved FY26 annual budget for Arboricultural Services is \$1,159,157.52 (Ex GST) with additional funds (~\$800,000) sourced through adjustments to other operational budgets (OP 6368, 6370, 6377, 6378, 6379, 0037 and Sub Activity 161) in response to the increased volume customer requests and traffic management compliance.
