#### 2. PUBLIC ADDRESS SESSION

**Mr Dan Cunningham** from Advanteering Civil Engineers spoke with regard to the facsimile sent to Councillors and staff on the tender for the Coogee Beach Jetty. He outlined the team of people the Company had and the expertise that they would bring with them, should Advanteering Civil Engineers be awarded the tender. He said his was

the lowest tender based on the contract document. He acknowledged the importance of the project, even though the cost did not run into millions of dollars. He stated that he did not want to underestimate the task at hand. In his opinion, he believes his organisation has the expertise and manpower to carry out the project.

He stated that in his letter faxed to Councillors and staff it was mentioned that they submitted the tender based on the contract document. Since then, there has been a question mark as to what they had priced. He also stated that he has read the report to Council both at this meeting and the last meeting and what was being told to Council was not quite accurate. Those variations that were stated in the Agenda as being priced by both the lowest tenderers, were not. Finally, he requested Council to give consideration to the matter and award this project to Advanteering Civil Engineers

Mayor Grljusich responded that the matter would be considered when the item is discussed.

#### 5. (SCM1/99) - TENDER NO. 46/98 - CONSTRUCTION OF COOGEE BEACH JETTY (1903) (JR) (COASTAL) (ATTACH)

#### RECOMMENDATION

That Council resolve to accept the tender from John Holland Construction & Engineering Pty Ltd for Tender No. 46/98 - Construction of Coogee Beach Jetty, in the sum of \$697,736, being the tender sum of \$801,872 less \$104,136 for the following variations to the tender specifications:

 Replacement of secondary beams and bolting system for the main jetty deck with fastening of deck planks using coach screws through the centre beam and kerbing at the edges bolted at 0.5m centres to hold down the whole decking;

- Replacement of all stainless steel fastenings with galvanised fastenings, except for the stainless steel ladders;
- Replacement of timber and stainless steel handrails with standard Monowills galvanised steel railings and posts.

  - (i) replacement of secondary beams and bolting system for the main jetty deck with fastening of deck planks using coach screws through the centre beam and kerbing at the edges bolted at 0.5m centres to hold down the whole decking;
  - (ii) replacement of all stainless steel fastenings with galvanised fastenings, except for the stainless steel ladders;
  - (iii) replacement of timber and stainless steel handrails with standard Monowills galvanised steel railings and posts.
