## Background

Council, at its meeting of 19 November 2002, resolved to provide the sum of \$420,000 in its 2003/04 Municipal Budget as a contribution towards the construction of the Atwell South Community Centre, with the funds to be drawn from the Community Facilities Reserve Fund.

An adjustment was made to the 2003/04 Municipal Budget in response to advice received on the outcome of the grant applications to the Lotteries Commission and the Department of Sport and Recreation. The result was that an adjusted anticipated total project cost of \$1,316,955 which would be funded as follows:-

#### Report

The Harvest Lakes (Atwell South) Community Centre design has been developed utilising environmentally sustainable development principles. There is external use of passive energy design principles and the utilisation of low embedded energy and recyclable building materials. The Centre design is similar to that of the adjoining primary school with a number of architectural techniques to differentiate the centre from the adjoining school.

The opportunity has been taken to jointly share an oval with the primary school.

Development of the joint use oval has been substantially paid for by Landcorp which has resulted in capital savings to the City. The opportunity to cost share with the Education Department for the ongoing maintenance of the oval, has also been achieved.



The building contract for the South Atwell Primary School incorporated a provisional sum for the construction of the Community Centre, in accordance with Local Government (Functions and General) Regulations 1996 section 11(2)(e). As indicated in the advice previously provided, the opportunity for Council to attain savings in the building contract was created by an economy of scale due to its being part of a larger building contract for the school. The school and the Community Centre both incorporate environmentally sustainable design principles which are not currently common in the building industry and hence, more expensive than traditional construction methods. The incorporation of the community centre in South Atwell Primary School Development would also be expected to provide savings to the City.

Included in the consultancy team for the project Architects Taglar Robertson B & N, are Quantity Surveyors Ralph Beattie Bosworth Pty Ltd, who have meticulously scrutinised the tender for the Community Centre presented by Esslemont Geo A & Son. Whilst substantial savings have been identified, the final negotiated tender price is above that originally estimated. The advice for this overrun is due in part to the unique building design as described above and an escalation in costs due to the building industry boom.

The revised budget for the Harvest Lakes Community Centre and Reserve are as follows :-

It ought to be noted that the Council contribution to the total project will be 27% of the cost, whereas Landcorp's contribution is 42% of the total cost.

For the project to proceed as envisaged, the Council contribution will be required to increase from the budgeted \$337,984 to \$436,086 (a further \$98,102 rounded to \$100,000).
