1.0 General information

This document has been designed to provide simple guidelines to assist and improve signage and branding within the locality of City of Cockburn and within its buildings and facilities.

This signage style guide contains information on the proper and consistent application of signage within City of Cockburn. The guidelines are to be used by City of Cockburn officers and signage contractors for all City of Cockburn signage. All visual design work for the City of Cockburn must comply with the relevant sections of the “accessible information” section of the State (Western Australian) Government “Access Guidelines for Information Services and Facilities (a guide to assist government, business and community groups to create Western Australia as an accessible and inclusive community)”, the “Accessible Information: Policy and Guidelines for Local Government” and the Association for the Blind of WA (Inc) “General Guidelines for Accessible Print”.

These guidelines must be used in conjunction with the following **City of Cockburn policy and procedure documents**:

- 1. City of Cockburn Corporate Style Guide
- 2. City of Cockburn Writing Style Guide.

Codes and Standards

All work and materials shall, except where otherwise noted on the drawings or directed in the specifications, comply with the latest editions of all relevant Australian codes or Australian Standards (AS).

See section 9.0 Symbols for information on using Australian Standard symbols in City of Cockburn signage.

1.2 The logo

The logo is a specially designed mark and must not be typeset, traced, respaced, redrawn or modified in any form by either manual or electronic methods.

The proportions, spacing, relative positioning and colour of the logo must remain consistent.

The logo must never be used in any other relationship other than the one in these guidelines. The logo can appear with and without the tagline. As a general rule though the logo with the tagline is used. Applications where the tagline is not used are noted throughout this document.

Note: Generally in signage applications the city of Cockburn logo with ‘Wetlands to waves’ tagline should be used at all times. Only in instances when the logo is reduced to a very small size should the tagline be dropped. Please refer to City of Cockburn corporate styleguide for minimum size application.

Usage

Use the Primary Logo (no tagline) when correct reproduction of the tagline text is impeded e.g the logo is reproduced at small size and may not be easily read



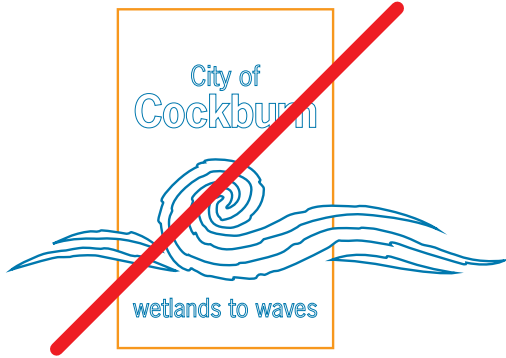

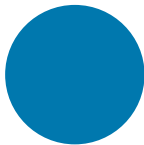

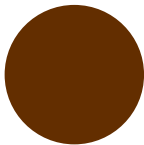

1.5 Typefaces

For legibility and clarity, **News Gothic Com (from the News Gothic)** is the recommended typeface to be used on all signage.

All type should be left aligned, unless indicated for specific signage within this document. Never use a justified setting for type.

Wherever possible, News Gothic Com Roman should be used for headline text and appear prominently.

Upper and lower case type should be used at all times for signs.

Stencil typeface

For information and directional footpath signage use Allerta Stencil. A Copy of the typeface is available from Corporate Communications, Graphic Design.

Headings/titles

For all headings and titles of City of Cockburn signage **News Gothic Com Medium** must be used.

Deciding text size

Although all of the text sizes are set in this style guide, they should be scaled to suit the application. Use your discretion when sizing type.

The minimum size that the fonts should be is 12pt. This size is only to be used in select instances when there is a larger amount of information displayed within a smaller area such as details on interpretive maps.

Line spacing

For optimum legibility, we advise that ample line spacing/leading be created between each line of text.

For all text with a size of 200pt must have space with 200pt leading.

For all body copy a normal x-height is required.

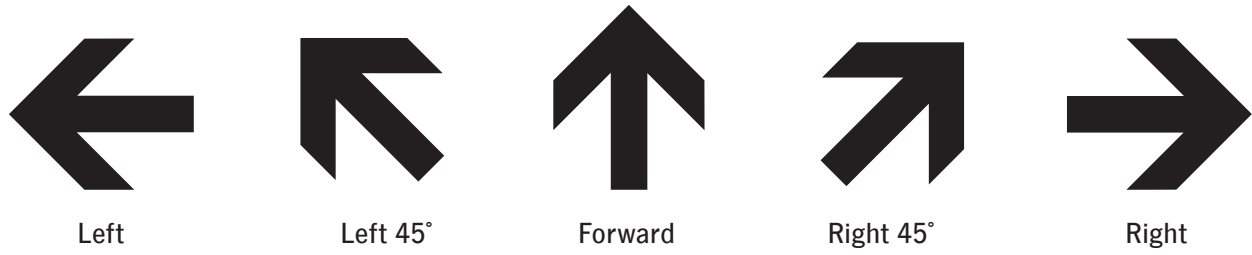
Tracking/letter spacing

For optimum legibility, it is advised that tracking/letter spacing is set to “optical, not “metrics”.

1.6 Directional arrows

Pedestrians will never be directed to facilities which are situated behind them due to misinterpretation and confusing. The City of Cockburn signage will only use forwards, left, right and 45° angles arrows on their signage.

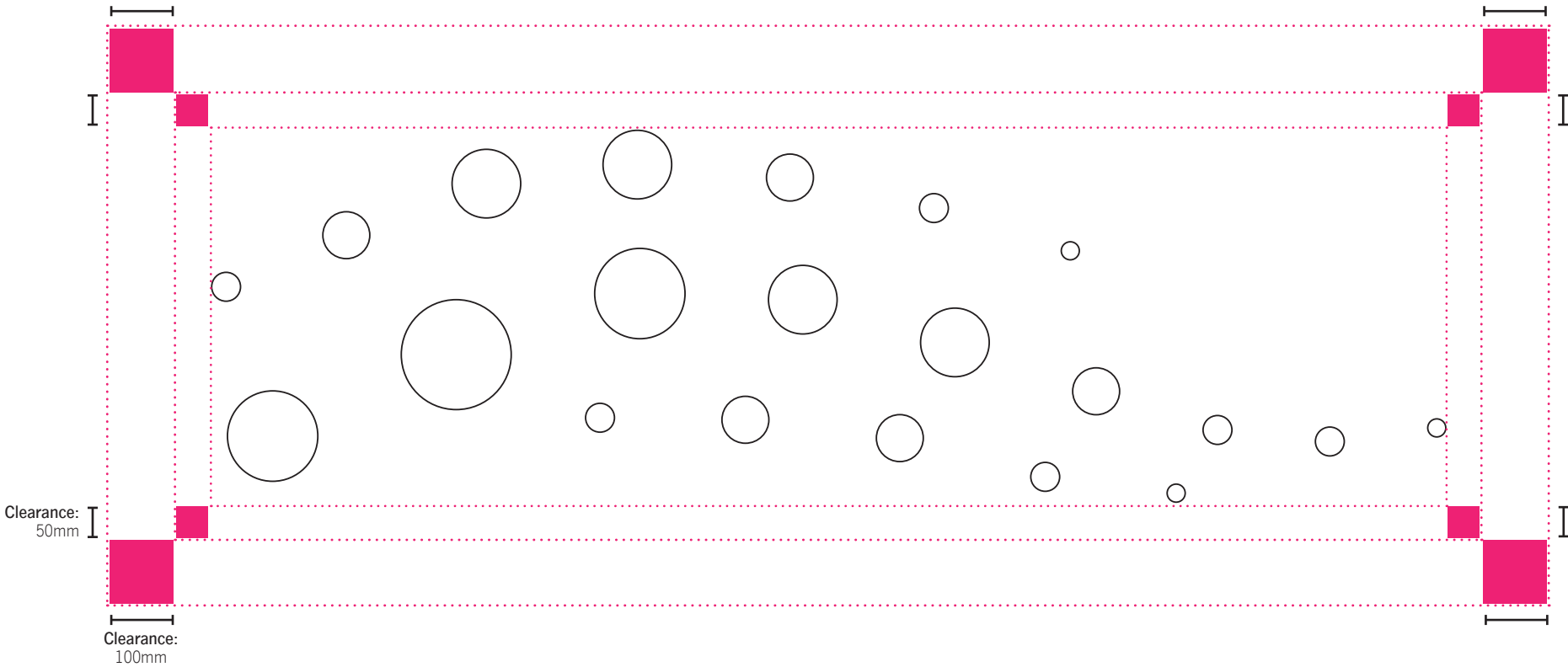
1.7 The wave - supporting graphic

The supporting graphic for the City of Cockburn signage is the wave, it will be laser cut or vinyl stickers onto all necessary signs.

The usage will depend on the type of sign used, on most flat panel signs the pattern will appear but on signage with curved surfaces you must follow the construction guidelines for that signage.

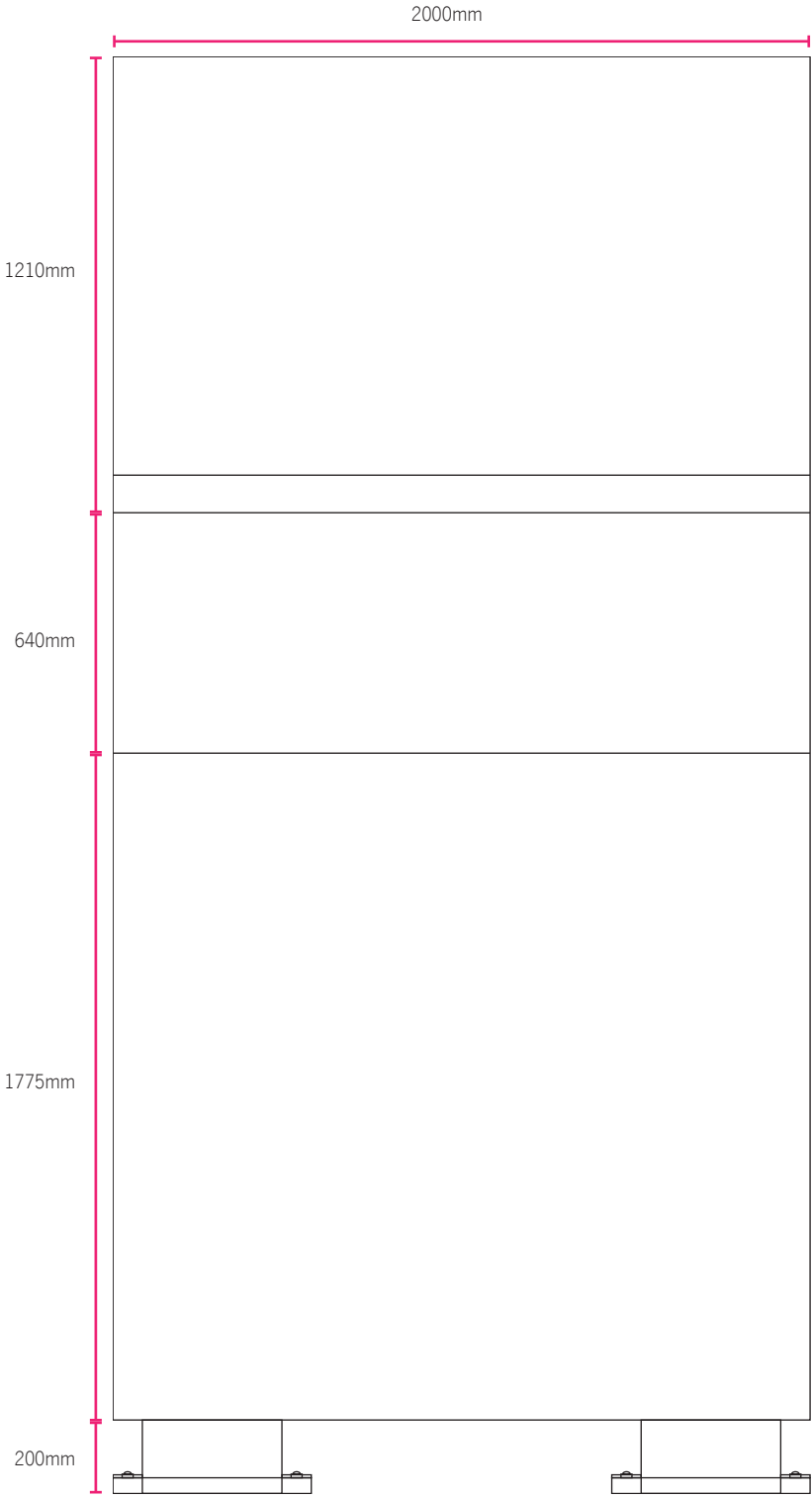
When the pattern is placed on signage it must have either a 50mm or 100mm clearance all round. This will be specified on the individual pages where the wave applies.

The wave can only be used for 5.0 Wayfinding signage, specifically for 5.3, 5.4 and 5.5 sign types.

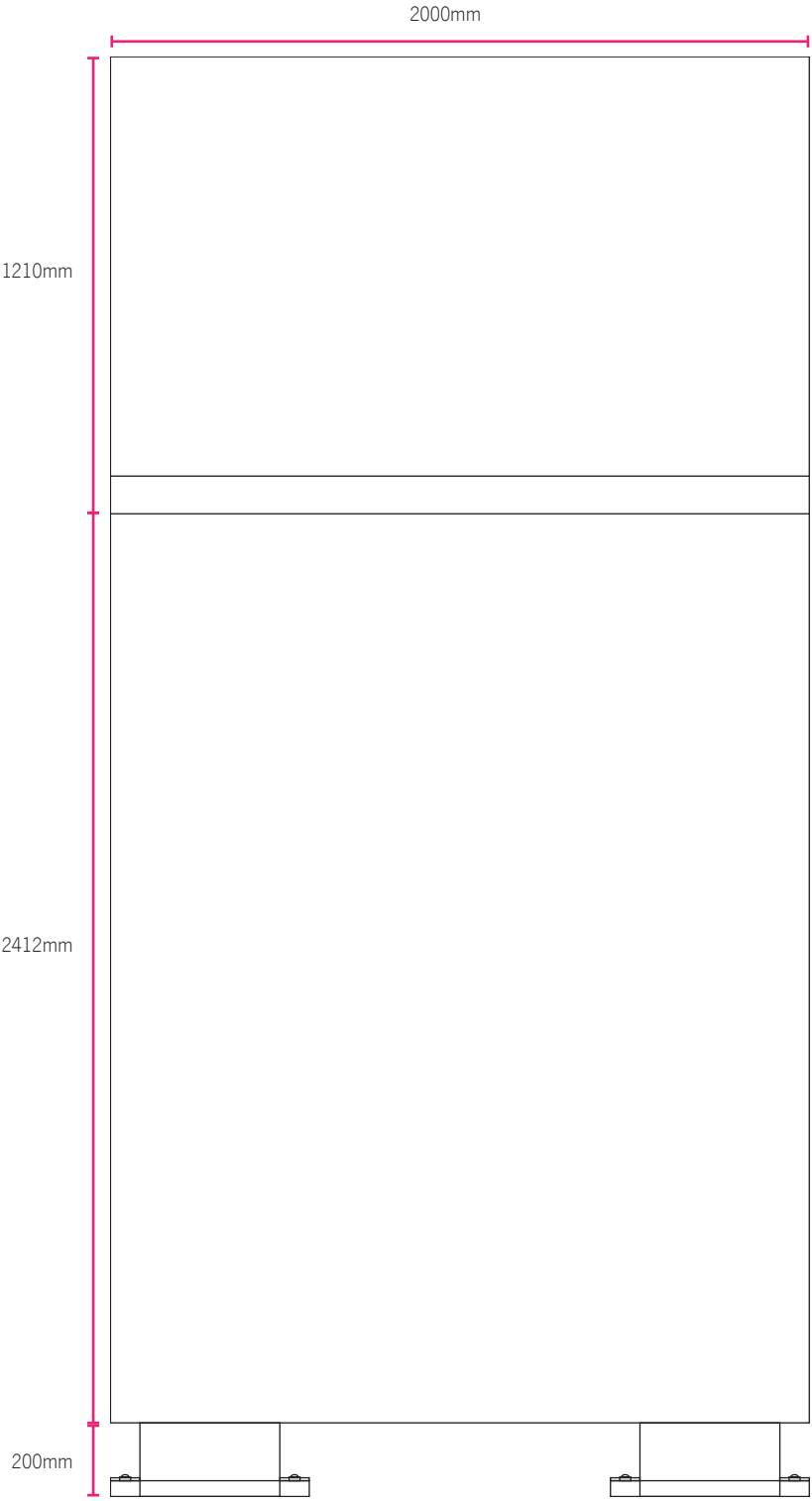

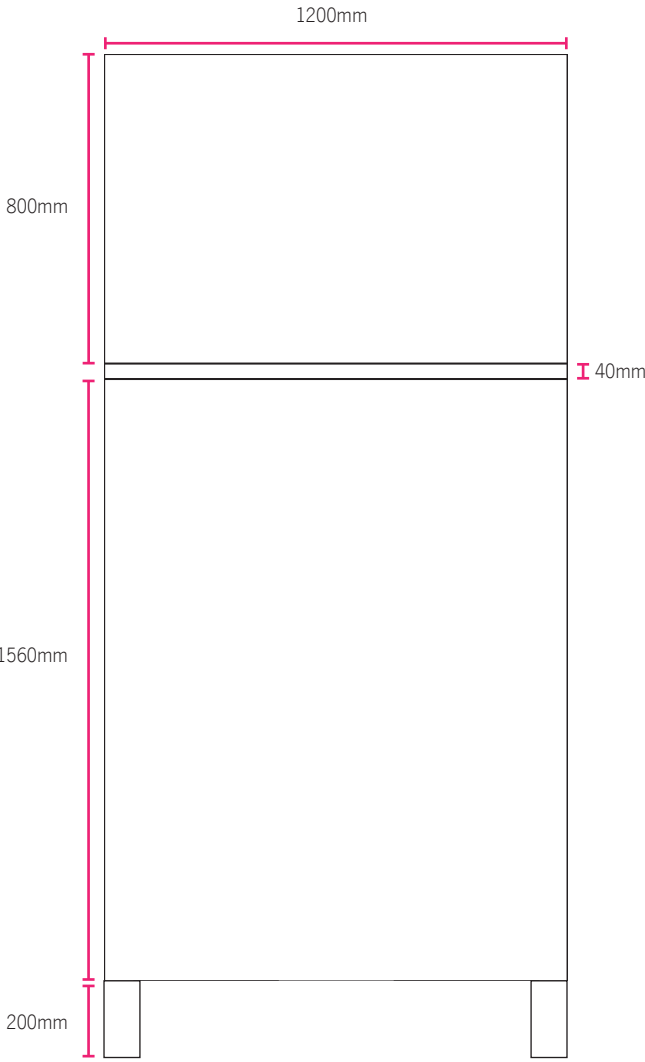
Structure for Entry/welcome signs

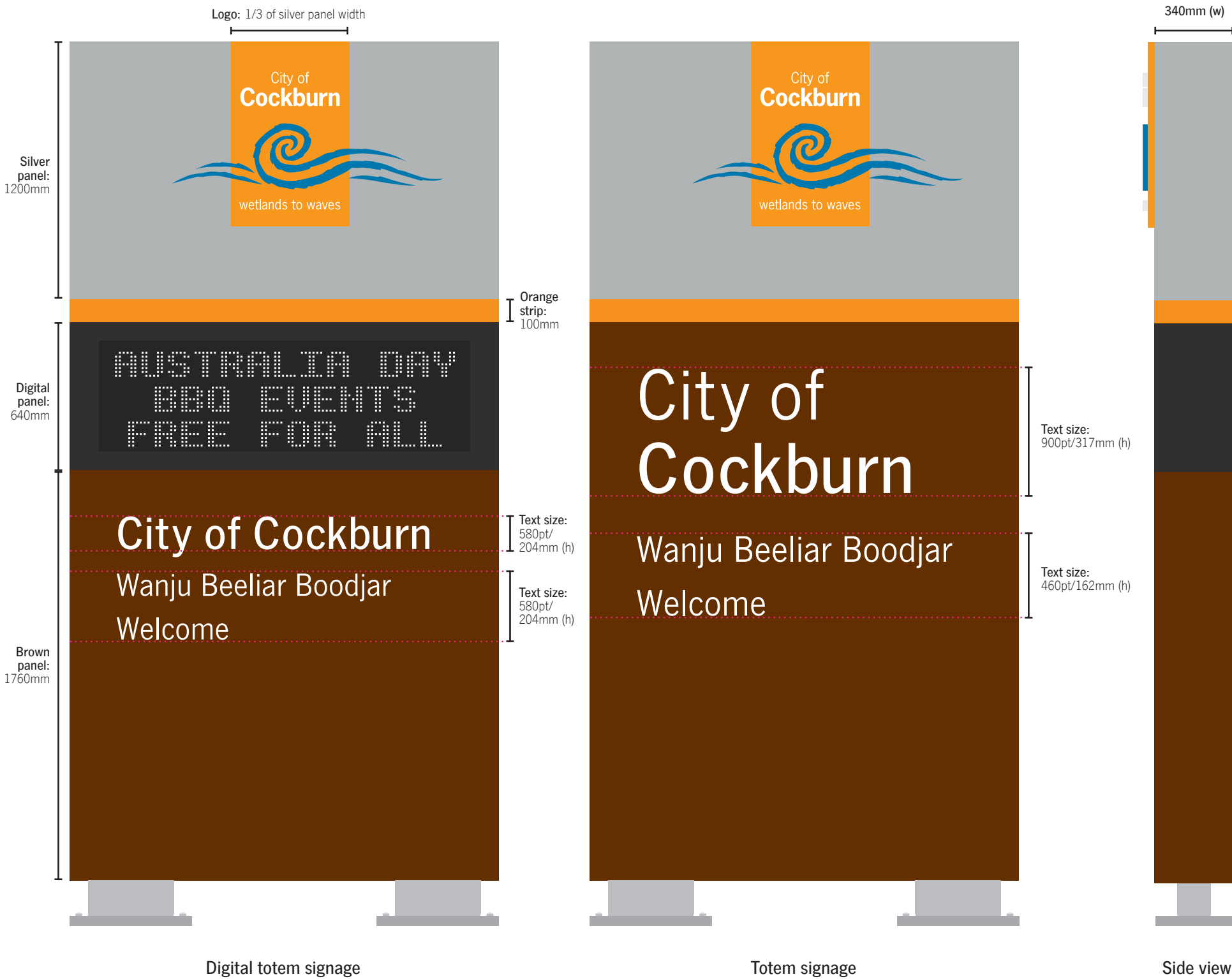

2.1 Totem entry signage

Totem entry signs are to be used at the City of Cockburn boundary on main/arterial roads. They will have a digital display screens on which you will be able to see messages about or from the City of Cockburn.

 - Positioning statement
 - Welcome message

2.2 Secondary entry signage

Secondary entry/welcome signs are to be used at the City of Cockburn secondary road boundaries. They will also be used at internal suburb boundaries. They can also be used at the entrance to larger facilities. These signs can be used in either single sided or double sided applications.

Each sign includes:

- City of Cockburn logo
- Welcome message (includes English and Nyungar)
- Address

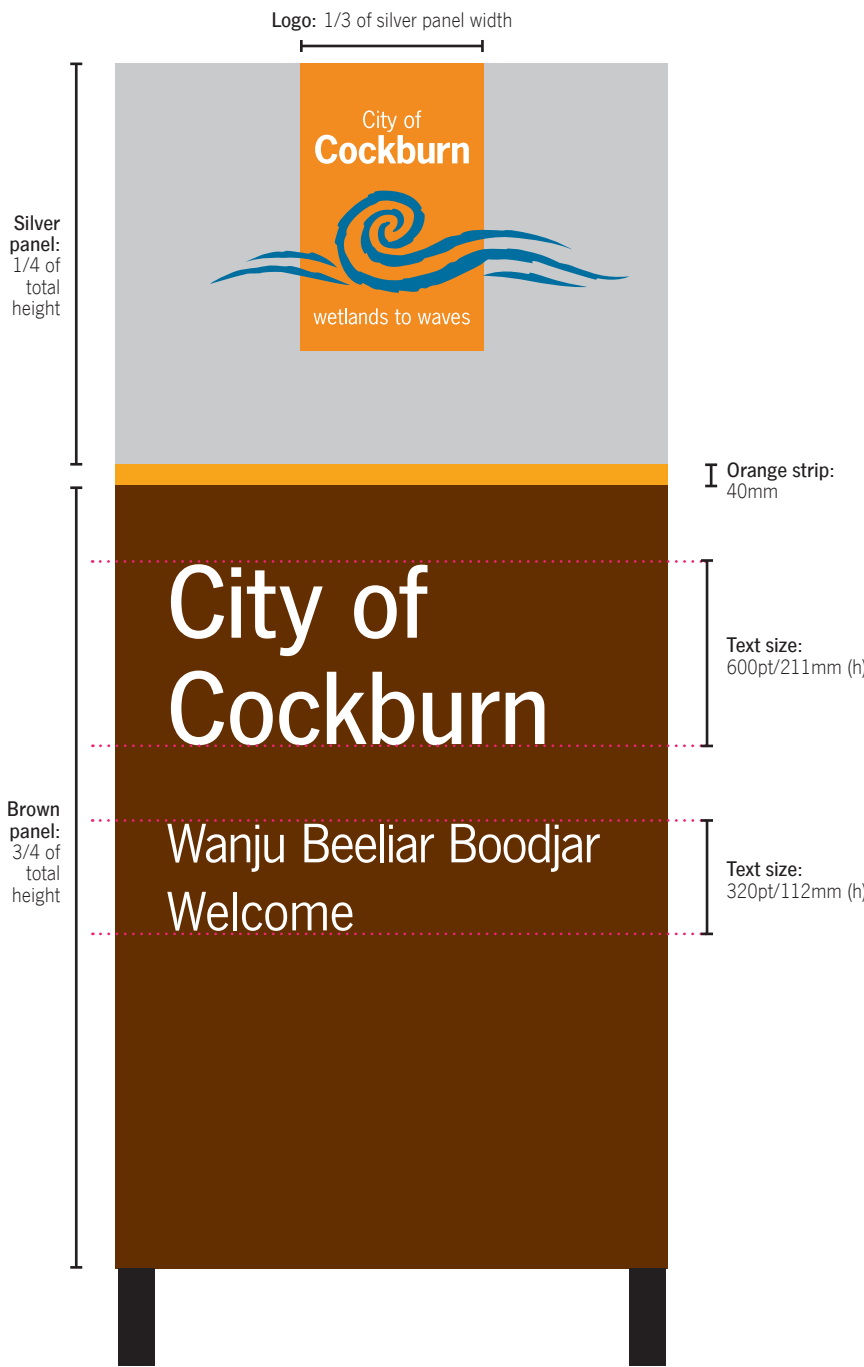

- Address

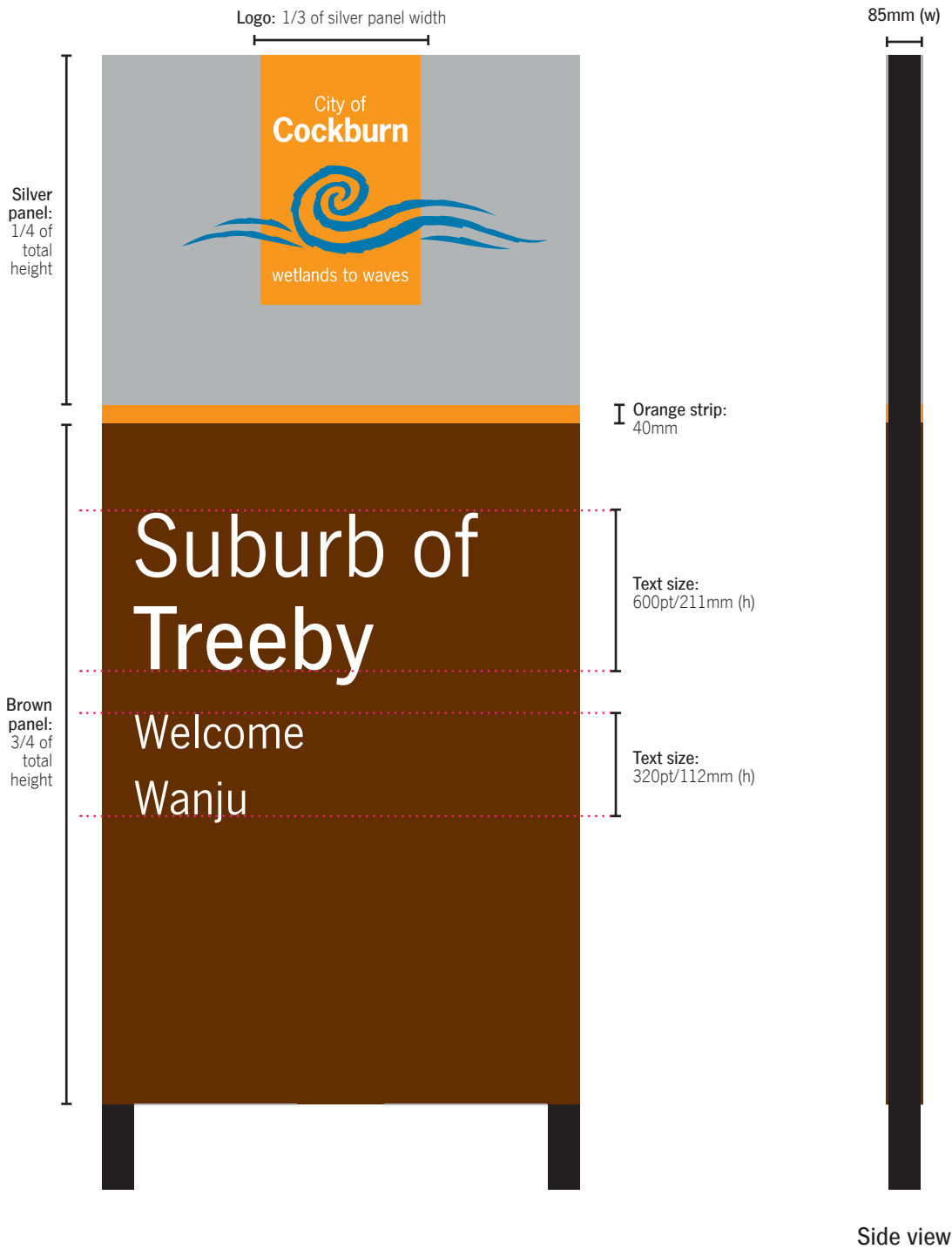

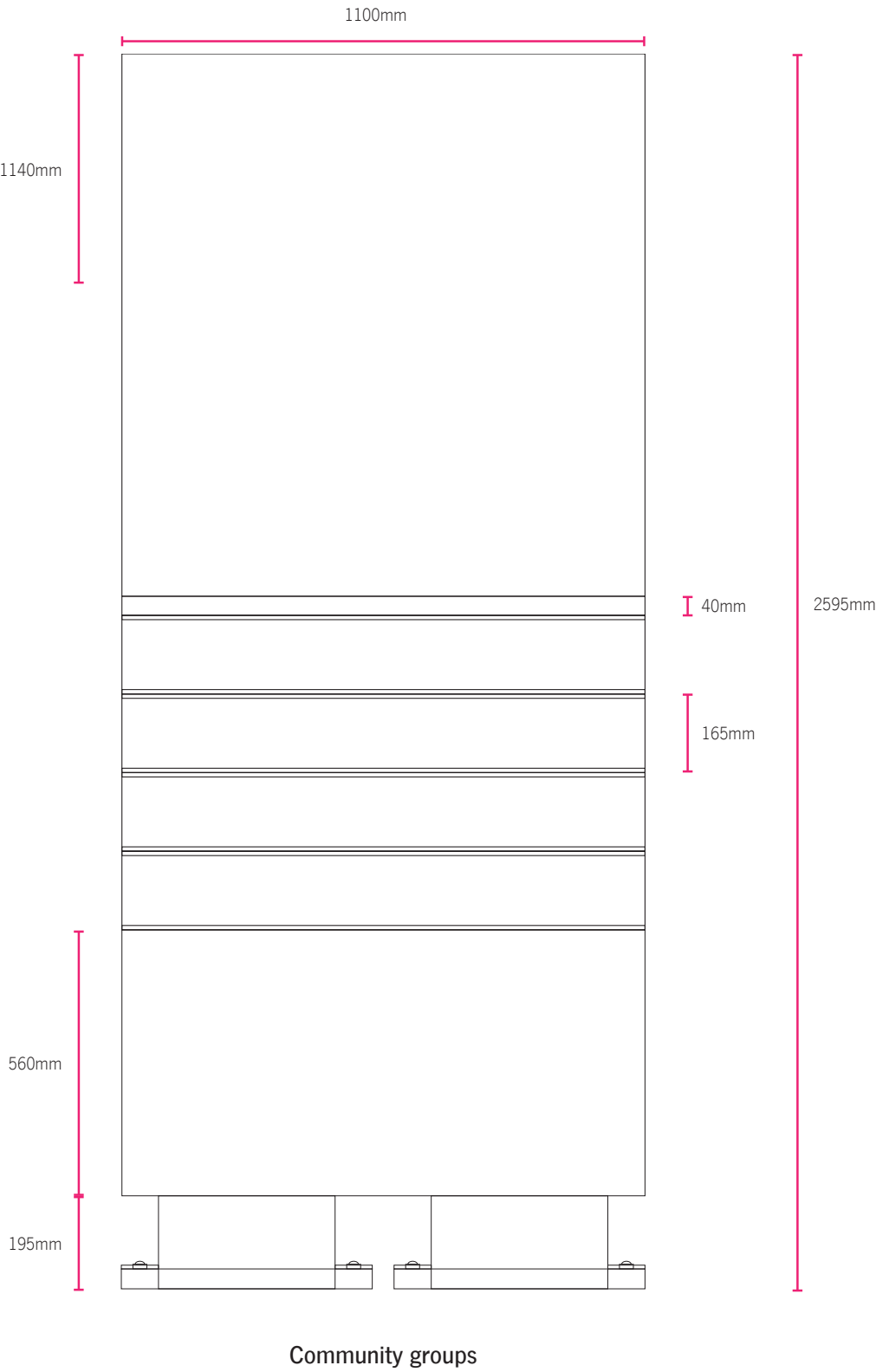

3.1 Sports facility signs with address and multiple clubs/businesses

Sports facility signs will be used at City of Cockburn sports facilities or groups. They will have messages or names of groups or sports clubs close to the surrounding area, and can be used in either single or double sided.

Each sign includes:

- City of Cockburn colour palette
- Sports club, facility or landmark name/message
- Address if it is at a major entry on a road (see 7.2)

4.0 Community groups



4.1 Cockburn community signs

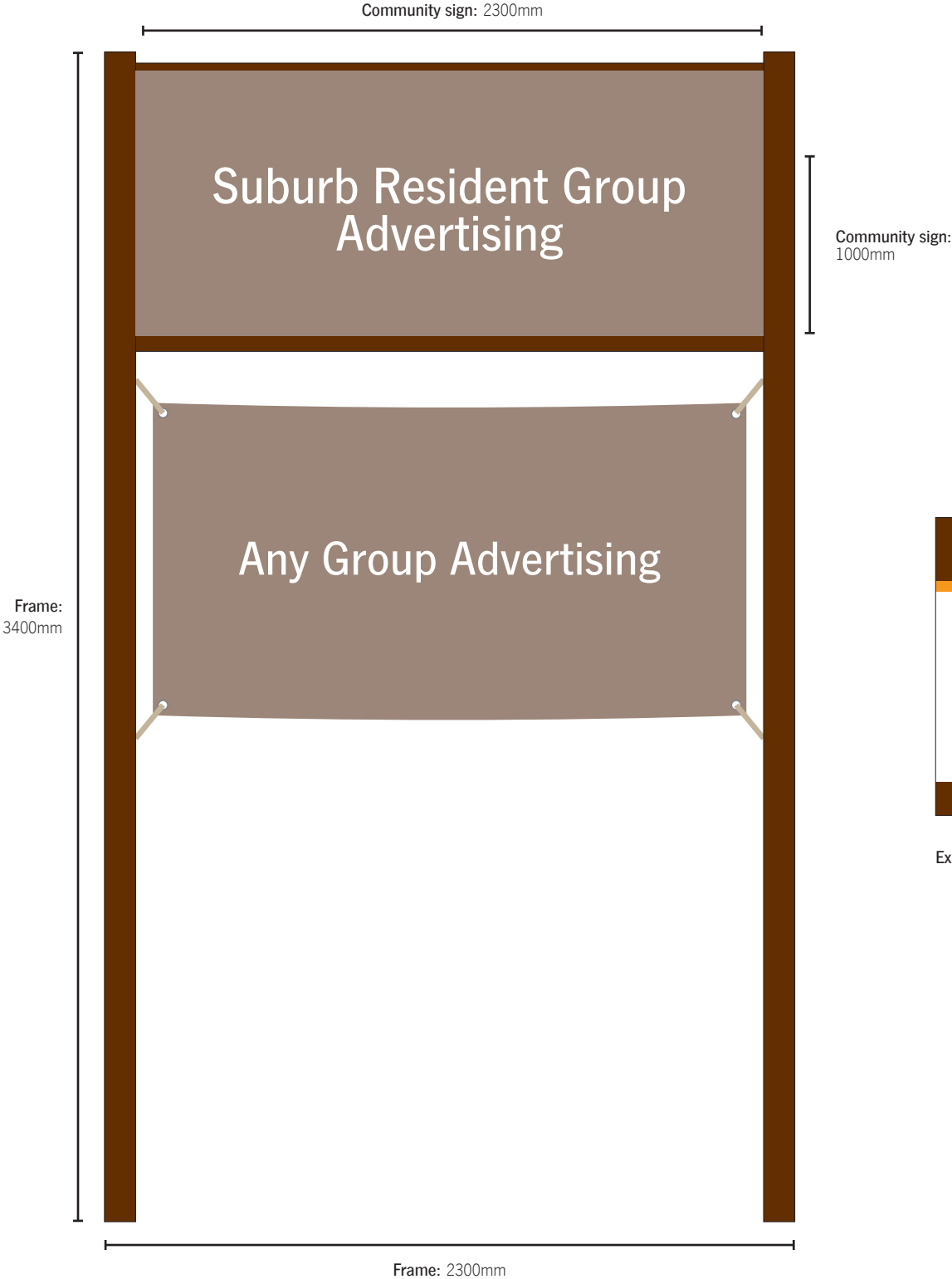
Cockburn community signs have been installed to promote non-commercial or non-political events and activities that benefit the community. The Community signs are the property of the City of Cockburn, but any or all of the 10 signs can be hired temporarily at no-cost by community groups, schools and registered charities - on approval from the City of Cockburn.

5.0 Wayfinding signs



The purpose of this section is to ensure that directional, service and tourist signage is effectively integrated into the urban landscape and the amenity of the locality is maintained and protected.

This procedure is a guide for City of Cockburn staff in assessing opportunities for signage rationalisation and internal and external requests for new signage.

Procedure

The City of Cockburn acknowledges the need to regulate signs on its road reserves, footpaths and public spaces to maintain the effectiveness of priority traffic control signs and directional signs and to ensure the amenity of the City of Cockburn is appropriate.

A reduction and limiting of the proliferation of road signs can preserve or enhance the aesthetic values of the landscape and environment. The use of Australian Standards and internationally recognised symbols on signs wherever possible can ensure simple, concise and consistent messages are conveyed to motorists and visitors.

Service and tourism directional fingerboard signs are to be in accordance with Australian Standard (AS) 1742.5 ‘Manual of uniform traffic control devices – Street name and Community facility name signs’.

Directional signs are signs erected in roads or public places to indicate the direction to places, services and tourist destinations within the City of Cockburn.

The purpose of tourism signs is to direct residents and visitors to services and attractions within City of Cockburn.

Directional signs not on a road name sign structure but proposed to stand alone will generally not be supported.

Refer to Engineering Services’ Community Facility Name Sign guidelines for approval requirements.

This policy has been developed to ensure that the installation of signs is undertaken in a regulated and uniform manner, consistent with the requirements of other relevant authorities, including Main Roads Western Australia (MRWA).

Objectives

Provide an environment in which efficient placement of signs enhances a street, road reserve or precinct by increasing the overall impact and effectiveness of individual signs.

Provide clear and logical directional signs through the use of standardised dimensions, symbols and consistent colour coding, compliant with Australian Standards.

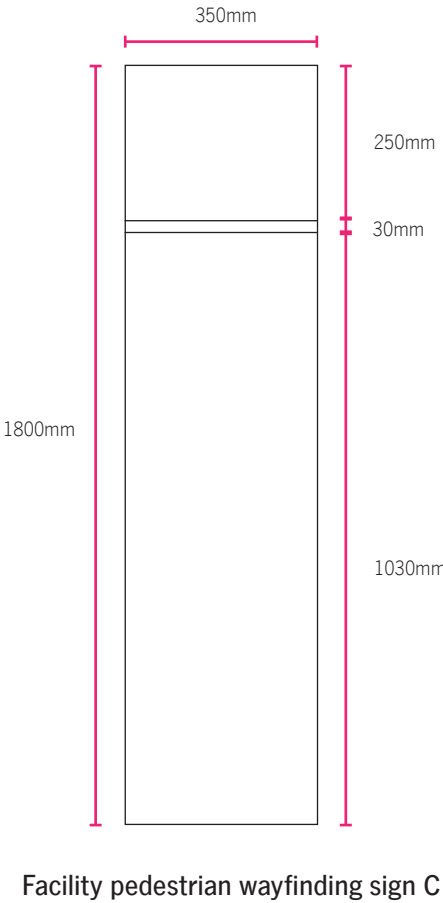
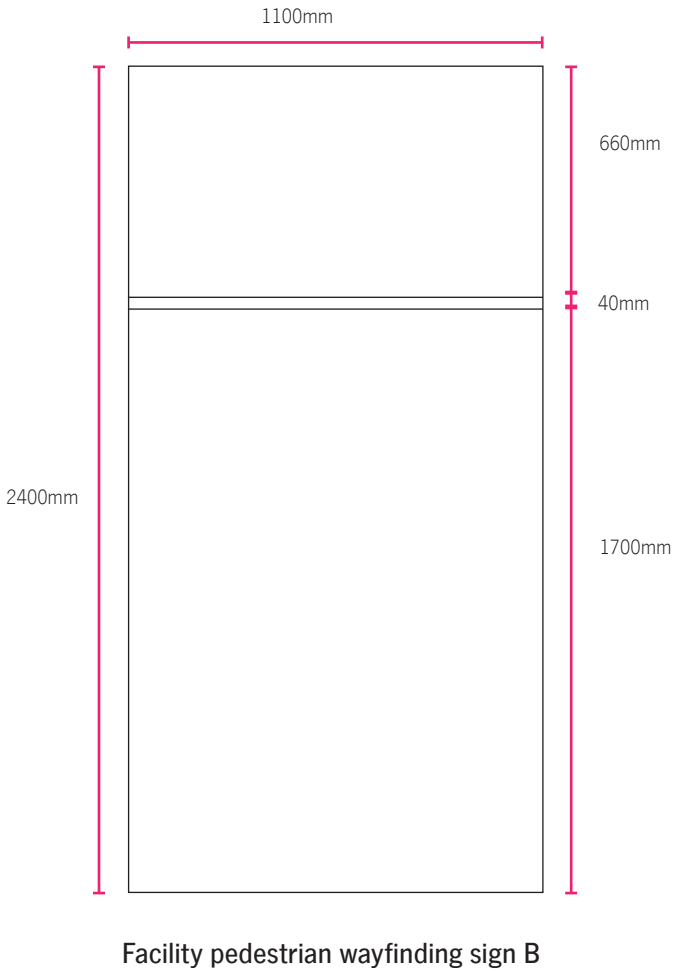
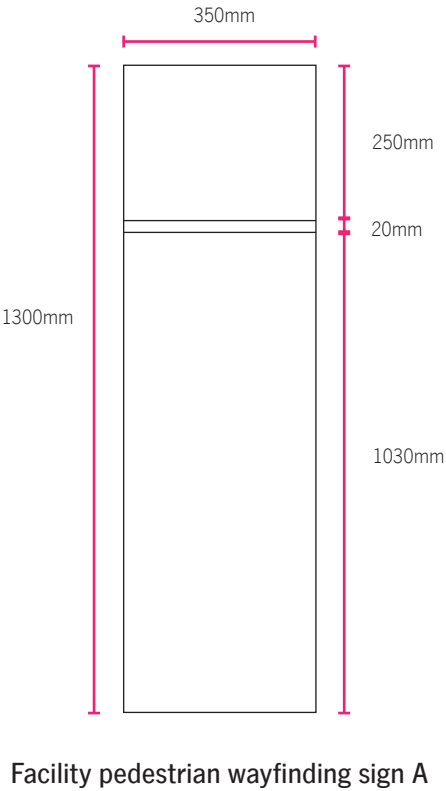
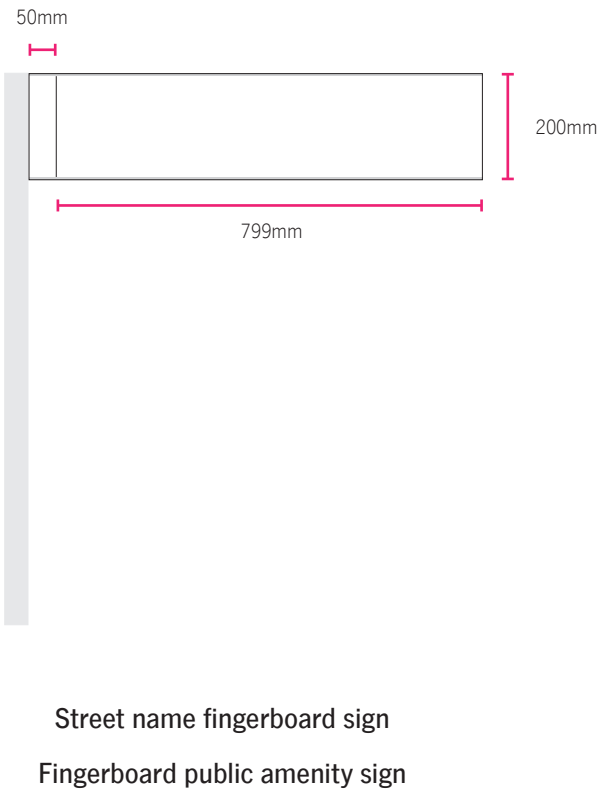
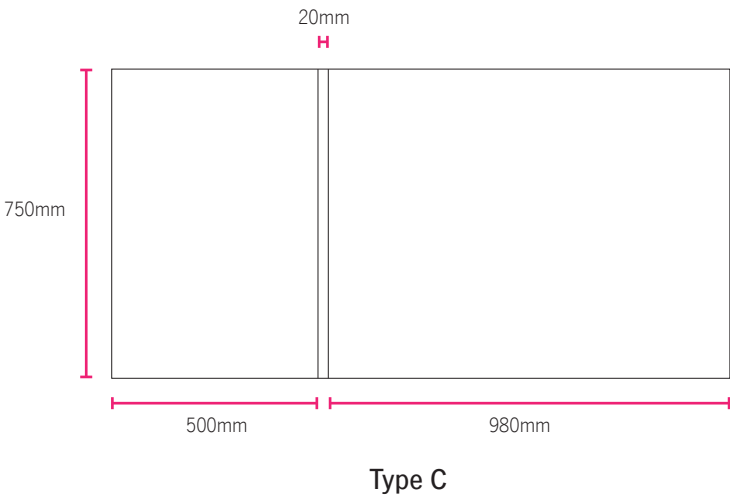
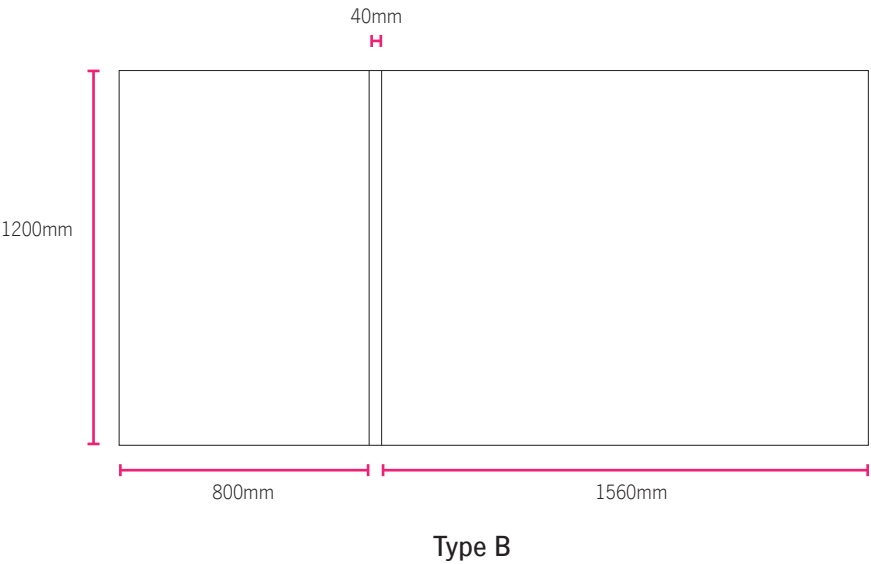
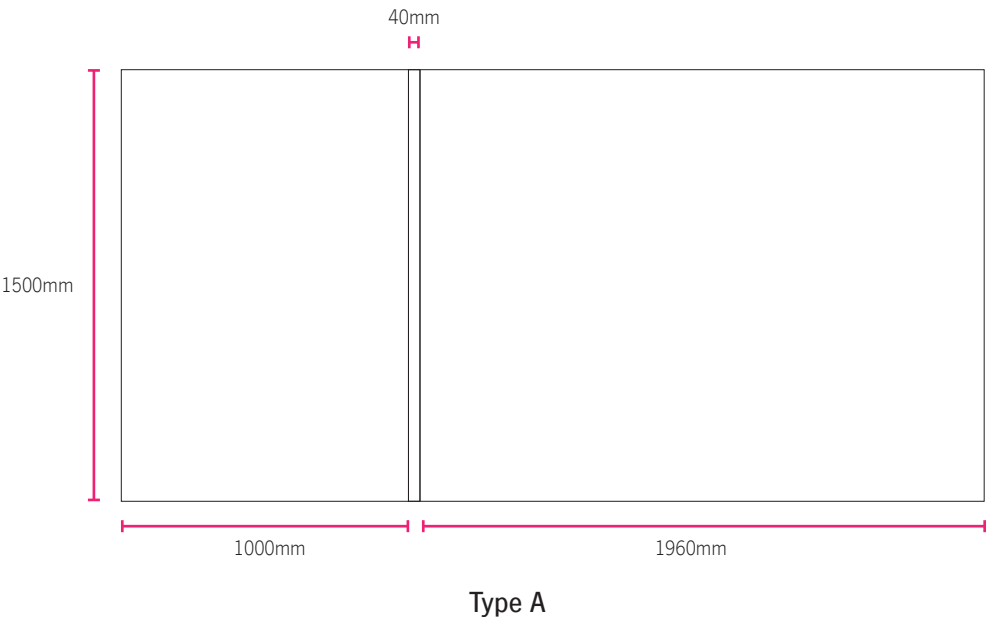
Ensure that directional signs throughout the City of Cockburn provide clear directions to community, service facilities and tourist destinations.

Provide traffic control signs that regulate, warn and guide traffic and facilitate safe, efficient and orderly travel.

Clearly identify those facilities that may qualify for directional signs and the conditions under which they may be permitted.

5.1 Fingerboard street name signs

Layout

- The following apply to fingerboard signs:
- Each individual sign is to incorporate the service and/or tourist feature/s, represented by a standard symbol where available, or standard text if necessary, and the directions to proceed.
 - The use of Australian Standard service and tourist symbols is limited to five symbols per sign.
 - In any one sign stack the maximum number of fingerboards is four, inclusive of the road name sign.
 - Tourist and service signs shall have upper case lettering only using the Australian Standard (AS) 1744 Series standard font.
 - For more information refer to Australian Standards.

Dimensions

Text: Refer to Australian Standard - Standard Alphabets for Road Signage AS 1744-1975 for details.

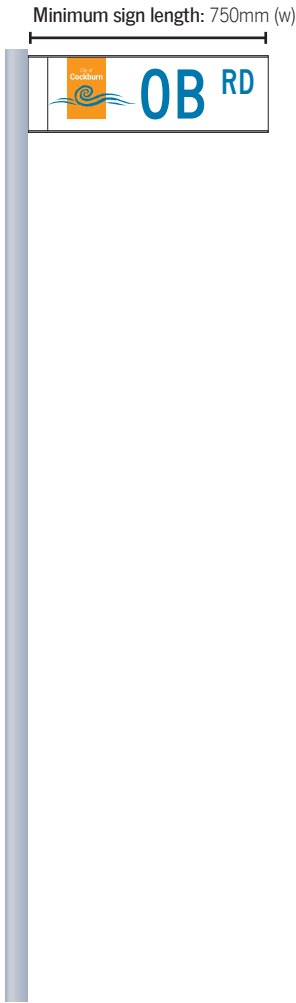
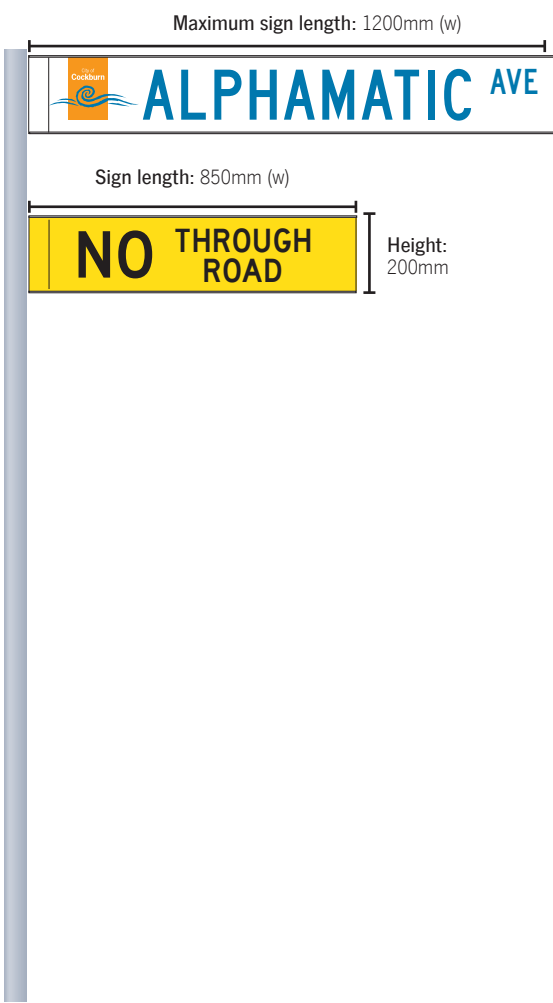
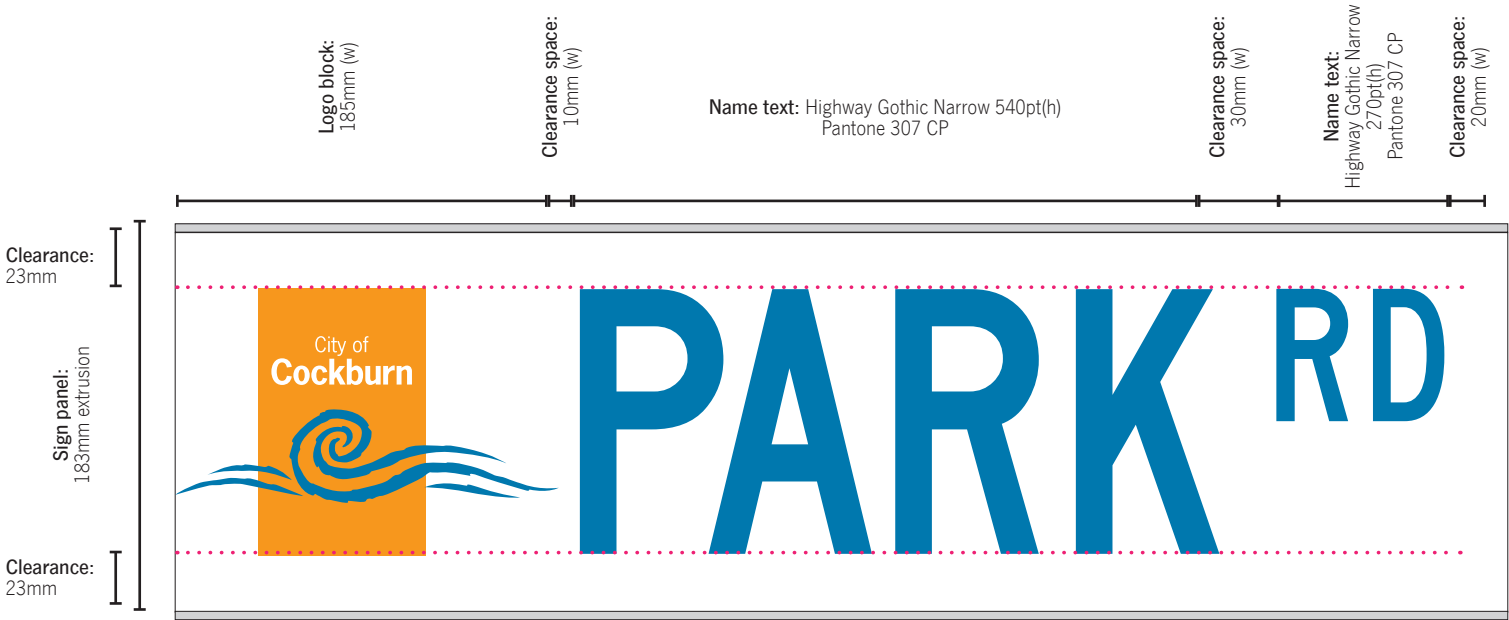
Sign face: Maximum length of 1500mm and height of 300mm. Each sign in a signage stack is to be 900mm, 1200mm or 1500mm in length, as determined by the text and or symbol on the sign.

Main Roads jurisdiction

Roads under jurisdiction or control of Main Roads WA are as follows:

- Kwinana Freeway
- Armadale Road (Kwinana Freeway to Armadale Boundary)
- Cockburn Road (Rockingham Road to Russell Road West)
- Rockingham Road (Stock Road to Kwinana Boundary)
- Russell Road West (Cockburn Road to Rockingham Road)
- Stock Road (Winterfold Road to Rockingham Road)

Note: Portions of Cockburn Road (Russell Road West to Kwinana Boundary), Rockingham Road (Cockburn Road to Stock Road) and Russell Road East (Rockingham Road to Kwinana Freeway) are City roads.



5.2 Fingerboard street name signs with poppy

Usage

The poppy symbol is to be added to street fingerboard signs within the district where the streets have been named after a local person, family or other related war or peace keeping activity or commemorative event.

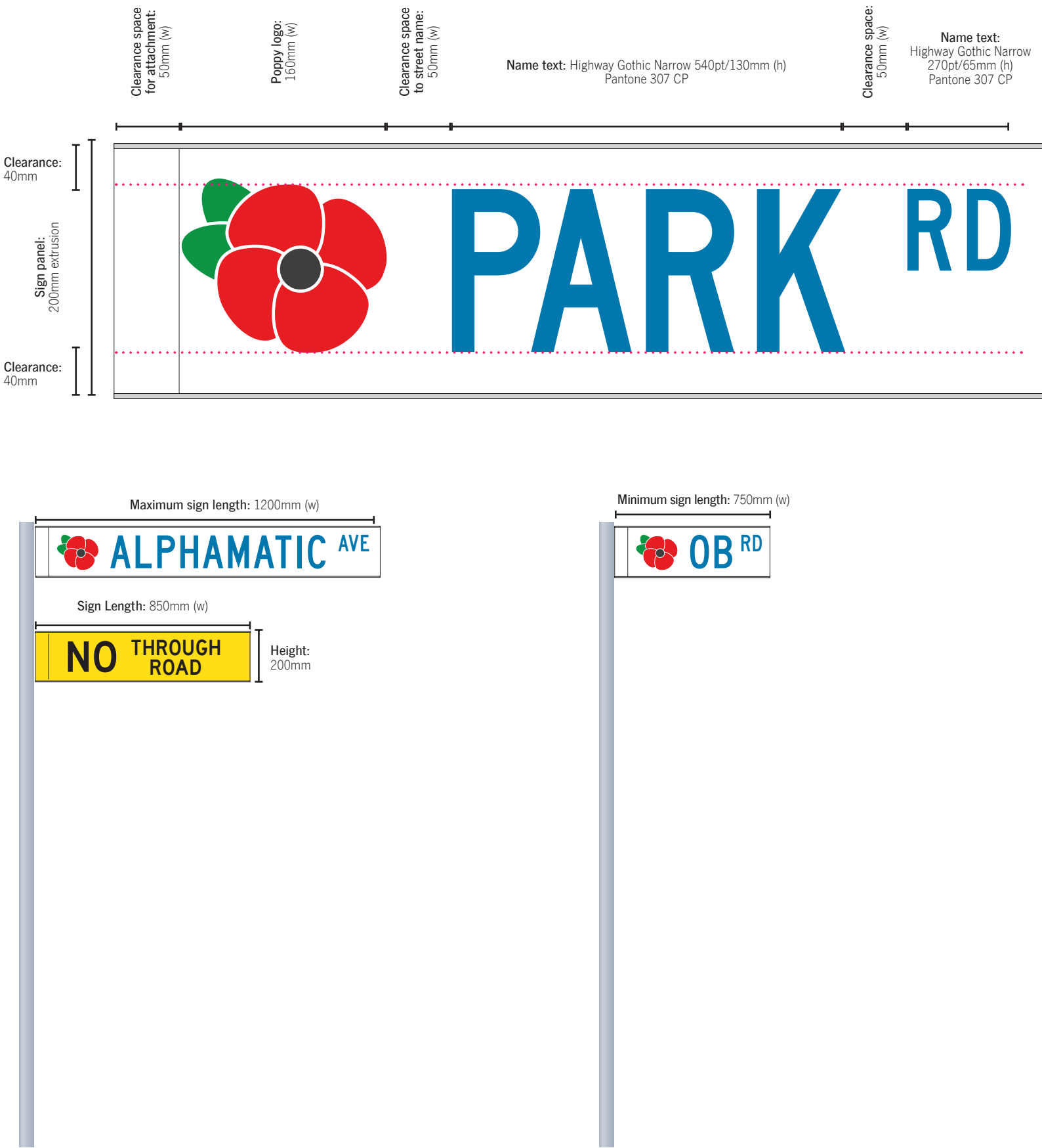

- Each individual sign is to incorporate the service and/or tourist feature/s, represented by a standard symbol where available, or standard text if necessary, and the directions to proceed.
 - The use of Australian Standard service and tourist symbols is limited to five symbols per sign.
 - In any one sign stack the maximum number of fingerboards is four, inclusive of the road name sign.
 - Tourist and service signs shall have upper case lettering only using the Australian Standard (AS) 1744 Series standard font.
 - For more information refer to Australian Standards.

Dimensions

Text: Refer to Australian Standard - Standard Alphabets for Road Signage AS 1744-1975 for details.

Sign face: Maximum length of 1500mm and height of 300mm. Each sign in a signage stack is to be 900mm, 1200mm or 1500mm in length, as determined by the text and or symbol on the sign.



5.3 Community facility name signs

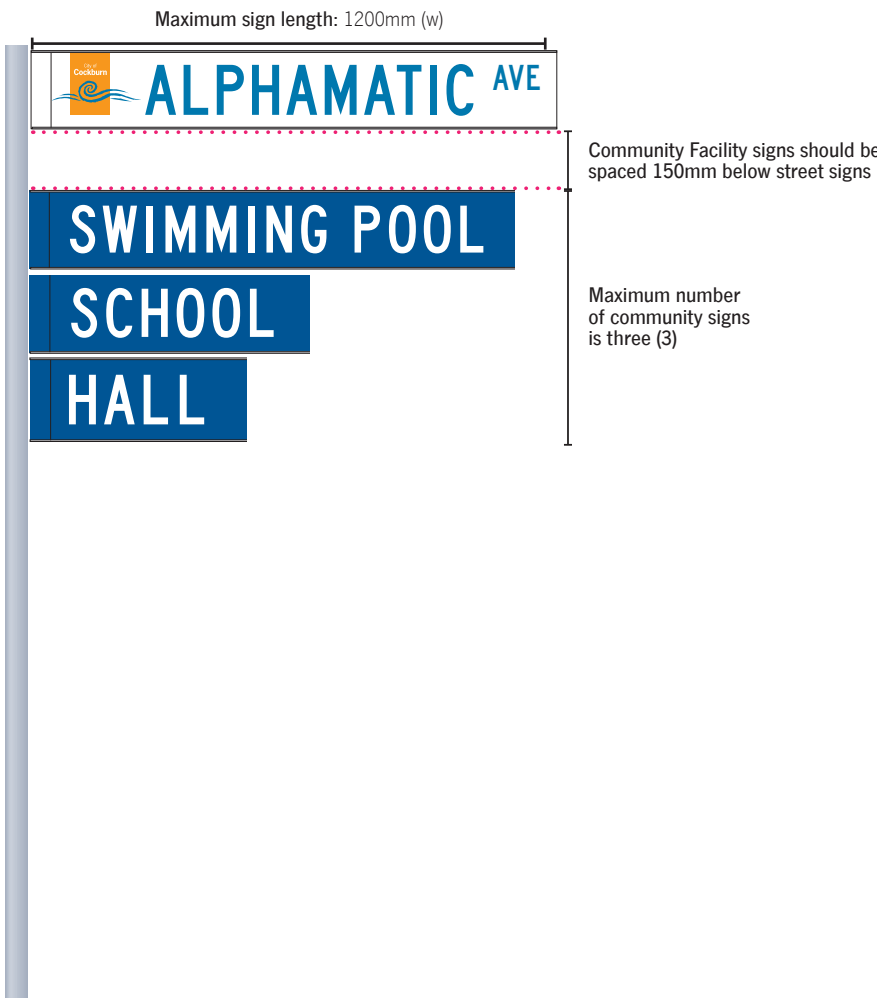
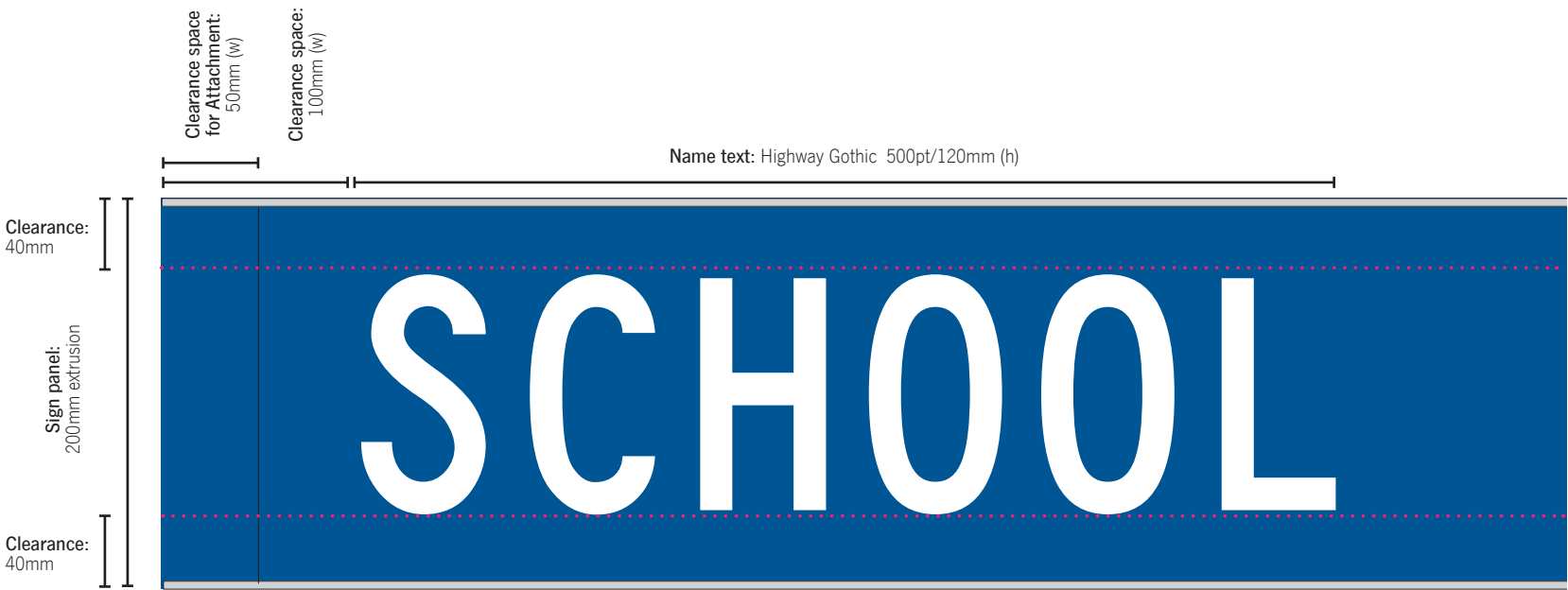

 - Tourist and service signs shall have upper case lettering only using the Australian Standard (AS) 1744 Series standard font.
 - For more information refer to Australian Standards.

Sign face: Maximum length of 1500mm and height of 300mm.

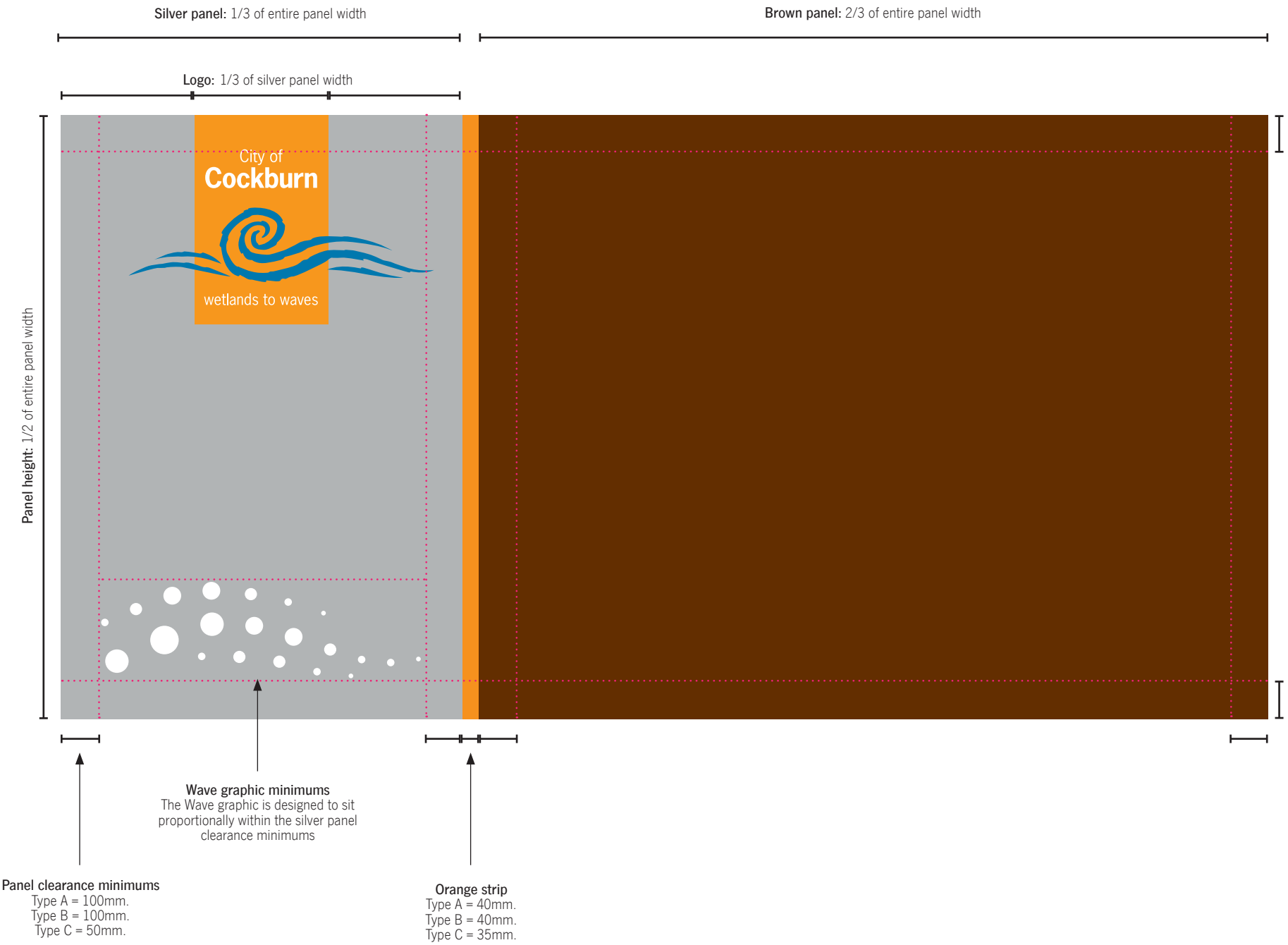

5.4 Facility directional sign proportions

The examples demonstrates the proportion of a typical panel sign. Whilst most panel signs are designed usually the three standard sizes (Section 3.4).

When a custom sized sign is required by using the sign ratios on this page any custom size can be created to fit within the City of Cockburn signage system.



5.4 Facility directional sign types

These signs are used across numerous applications throughout the City of Cockburn include vehicle and pedestrian wayfinding and facility signage.

Each sign may includes:

- City of Cockburn colour palette
- City of Cockburn logo
- Name of destination (wayfinding)
- Name of facility (destination)
- Address of facility
- Directional arrows
- Australian standard symbols
- Supporting Wave graphic

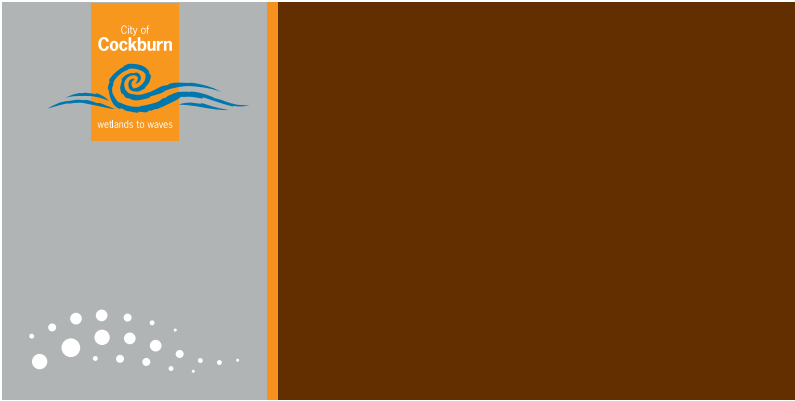

These signs are generally used at secondary entrances to City of Cockburn facilities that have numerous services clustered in the same location and require the listing and wayfinding to these services. Example of where these signs are used include the City of Cockburn Administration Centre and the Cockburn Central Library building. Type B panel signs can be used as vehicle wayfinding or as medium sized facility signs.

Type C - 1500mm (w) x 750mm (h) Example location: Jean Willis Centre



Type C panel signs

These signs are generally used at pedestrian and tertiary entrances to City of Cockburn facilities that have numerous services clustered in the same location and require the listing and wayfinding to these services. Example of where these signs are used include the City of Cockburn Administration Centre and the Cockburn Central Library building. Type C panel signs can be used as pedestrian wayfinding or as small facility signs.

5.5 Facility directional sign typeface sizes

This City of Cockburn standard panel signs use the city’s standard typeface for all city signage. This typeface will vary in size dependant on the size of the sign. Refer to the three standard sign sizes when choosing the correct sized typeface for your sign.

8.0 Interpretive signs

What is Interpretive signage


Interpretive signage is signage that helps to tell a story and/or educate, that promotes local heritage and teaches sustainable practices. Interpretive signage is not directional signage but they will often follow a natural progression. Signage is not the only important component of interpretation – people, props, artefacts and other tools can be used. But here we deal with the signage component.

The examples within are based on conventional interpretive sign sizes but can be adapted according to location and needs.

While the design must adhere to the corporate design examples there is some leeway with Interpretive signage.

There are consultants who specialise in Interpretive signage and in most cases it is recommended that a specialist is engaged.

Officers must consider any opportunity to incorporate Nyungar language within signage. Please consult with Communications and Marketing if you need guidance.

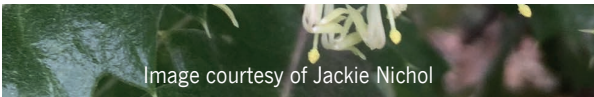

**Feed a bird?
How absurd!**



Birds are highly adapted to feeding themselves. Can you see them dive, wade, dabble, upend or even soar above the water?

Look out for special adaptations such as leg length and bill shape which enable birds to source different foods from different parts of the wetland.

Most of us have fed bread to waterbirds before, but did you know this can lead to sickness, disease, food dependency and aggression!

Food waste can also reduce water quality, contributing to toxic algal blooms and nuisance midges.

Help keep our wetlands healthy and observe our local birds by borrowing binoculars or a mini twitchers kids pack from the City, or get involved in local bird surveys.

9.0 Project signs



Temporary project signage is to be used to inform the community about temporary maintenance and works projects that are carried out by the City of Cockburn or their contractors.

When to use temporary project signage

It applies to those projects that are:

- highly visible
- will take more than two days to complete
- will cause inconvenience to the public and/or
- will require the project to be fenced off.

Temporary project signage does not apply to small maintenance projects that are completed over the course of a day and City officers are in attendance for the duration of the project.

Temporary project signage should be placed in one or more prominent locations at the project site at least 24 hours prior to the commencement of the project and be removed immediately the project is completed.

Should delays occur to the project that result in a later completion date than indicated on the signage, the signage is to be changed immediately to indicate the new completion date.

Communication process

- Ensure the project is registered in the CRM system
- Update the ‘maintenance and road works’ calendar on www.cockburn.wa.gov.au
- Discuss project with marketing and communication for inclusion in marketing material
- Arrange letter drop to advise residents and or businesses (if required).

13.0 Symbols



13.1 Using symbols

All symbols included in City of Cockburn signage must be Australian Standard (AS). Where there is no AS symbol available, the international standard (ISO) equivalent symbol must be used. (Note: many Australian standard symbols use the ISO equivalent symbol, meaning that the Australian Standard is the same as the international standard.)

The use of AS and internationally recognised symbols on signs ensures simple, concise and consistent messages are conveyed to motorists, visitors and City of Cockburn residents.

The symbols shown (right and overleaf) have been chosen as the standard for all City of Cockburn signage, including:

- directional/wayfinding
- tourism
- public space
- parking
- facilities and public buildings.

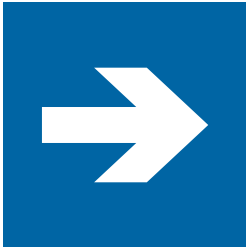
Some older signage may use different symbols. These will be phased out gradually as signage is updated and replaced.

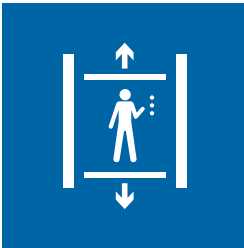

Note: not all City owned facilities are included in this document. Refer to Australian Standards AS 1102.101—1989 for guidelines for any building or facility that is not listed.

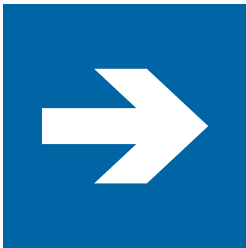
Toilet and changeroom signage

Signage applied to all toilet and changeroom facilities within the locality must follow these guidelines. This includes facilities within City owned buildings and service centres, public toilets and beach changerooms/toilets. This section does not relate to directional signage for public toilets.

All signage must use the following Australian standard symbols:

It is not necessary to include text, other than in braille, when the above symbols are used. Generally text should be kept to a minimum and must not be used to repeat the message of a symbol for example using the word toilet, male, or female and a symbol is not necessary.

Note: this document specifies new signage only, installed since March 2012. Older toilet and changeroom facility signage may not follow these guidelines. This will gradually be phased out as facility signage is updated. During this transition some old and new signage may co-exist.



Direction Arrow:
Indicates direction or movement of people.
Only used in conjunction with other symbols.



Full Accessibility Or Toilets Accessible:
To indicate routes and facilities with full accessibility.



Toilets - Female:
To indicate the location of a public toilet for females.



Toilets - Male:
To indicate the location of a public toilet for males.



Toilets - Unisex:
To indicate the location of a public toilet for males and females.

Braille should be used on these signs as per Australian Standards

Dimensions

Sign face: 180mm (w) x 180mm (h) standard size
Other sizes may be used if appropriate, for example see next page.
Overall height: Signs should be positioned as specified in AS 1428.

Sign face: 2mm aluminium panel.
Graphics: Premium grade cut applied to face and to wrap edges.

Overall height: Approx 1200mm from ground level.

Sign face: 2mm aluminium panel.

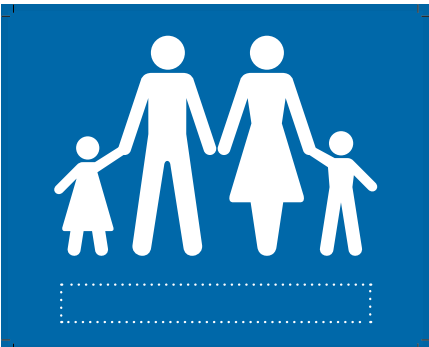

13.9 Dog permission icons

As referenced in the Animal Management and Exercise Plan 2020-2025, the City uses a traffic light style signage system for dog owners.



Dog prohibited area. Dogs are not allowed within the area on or off-leash. Registered assistance dogs are exempted.



Dog on-leash area. Dogs are allowed within the area but must be on-leash unless within an enclosed dog park.



Dog off-leash area. Dogs may be off-leash within the area, but effective control by the owner is still required. Dogs must be tethered if a designated sporting field is in use, City officers are using power tools or mowing, or at the direction of a City officer.



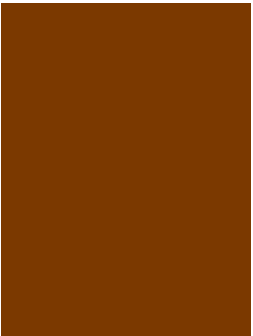
