- CYCLISTS ENCOURAGED TO USE SHARED PATH ON EASTERN SIDE OF CAR PARK
- NORTH END OF CAR PARK RECONFIGURED TO PROVIDE ADDITIONAL BAYS
- PEDESTRIAN PATH TO WESTERN EDGE OF CAR PARK
- VEGETATED SWALE IN CAR PARK TO CAPTURE RUN-OFF AND PLANT NEW TREES TO PROVIDE SHADE
- OVERHEAD POWER LINES TO BE REMOVED AND REINSTATED UNDERGROUND TO BRING PARKLAND CLOSER TO CAFE AND ALLOW THE PLANTING OF LARGER SHADE TREES OVER OUTDOOR GATHERING AREAS
