Dangerous & Restricted Dogs

DECLARED DANGEROUS DOG

Means an individual dog that under section 33E(1) is declared to be a dangerous dog (declared).

DEFINITION OF RESTRICTED BREEDS

- · Pit Bull Terrier breed or American Pit Bull Terrier;
- · Fila Brasileiro (Brazillian fighting dog);
- Japanese Tosa;
- · Dogo Argentino (Argentinian fighting dog); and
- · Perro de presa Canario.

COMMERCIAL SECURITY DOG

Means a dog that is kept primarily for the purpose of guarding or protecting premises that are not dwellings and that are not the premises of the dog's owner, whether or not accompanied by a dog handler.

Dog Owner Responsibilities

- 1. Dogs three months & over must be registered at all times.
- The City must be informed immediately in writing or by email of any change in ownership, the death of a dog & any change of address.
- 3. Proof of sterilisation is needed to claim the concession rate. Eg: Sterilisation Certificate or Statutory Declaration.
- 4. Current pension cards are to be shown each time the pension concession is claimed. A 50% discount applies.
- 5. There is a penalty for failing to register your dog(s).
- If registering a dangerous or restricted breed dog contact Ranger Services at the City for more information.
- Providing a microchip number is compulsory for all New dog registrations.

Important

Fencing Requirement

(Sec 16 Dog Act) The owner shall provide means on the premises for effectively confining the dog in or at the premises.

Control of dogs in Public Places

(Sec 31 Dog Act) A dog shall not be in a public place unless it is; a) held by a person who is *capable* of controlling the dog; or b) Securely tethered for a temporary purpose by means of a chain, cord, leash or harness of sufficient strength and not exceeding two metres.

Barking (Sec 38 Dog Act) A dog must not cause a nuisance by barking. Please report lost dogs to Ranger Services on 94113444.
