3. Details of storage conditions for raw ingredients and finished product to prevent contamination.
4. A copy of the label (if required) for the product, compliant with the Australia New Zealand Food Standards Code.

Please note that submitting this application does not automatically result in an approval.

An assessment of the proposed food handling activity will be conducted. Certain food handling activities may not be permitted within a residential home, or in the primary residential kitchen.
