

The Port Coogee Marina is situated in the Port Coogee development abutting beautiful Cockburn Sound and Owen Anchorage, just 5.5 km south of Fremantle and immediately north of Coogee Beach in the City of Cockburn, Perth.

Facilities:

- Secure floating mooring berths of sizes ranging in length from 10 m to 20 m for single and multi-hull vessels
- No height restrictions for yachts direct ocean access
- Onshore showers and toilets for penholders
- Electricity and water provided at each berth
- Service jetty with diesel & premium unleaded fuel and sullage offtake (not yet operational – coming soon)
- Walking distance to cafes, shopping centre, landscaped parks and safe swimming beaches
- Ready access to Rottnest, Garden and Carnac Islands



Important Information

- Pen licenses are subject to the terms and conditions of the Deed of License, Marina Rules and Regulations, and City of Cockburn Waterways Local Law – all of which are available on the City of Cockburn's Marina website cockburn.wa.gov.au/Council Services/Port Coogee Marina.
- Depths of at least 2.5 m + tide are available throughout most pens, and many are deeper. Marina Management will be able to help you determine if your vessel's draft will be suitable for the desired pen.
- The overall length of the vessel (including bowsprits, marlin boards, outboards, etc) must be no longer than the stated length of the pen.
- Live-aboard arrangements are not permitted. Penholders may stay overnight on their vessel up to a maximum 20 nights per year refer License Deed terms and conditions for further information.
- A current certificate of electrical compliance is required to connect to shore power.




Mooring Pen License Fees

The table below shows fees payable for licenses commencing in the 2016/17 financial year. These fees are typically reviewed annually. Fees include water usage and sullage offtake, but exclude electricity consumption. Licensees are billed separately for electricity consumed at their pen.
