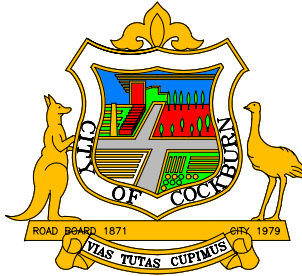

The purpose of the meeting is for Council to consider amending its 2004/05 Municipal Budget to enable additional funds to be allocated to conduct a Concert at Manning Park on 19 March 2005.

RECOMMENDATION

That Council amend its Municipal budget for 2004/05 as follows:

- (1) reduce the allocation to Account No.CW1901 – Waste Disposal Site Works from \$476,305 to \$449,305; and
- (2) increase the allocation for Account No.9470 – Classic Special Events – Manning Park from \$40,000 to \$67,000.

COUNCIL DECISION

Background

Council allocated an amount of \$40,000 in the 2004/05 Municipal Budget to conduct a Classic Event in Manning Park. The cost of holding the event is now estimated to be \$67,000 and additional funds are therefore required so that the event can take place.

Additional funding is sought to secure Marcia Hynes to perform at Manning Park on 19 March, 2005 in a concert proposed to be free to the public.

Initial discussions with the Event Co-ordinator confirmed that, due to the high quality and profile of the entertainment proposed, additional funds to that provided in Council's Budget would be required.

As requirements for the proposed concert were confirmed, it became apparent that an additional \$27,000 would be required to undertake the project (see proposed budget estimate attached).

The event management company which provided the details and costings associated with the exercise are keen to confirm the arrangements on behalf of Council, however, this can only occur after Council has the funds made available.

The required amount can be made available from the funds allocated for Works at the Henderson Landfill Site as it is unlikely that the works will be completed this financial year.
