#### **Council Decision**

MOVED Cr P Corke SECONDED Cr M Separovich That Council:

- (1) ENDORSES bringing forward municipally funded capital programs listed below from FY26 to the FY25 Capital Budget for delivery to be funded through the Local Roads and Community infrastructure (LRCI) Program, subject to the approval from LRCI funding amendment
- (2) REALLOCATES Grant Funding of \$621,299 from the Rockingham/Phoenix Roundabout project in FY25 to the projects listed below
- (3) ENDORSES funding for future expenditure on the Rockingham/Phoenix Roundabout from the Municipal Fund in FY26 as required
- (4) AUTHORISES and EFFECTS the following 2024/25 budget adjustments:
  - 1. Rockingham Rd Goldsmith to Newton (Resurfacing) INCREASE expenditure and LRCI grant funding by \$400,000; and
  - 2. Coogee Beach Carpark (North) (Resurfacing) INCREASE expenditure and LRCI grant funding by \$221,299

#### Background

In 2020 the Federal Government released the Local Roads and Community Infrastructure (LRCI) Program to support Local Governments to delivery priority road and community projects, create jobs and long-lasting benefits to the community.

The Federal Government committed \$3.25 billion to the program over four phases.

Each local government across Australia received an allocation and was given the opportunity to nominate able to nominate projects that aligned with the grant conditions

The City received funding across all four phases, which was allocated to the following projects:

- Phase 1 \$1,077,107
  - Frankland Ave road widening and traffic flow treatments
  - Replacement of evaporative air conditioning system at the Coogee Beach Surf Life Saving Club
  - Henderson Reuse Shop Air Conditioning
  - South Coogee Clubrooms External Works
  - Slow Down Coastal Path
  - Hammond Park Shared Path
  - Urban Forest Crossing
  - Yangebup Local Centre
  - Smart LED Street Light Trial in North Coogee
- Phase 2 \$3,723,182
  - Jandakot Road (Berrigan to Solomon)
- Phase 3 \$2,154,214
  - Hammond Rd (Bartram to Jubilee)
- Phase 4 Part A (\$1,077,107) and Part B (\$621,299)
  - Part A: Omeo Port Coogee Southern Amenities \$1,077,107
  - Part B: Rockingham Rd / Phoenix Roundabout.

This report seeks Council approval to reallocate the Phase 4 Part B funds to alternative projects.

## Report

The City received notification from the Federal Government for Phase 4 of the LRCI program in July 2023 for allocation to projects meeting the grant conditions.

There were two parts under the Phase 4 funding program totalling \$750 million.

Part A: \$500 million available to 550 councils across Australia to spend on local roads and community infrastructure projects,

Part B: \$250 million available to 466 councils in rural, regional or outer-urban areas to spend exclusively on roads projects.

The City allocated the funds to the following projects:

#### Omeo Port Coogee Southern Amenities

This project was selected as the most advantageous for the City to nominate as it met all the grant conditions and would be delivered by 30 June 2025.

The entire allocation under Part A \$1,077,107 was assigned to the project as per Ordinary Council meeting (2014/MINUTE NO 0140) RFT 01/2024 Building Construction Services – Omeo Amenities Building, Port Coogee

#### Rockingham Rd / Phoenix Roundabout

This project was selected as the most advantageous for the City to nominate as it met all the grant conditions and would be delivered by 30 June 2025.

The entire allocation under Part B \$621,299 was assigned to the project and adopted at the Special Council Meeting (2024/MINUTE NO0129) Adoption of the 2024-25 Annual Budget, 2024-25 Differential Rates, and 2024-25 Schedule of Fees and Charges.

However, with the project delivery timelines unable to be achieved it is proposed that Council reallocate the funds allocated to the following projects.

#### Rockingham Road Resurfacing

The "Draft" FY26 Capital Program lists resurfacing of Rockingham Road (Goldsmith to Todd) with a budget of \$142,217

The proposed scope of works includes a significant extension to the original plan which will expand the project from Goldsmith to Newton.

This section is experiencing similar levels of degradation and would benefit from earlier intervention provided funding is available within this grant.

The estimated cost to extend the scope of work and address additional issues in drainage whilst on site is \$400,000.

## Coogee Carpark (Northern Section)

The "Draft" FY26 Capital Program lists the resurfacing of the northern section of the Coogee Car Park (Café to Perlinte View) with a budget of \$112,162

The scope of works includes the resurfacing of the northern section of the carpark, kerbing, traffic management and line marking.

It is proposed to include a budgetary figure of \$221,299 to ensure sufficient funds exist to deliver this work with the funding coming from the Phase 4 (Part B) LRCI grant.

If the City is successful in reallocating this funding under the LRCI program, the impact on Municipal reserves will be negligible.

This reallocation would allow Council to fully benefit from the grant and avoid forfeiting access to the available funding.

However, if the reallocation is not approved, additional own-source funding will be required to meet the City's existing commitments and to deliver priority infrastructure and asset management projects

There is a medium to high risk the selected projects are not completed by 30 June 2025 due to the tentatively booked contractors postponing works or inclement weather delaying delivery.

There is a medium to high risk the Department of Infrastructure, Transport, Regional Development, Communications and the Arts will not approve the amended works schedule.
